






8-County Metro District





MnDOT Metro Investments in the ATIP/TIP



Changes in this ATIP/TIP

Adding federal funds

- Minnesota Highway Freight Program (MHFP) awards
- Federal INFRA and RAISE grants for projects on I-494 and US 61/Hwy 5
- CRRSAA (COVID relief) included in MnDOT projects
- Corridors of Commerce projects
 - I-494 COC project programmed with additional MHFP, INFRA, and district funds
 - Hwy 252/I-94 project programmed in 2026 and associated local funding/projects

- 2022 this construction season
 - 3rd Ave Bridge (Hwy 65) over the Mississippi River in dwtn Minneapolis. Year 3 of 3. (Hennepin)
 - I-35W/42nd St. Stormwater storage facility, final year (Hennepin)
 - Hwy 55/Hiawatha Ave pavement and bridge rehab, safety guardrail, ADA, stormwater drainage from dwtn to Hwy 62 (Hennepin)
 - US 10 Ferry St interchange improvements and Rum River Bridge replacement, auxiliary lanes, noisewalls and ADA improvements (Anoka)
 - I-94 pavement and bridge rehab on I-94 from Western Avenue to Mounds Boulevard in Saint Paul and on I-35E from 10th Street to University (Ramsey)
 - Hwy 55 pavement and bridge rehab, stormwater drainage, ADA from Bloomington Rd in Mpls to Argenta Trail in Inver Grove Heights (Hennepin/Dakota)
 - Hwy 13/Dakota Ave interchange (Scott)

- 2023 all multi-year construction projects
 - I-494 Corridor of Commerce project. I-35W interchange improvement, EZPass lanes, Portland Ave interchange reconfiguration, bridge rehab, roadside infra, ADA/ped improvements (Hennepin)
 - I-35W pavement repair, drainage and ADA improvements from W 106th Street 82nd St in Bloomington (Hennepin)
 - I-494 Resurface Minnesota River Bridges and trail (Hennepin/Dakota)
 - I-94 pavement improvements, freight lane addition, roadside infrastructure, safety and ADA/ped improvements from Hwy 120/Oakdale to St. Croix River (Washington)
 - US 52 pavement improvements, bridge rehab, roadside safety in Rosemount/Hampton Township (Dakota)

• 2024

- Hwy 65, resurface road, drainage repairs and ADA improvements from CR 10 in Spring Lake Park to Coon Creek in Blaine (Anoka)
- Hwy 55/Olson Memorial Hwy, Repair pavement and bridges, traffic improvements in Plymouth to Golden Valley (Hennepin)
- US-212, construct a reduced conflict intersection at County Rd 51 in Benton Township (Carver)

• 2025

- I-35W from Cliff Road to the I-35W/I-35E split, major pavement, repair bridges, ADA and trail improvements (Dakota)
- I-94, repair 9 bridges and replace 2 bridge superstructures from Western Ave to Mounds Blvd and I-35E from 10th St to Jackson St in St Paul (Ramsey

• 2026

- Hwy 252/I-94 Corridors of Commerce. Programmed funds and general description; awaiting EIS results (Hennepin)
- Hwy 77/Cedar Ave, pavement rehab from Bloomington to Apple Valley (Dakota/Hennepin)
- Hwy 12, resurface road, lighting, drainage improvements, ADA, pier protection on bridges in Orono to Minnetonka (Hennepin)
- I-394 Dunwoody Bridge rehab (includes 14 bridge structures), drainage, lighting, sidewalk and ADA on and along I-394 from Penn Ave to I-94 in Mpls (Hennepin)
- Hwy 280, repair pavement, rehab 13 bridges, roadside infra and ADA/ped improvements from I-94 to I-35W (Ramsey)

Issues/risks

- Ever changing program
 - Expecting new revenue through:
 - Federal transportation act reauthorization (IIJA/BIL)
 - Earmarks and grants
 - MN 2022 legislative session/season
 - Next MnSHIP will impact projects in 2027 and beyond
 - Engagement to start this summer
