What is the UN Conference of the Parties (COP)?

- Intergovernmental Panel on Climate Change formed in 1988
- Started in 1992 with UN Framework Convention on Climate Change (UNFCCC) creation at the Rio Earth Summit
- COP1 in 1995 in Berlin, Germany
- COP3 in 1997 in Kyoto, Japan. Kyoto Protocol adopted
 - Binding agreement
- COP15 in 2009 in Copenhagen, Denmark
 - Nonbinding, voluntary agreement
 - Recognition to limit warming to 2°C
- COP21 in 2015 in Paris, France
 - Nonbinding "Nationally Determined Contributions" (NDC)
 - Limit warming to 2°C



Urgent action needed for mitigation

Global climate crisis

To keep global warming below 1.5 degrees Celsius, the world will need to cut emissions by 50% within 10 years.

"The report shows that limiting global warming to 1.5 degrees can have many benefits, including those for human health and natural habitats. We can still choose the kind of future we want, but we have to act now."

(Heleen de Coninck, Climate Scientist and Lead Author of IPCC Report "Global Warming of 1.5 Degrees Celsius", 2018)





- Continue to operationalize 2015 Paris Agreement
 - Raise overall ambition for enhanced Nationally Determined
 Contributions (NDCs) 80 counties committed to this
 - Complete work on Article 6 of the Agreement Vital & not done
 - International climate markets
 - Other areas of focus
 - Adaptation, loss and damage, transparency, finance, capacity-building, indigenous issues, oceans, forestry, gender, and more Some work done on gender, but no dedicated fund agreed on loss and damage, which is important now.
- Set the stage for COP26 in 2020 in Glasgow, Scotland




