#### **Proposed Action**

That the Metropolitan Council amend the 2014 Unified Planning Work Program (UPWP) for the Twin Cities Metropolitan Area to add \$400,000 to the budget for ongoing consulting studies and provide a complete work program.

#### **Background**

The Unified Planning Work Program (UPWP) includes activities required by federal regulation that address planning priorities of the metropolitan area. The document identifies budgeted expenditures, funding sources, and allocation of staff resources for a variety of transportation planning activities.

Studies identified in the 2014 UPWP were specific studies known by June 2013. Additional studies have been specifically identified for carryover or new and are being amended into the 2014 UPWP.

#### Rationale

The Regional Solicitation Evaluation schedule lengthened to accommodate increased input and review from stakeholders in the recommendations. By extending the schedule for the evaluation, the time to develop a new solicitation based on the evaluation's recommendations is shortened significantly. Consultant assistance is needed for developing the new solicitation with technical expertise on a short timeline.

The Travel Behavior Inventory is ongoing and completion revised from 2013 to 2014. Previously budgeted UPWP funds were expended except for the 10 percent retainage. The retainage amount budgeted in 2013 will be paid in 2014 when the TBI is completed.

The Travel Behavior Over Time Study is a three-year study which began in 2013. The study budget is spread over three years, with \$50,000 budgeted in 2013. Just under \$25,000 was expended in 2013, and the amendment will add the \$25,000 unspent budgeted funds into 2014.

The Highway Transitway Corridor Study is being amended into the product list as a continuing study. No additional funds need to be amended into the budget for this study.

### **Funding**

The proposed 2014 UPWP amendment modifies the budget to fully fund the Regional Solicitation Evaluation Study and the Regional Solicitation Application development, completion of the Travel Behavior Inventory, and continuation of the Travel Behavior Over Time Study. Additional UPWP funds and local match are added to the consultant costs in Tasks B and D in the budget (see attached budget).

**MOTION:** Recommend adoption of Amendment to the 2014 Unified Planning

Work Program (UPWP) for the Twin Cities Metropolitan Area.

**BACKGROUND AND PURPOSE OF ACTION**: The Unified Planning Work Program (UPWP) includes activities required by federal regulation that address planning priorities of the metropolitan area. The document identifies budgeted expenditures, funding sources, and allocation of staff resources for a variety of transportation planning activities.

Studies identified in the 2014 UPWP were specific studies known by June 2013. Additional studies have been specifically identified for carryover or new and are being amended into the 2014 UPWP.

The Regional Solicitation Evaluation schedule lengthened to accommodate increased input and review from stakeholders in the recommendations. By extending the schedule for the evaluation, the time to develop a new solicitation based on the evaluation's recommendations is shortened significantly. **Committee Action:** TAB adopted of an amendment to the 2014 Unified Planning Work Program (UPWP) for the Twin Cities Metropolitan Area increasing the budget for consulting funds for the Regional Solicitation, Travel Behavior Inventory, and Travel Behavior Over Time Study and adding the Highway Transitway Corridor Study to the product list.
