TAP Solicitation

- 42 applicants requested \$26.4 M federal funding
- \$6.32 M available
- Applications were evaluated and scored; appeals process held
- 11 projects selected for funding
- Added 4% inflation to the project costs

CMAQ Transit Capital

- One-time Request for Projects emphasis on regionally significant projects
- 6 applications requested \$35.96 M in federal funding
- \$20 M available
- Applications reviewed and rated
- No inflation added to project costs



CMAQ Transit Capital cont.

- Top three rated projects requested \$21 M (\$7 M each)
 - MOA Transit Station Renovation
 - West 7th St. B Line
 - Lake Street Station at I-35W
- Metro Transit proposed:
 - Reallocate 2016 CMAQ funds awarded for Chicago Avenue bus service enhancement to Hopkins park-and-ride
 - Allocate 2016 funds to B Line and 2017 funds to Hopkins to match project schedules
