

## Blue Line Ext. (Bottineau LRT)


- 10 to 11 stations
- 27,000 est. rides by 2030
- DEIS published Spring
  2014
- FTA approved entry into Project Development August 22
- Estimated Capital Cost: \$1 billion
- Opening 2021






## **Blue Line Extension**


- Council Districts




## **Local Funding Commitments**

- TOTAL LOCAL FUNDING
  - Pre Project Development: \$150K
    - 100% = HCRRA
  - Project Development: \$46MM
    - 60% CTIB = \$27.6MM
    - 38% HCRRA = \$17.4MM
    - 2% State = \$1.0MM

## **Engineering Services Consultant (ESC) Contract Includes:**

- Preliminary Engineering during Project Development
- Engineering (Final Design)
- Design Support Services during Construction



### **ESC Proposal Review Process**

- Evaluation Panel consisted of seven staff from:
  - Metropolitan Council (3)
  - Hennepin County Regional Railroad Authority (2)
  - Counties Transit Improvement Board
  - Minnesota Department of Transportation
- Technical Advisory Group consisted of seven staff from:
  - Metropolitan Council (2)
  - Minneapolis
  - Golden Valley
  - Robbinsdale
  - Crystal
  - Brooklyn Park



### **ESC Proposal Review Process (cont.)**

- The Council received three responsive proposals
- Proposals reviewed by Evaluation Panel and Technical Advisory Group
- All three proposing teams participated in an interview
- Most qualified proposer identified



#### **Kimley-Horn and Associates, Inc.** determined to be the most advantageous to the Council

- Proven technical expertise on recent New Starts projects including CCLRT and SWLRT
- Strong local presence coupled with national expertise
- Demonstrated knowledge of the Bottineau Corridor
- Cost Proposal less than Independent Cost Estimate (within 1%)
- Disadvantaged Business Enterprise participation is 19.0%, which meets the 19% goal established by OEO



## Phased Notices to Proceed (NTP)

Four NTP's will be issued to authorize work:

- Phase I Completion of the portion of Project Development through municipal consent and support of the Record of Decision (\$30.5MM)
- Phase II Completion of Advanced Design sufficient to enter Engineering according to the Federal Transit Administration's New Starts Program.
- Phase III Completion of Final Design.
- Phase IV Design Support Services during construction



#### **Recommended Action**

- That the Metropolitan Council authorize the Regional Administrator to negotiate and execute an engineering services contract with Kimley-Horn and Associates, Inc. for engineering consultant services for the METRO Blue Line Light Rail Transit (BLRT) Extension
  - Not to Exceed \$110,046,172
