Proposed Action

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2015-2018 Transportation Improvement Program (TIP) to include an increase in cost for construction of a roundabout on CSAH 18 at CR 62 in Columbus.

Background

The project will construct a roundabout at the intersection of Anoka County State Aid Highway (CSAH) 18 and County Road 62. The total project cost has increased due to higher construction costs than estimated in the original Highway Safety Improvement Program (HSIP) application. The scope of the project is not changing. See attachment for more details.

Rationale

The Transportation Advisory Board approves formal amendments to the TIP and the Metropolitan Council concurs with the action of the TAB. The project is consistent with the Transportation Policy Plan (TPP) and meets fiscal constraint because the federal funds are sufficient to fully fund the project. The Minnesota Interagency Air Quality and Transportation Planning Committee determined that the project is exempt from air quality conformity analysis.

Funding

The project is fully funded with federal and local funds. The project is currently programmed in SFY 2015 with a total of \$550,000 including \$495,000 in HSIP federal funding and \$55,000 in local matching funds from Anoka County. The total project cost is increasing from \$550,000 to \$1,129,770, an increase of \$579,770, all of which will be covered by Anoka County, for a total of \$634,770 in local matching funds.

PROJECT BACKGROUND:

1. Briefly describe why amendment is needed (e.g., project in previous TIP but not completed; illustrative project and funds now available; discretionary funds received; inadvertently not included in TIP).

An amendment is needed to adjust the total project cost. The project is to construct a roundabout at the intersection Anoka CSAH 18 and Co. Rd. 62. The total project cost has increased due to higher construction costs than what was estimated in the original HSIP application. As the county proceeded to final design, final construction costs are higher than originally estimated. The increase in total project cost is being paid with county funds. The scope of the project is not changing.

SP 002-618-030 is currently programmed in SFY 2015 with a total of \$550,000 including \$495,000 in HSIP federal funding and \$55,000 in local matching funds from Anoka County. The

total project cost is increasing from \$550,000 to \$1,129,770, an increase of \$579,770. Anoka County will provide the additional funds, for a total of \$634,770 in local matching funds. This is sufficient to fully fund the project; therefore, fiscal constraint is maintained.
