



Public Properties Mapping Project




- Humphrey School

Snelling Site Update

History

•2012: City & Council agreed to plan southern sites = Council owned + City-optioned sites.

•2014: 3-party agreement to plan entire block. Consultant report identified major financial gap between desired plan & market conditions. City option expired.

•2015: City & Council staff agreement to move forward with separate RFP for Council site.



Next steps

•Analyze Met Council site development potential, given existing codes and regulations. Estimate market demand. Review findings with City staff and resolve any issues


- •Working with City staff, develop scope, issue solicitation, evaluate responses
