## **Proposed Action**

That the Metropolitan Council concur with the Transportation Advisory Board (TAB) action to amend the 2018-2021 Transportation Improvement Program (TIP) to increase the cost of a traffic management system project on I-35W (SP # 8825-614) and to amend a project to replace a median barrier on I-494 (SP # 2785-423).

## **Background**

These projects were a part of the 2017 Minnesota Legislature's transportation funding package of fiscal year 2018 projects. The two projects in this amendment will:

- Increase the cost of, and replace changeable signage along, a traffic management system project on I-35W and
- Replace a cable median barrier with a concrete median barrier on I-494.

Other Projects from the 2017 Legislative Funding Package

Along with the two projects being amended, the Legislature's transportation funding package included:

- A temporary lane re-striping on I-394 and MN 62. This is a separate, regionally significant TIP amendment request that will be before TAB in November.
- Rehabilitation of the Irene Hixon Whitney Memorial Pedestrian bridge over I-94. This project was included in the Draft 2018-2021 TIP (SP # 2781-496)
- Addition of the I-35W over 106<sup>th</sup> St. bridge to the I-35W bridge project in Bloomington. This was reflected in the Draft 2018-2021 TIP (SP#1981-124).
- One dozen MnDOT-sponsored, state-funded projects that are not required to be included in the TIP and will be placed via administrative modification. They are shown in the table at the bottom of this business item.

This amendment is requested to be approved pending approval of the 2018-2021 TIP by the USDOT. The 2018-2021 TIP was approved by the Metropolitan Council on September 27, after which time it will be provided to MnDOT and then in federal review. This amendment will not be official until after that approval is granted.

### Rationale

The Transportation Advisory Board approves formal amendments to the TIP and the Metropolitan Council concurs with the action of the TAB. The project is consistent with the Transportation Policy Plan (TPP) and meets fiscal constraint because the federal and state funds are sufficient to fully fund the project. The Minnesota Interagency

Air Quality and Transportation Planning Committee determined that the project is exempt from air quality conformity analysis. This TIP amendment is using the streamlined process adopted by TAB on April 19, 2014.

# **Thrive Lens Analysis**

The project is fully funded with federal and state funds.

## **PROJECT BACKGROUND:**

1. Briefly describe why amendment is needed (e.g., project in previous TIP but not completed; illustrative project and funds now available; discretionary funds received; inadvertently not included in TIP).

This amendment is to add funds received by two projects from the 2017 Minnesota Legislature Transportation Funding package to state fiscal year (SFY) 2018 of the 2018-2021 TIP. This includes a cost increase to State Project # 8825-614 and use of a concrete median barrier, instead of a cable median barrier, for State Project # 2785-423.

These projects are not regionally significant. They were selected by MnDOT-Metro District as projects that addressthe District's safety and roadside infrastructure needs that could be easily developed and delivered in a short time period. In addition to these projects, there is another project that will go through the full amendment process because it is regionally significant, adding temporary lanes on I-394 and MN 62 as mitigation during the I-35W/Lake Street project. The 2018-2021 TIP was approved by the Metropolitan Council on September 27, and was subsequently provided to MnDOT. It is now in federal review. Should this amendment be approved by the Metropolitan Council prior to federal approval of the 2018-2021 TIP, it will not be official until after federal approval is granted.

The transportation package gave MnDOT additional general obligation (GO) state funds, bonds for State Road Construction (SRC), and bonds for a Corridors of Commerce program. The projects in this amendment have state, bond funds, and federal funds. The federal funds are part of MnDOT's federal allocation. The remaining

new funding from the 2017 transportation package for projects in years 2019-2022 will be incorporated into the development of the 2019-2022 TIP.

Both projects are in the 2018-2021 TIP, and are being upscoped with the new funding. SP 8825-614 (SEQ 1502) is a traffic management system project to replace MnPASS changeable signage along I-35W in the South Metro, and is being upscoped to include additional signage in that corridor. SP 2785-423 (SEQ 1448) is being amended to the 2018-2021 TIP because the scope of the project is changing from a cable median to a concrete median barrier.

In addition to the projects with federal funds, there are a number of MnDOT projects that will only have state or bond funds that will be added to the STIP via an administrative modification.

SP 8825-614 will receive state funds from the new 2017 transportation package and federal funds. SP 2785-423 will receive bond funds from the new 2017 transportation package and federal funds. The federal funds for both of these projects are made available due to additional federal funds received by MnDOT. In SFY 2017, Minnesota received \$54.3M of federal funds from August Redistribution. These funds were used to fund AC paybacks and 2018 projects. Because of this, SFY 2018 has additional funds that have become available to use on other projects.

#### **CONSISTENCY WITH MPO LONG RANGE PLAN:**

This amendment is consistent with the Metropolitan Council Transportation Policy Plan, adopted by the Metropolitan Council on January 14, 2015, with FHWA/FTA conformity determination established on March 13, 2015.
