Corridors of Commerce

- Application period open until 2/5/18, project selection in April
- MnDOT received 175 public comments on application.
- MnDOT decided to maintain soft 50-50 split of the \$400 million between Metro/Greater MN
- MnDOT provided flexibility on the construction window to avoid construction on parallel corridors



MnDOT Competitive Solicitations

• 50% to Metro on 2018 Corridors of Commerce

Recently:

- 80% to Metro in 2017 Freight Awards
 - Would have been 96% based on pure scores
- 91% to Metro in 2017 TED Awards

Context:

- Declining share to Metro highway investment due to statewide focus on asset preservation → CoC Important for Metro Mobility \$
 - 42%: 2018-2021
 - 36%: 2022-2027
 - 28%: 2028-2037

- 5. I-94/TH 280 Interchange
- Lower Cost/High Benefit Spot Mobility Projects:
- 1. TH 62 Auxiliary Lanes Eastbound Only
- 2. TH 62 Auxiliary Lanes Both Directions
- 3. I-94 Auxiliary Lanes in Maple Grove
- 4. I-94 St. Paul Aux lane Westbound Only
- 5. I-94 St. Paul Buffer and Aux Lane Westbound Only



Anticipated Partner Submittals

- Aware of about 25 submittals to date, likely more before 2/5/18 deadline
- Will keep Transportation Committee informed of projects
- Some projects already have fallen off due to potential consistency issues with the TPP
- Some high priority projects (TH 65 in Blaine) need a corridor study prior to pursuing funding
- Region will submit projects from all 7 counties + 7W area and Chisago County
 - 7W projects counted as Greater Minnesota projects
 - Chisago County counted as Metro Area project
