Wednesday, June 20, 2018

Reports

TAB Chair's Report – TAB Chair Jim Hovland reported that the TAB Executive Committee met and review the TAB agenda and items. Hovland attended an MSP/Memphis roundtable.

MnDOT – McBride reported that the legislature added \$400 million to Corridors of Commerce. Three additional projects were selected: one in the metro area (Hwy 252/I-94 MnPASS) and two in Greater Minnesota (Hwy 14 and Hwy 23).

MAC – Bridget Rief reported that the airport hotel is scheduled to open on July 14.

TAC – Chair Freese reported that the MnDOT Project Selection process was discussed, and feedback provided to MnDOT. Freese said an overview of the MnDOT Asset Management Program was discussed as well.

- 2. Geographic Balance in Regional Solicitation Steve Peterson presented information on the geographical distribution of Regional Solicitation projects from 2003-2016. TAB members discussed options for looking at distribution of projects beyond population or employment by county, including priorities of the counties, income, travel sheds, and meeting future development needs.
- 3. MnDOT Project Selection Performance Measures Philip Schaffner presented additional information on MnDOT's project selection processes. MnDOT is accepting comments, questions, and suggestions on their Project Selection Policy through the summer.
