

Anticipated rating after scope modifications (STOPS feedback from FTA on 3/5)







Modification of Helmo Park and Ride



- Redesign and add ~38 stalls to Helmo Park and Ride
- Consistent with City of Oakdale TOD plan





494 Park & Ride Modification



- Redesign and add ~312 stalls and parking structure to 494 Park and Ride
- City/County developing TOD plan (including potential Joint Development)
 - Washington County Board proposing "West Central Service Center" for this site





West Central Service Center (WCSC)

- Replaces existing facility that doesn't meet needs of county stakeholders
- 60,000 sq.ft. building with approx. 150 jobs
- Serves region-wide residents with the following services:
 - SNAP food assistance
 - Workforce center
 - Voting center
 - Sheriff patrol touchdown space
 - License services
 - Adult, child, and veterans social services
 - Adult and juvenile community corrections
 - Public health nursing services



WCSC Employee & Visitor Parking: mix of surface and structure


GBRT Parking: 512 in structure


