





## **Demand Response – Change in Ridership over 2019**






# Change in Ridership over 2019

typical COVID (2020) weekday



# Successes

- Essential Mobility
  - travel to essential jobs, necessities
  - support for health care workers
  - service matched to demand to ensure social distancing
- Local and arterial BRT service strong
  - emphasis on all-day, all-purpose trips
  - solid base of ridership to build on through 2021





# Challenges

### • COVID-19

- capacity limits for health means limits on operational flexibility
- pace of vaccinations may determine pace of ridership in 2021

#### Telecommuting

- commutes to 9-5 office jobs (transit mainstay) replaced by no trip at all
