# **Proposed Action**

That the Metropolitan Council adopt an amendment to the 2022-2025 TIP to extend the length of Woodbury's Lake Road 4-lane-to-3-lane conversion and add mill and overlay, signals, and ADA improvements.

## Background

This request is to expand the project footprint, increase the project cost, and add nearby locally funded mill and overlay, signals, and ADA improvements to the contract. The purpose of adding this local work to the project is to create efficiency in letting the projects together.

## Rationale

The Metropolitan Council approves formal amendments to the TIP. The projects are consistent with the Transportation Policy Plan (TPP) and meet fiscal constraint because the federal, state, and local funds are sufficient to fully fund the projects. The Minnesota Interagency Air Quality and Transportation Planning Committee determined that the project is exempt from air quality conformity analysis.
