April 1, 2021 – September 30, 2021 FTA Report Summary

The current Metropolitan Council sets an overall DBE goal that is valid for 3 years. This is commonly called the Triennial DBE Goal. Metropolitan Council's current triennial goal is 14% overall, with a 11% Race -Conscious goal and 3% Race-Neutral. DBE Participation is based on awarded contracts and reviewed on a semi-annual basis by the Federal Transit Administration (FTA) to ensure the agency is on track to meet the established triennial goal. OEO compiles and submits these reports to FTA on June 1st and December 1st of each calendar year.

The Metropolitan Council achieved 8.4% awarded DBE participation for this reporting period. The June report achieved 15.65% DBE on contracts awarded. Between the June and December reports, 14.02% was achieved on the contracts awarded for the year. The information compiled during reporting period April 1, 2021 – September 30, 2021 includes the following:








