 - Construction, A & E, Professional Technical Contracts
 - Annual goal set every three years (2021 – 2023 =14%)
 - Project specific goals assigned by Small Business Unit staff
 - Report utilization to FTA semi-annually
 - Achievement against annual goal is based on Awarded Contracts
