


# **Project Update**




# **Blue Line LRT Extension**

- Located in Hennepin County directly connecting downtown Minneapolis, Robbinsdale, Crystal and Brooklyn Park and communities in the northwest metro
- Serves some of the most racially, culturally and economically diverse communities in Hennepin County and will connect people to jobs and opportunities along the line and providing a one-seat ride to the airport and the Mall of America
- Supplemental Draft and Final Environmental Impact Statement (EIS) process underway for modified route adopted in June 2022
- Public engagement ongoing, including an Anti-Displacement
  Workgroup which is preparing recommendations this month

### **Request for Proposals Process**

- A single Request for Proposals (RFP) was issued in August 2022 with three parts (A, B and C)
- Proposers could propose on any or all of the parts
- Council indicated it could issue up to 3 contracts for the work



## **Request for Proposals Process**

- Part A: Engineering Services Scope:
  - Preliminary and Final Design
- Part B: Project Management Services Scope:
  - Independent cost estimating, scheduling, outreach and engagement support, Capital Investment Grant Program submittals, safety and security expertise and the overall quality oversight
- Part C: Risk Management Services Scope:
  - Risk management, peer reviews, value engineering and constructability reviews



### **Proposals Received**

- Eight proposals were received across the three scopes of work
- 52 registered plan holders
  - 24 identified as minority, women, small, veteran, or disadvantage business enterprises (DBEs)
- DBE goal ranged from 18-19%
- Brooks Act procurement following two-step process:
  - Step 1: Evaluation panel consisting of Council staff and project partners ranked the proposers for each of the three Parts A, B and C
  - Step 2: Cost data was requested for the highest ranked proposal for Part A, B and C



## **Contract Risk Considerations**

- Separation of scopes of work in the RFP process led to more consultant interest in proposing on the work
- Three contracts with three different consulting firms mitigates project risk by segmenting key tasks:
  - Contract A focuses on the Design and Engineering only
  - Independent Cost Estimating and Project Controls separated into Contract B
  - Risk Management is separated out into Contract C
  - Peer Review, Constructability, and Value Engineering separated into Contract C




## **Contract Risk Considerations**

- Limited Notices to Proceed (LNTP) to be issued for phases of work
  - Allows time to complete the next Capital Grant Agreement with Hennepin County and the Hennepin County Regional Railroad Authority
- Each of the contracts will extend through 2030
  - Contracts allow for termination at any time
- The Metropolitan Council will act again prior to a Full Funding Grant Agreement and Construction phase

That the Metropolitan Council authorize the Regional Administrator to negotiate and execute the Engineering Services Consultant (ESC) contract #22P103A with Kimley-Horn and Associates, Inc. for consultant services for the METRO Blue Line Light Rail Transit Extension (BLRT Project) in an amount not to exceed \$96,375,448 and issue Limited Notice to Proceed #1 in an amount of \$9,300,000.
