### Proposed action

That the Metropolitan Council authorize the Regional Administrator to execute 23M005D – Work Order # 4 in the amount of \$808,965 with Wabtec Railway Electronics, Inc.

### Background

Blue Line Enhancements Phase IIB Project (BLEP2B) will rehabilitate and upgrade track and signals on the existing METRO Blue Line between MOA Station and Terminal 2/Humphrey Station. The AIMRail SCADA system must be modified to incorporate the changes including, but not limited to, civil, track, communications, signal systems, overhead contact system, and traction power system work.

This is a Work Order Contract associated with the Wabtec Master Contract 23M005 which provides engineering, design, programming, testing, and integration services related to the Metro Transit light rail signal, communications, SCADA, and PACIS systems and the Northstar signal, communications, SCADA, PACIS, and PTC systems.

Work that is performed by Wabtec under the Master Contract is assigned a unique Work Order number and corresponding Alpha character for its Statement of Work and budget, per the job requested. This Business Item is to authorize 23M005D - Work Order #4 to make modifications to the AIMRail SCADA system required by the BLEP2B project.

The AIMRail SCADA system is a proprietary system of Wabtec. Due to the proprietary nature of the programming, only Wabtec is allowed to make programming and graphics modifications to the system.

### Rationale

The execution of a professional services contract exceeding \$500,000 requires Council approval.

### **Thrive lens Analysis**
