## By the numbers

- 7 planning meetings & 2 on-site walkthroughs
- ~60 staff on-site to help applicants
- 7:30am staff set-up time
- 8:45am first applicants welcomed
- **12:10pm** doors closed for new arrivals
- 3:05pm final behind the wheel completed
- 156 attended
- **140** completed an interview
- ~120 drove the bus!

## By the numbers cont.

- **117** passed the interview
- 25 moved to background check with a Class A or B with passenger endorsement
- 92 need Commercial Learner's Permit
  - 63 interested in week Zero
  - 29 will test for CLP on their own

## **Hiring Practice Changes**

#### • CLP Week Zero:

- 1/23: 2 started, 1 completed
- 1/30: 1 started, 1 completed
- 2/6: 0 started
- 2/13: 1 started
- Train Operator Staffing: Current 86 vs. Target 95
- Train Operator System Pick: Zero (0) train operators picked back to Bus
- External Train Operator Applicants:
  - 2/20: 2 Week Zero Rail Ops
  - 2/27: 6 Rail Ops starting (4 regular and 2 week Zero from 2/20)
- Future postings for Bus and Rail operators will be consolidated to include interviews and the first 2 weeks of training

## **Retention Strategies**

- Enhanced Probation
  - More than doubled touchpoints by instructors and managers with probationary operators
- Red Kite
  - Resilience training initially developed for first responders then adapted for front line workers. Bus and Rail operators attend 3 – 8 hour days
  - 818 participants since inception in November 2016
  - RFP is currently in proposal stage
- Bus Operator Apprenticeship
  - 2-year program that pairs new bus operators with a mentor
  - Currently have 185 apprentices and 60 mentors



- Bus maintenance and storage facility
- Basic maintenance for minor repairs
  - Change oil, tires
  - Fueling
  - Washing
- Home base for buses and drivers
  - Dispatch
  - Fare processing

## **Timeline to Opening**

- January- March 2023
  - Final Commissioning and punch list work
  - Equipment delivery and set up, fluid and parts delivery, final set up-testing technology systems
  - Internal coordination and assignments on going
- March 18, 2023
  - Begin daily operations from new garage.




View of North Loop Garage exterior

## **Project Considerations**

- Efficiently redistribute service throughout the system
  - Closure of Martin J Ruter Garage (MJR)
  - Opening of North Loop Garage (NLPG)
  - Scheduled service cost neutral
- Anticipate future Battery Electric Bus& BRT plans
- Consolidation of fleet types
- Balance express vs local work



### Assumptions - keep sub-fleets together

#### <u>BRT</u>

- A Line & Orange Line at South
- C & D Lines remain at FTH
- Assign B line to FTH/EMET (2024)
- Assign E line to FTH (2025)
- Assign F Line to FTH (2026)
- Assign Gold (2025) & Purple (2026) lines to EMET

#### **Battery Electric Bus**

- North Loop and East Metro next for electric buses
- Leave capacity for other garages to shift to FTH or NLPG during electrification



 Routes 3, 62, 67, 71, and 75 detour from Cedar, Kellogg, and Minnesota to Robert and other streets

#### **Osseo Road Detours**

- Summer 2023-2024 construction Osseo Road reconstruction Hennepin County
  - Redecking the bridge
  - Safety and accessibility upgrades
  - Complete & Green Streets elements
- C and D Line detour via 45Ave, Lake, France, Hwy 100
  - Skip 51Av/Brooklyn Station
- Rt. 5 detour adds one-way loop via 49Ave, Washburn, 51Ave, Brooklyn
  - Serve 51Av/Brooklyn and additional stop for coverage





- Bus layover location on Plymouth Ave and Theodore Wirth Parkway




## **Route 7 detour and VAMC deviation elimination**
