

## October 1, 2022 – March 31, 2023 FTA Report Summary

The current Metropolitan Council sets an overall DBE goal that is valid for 3 years. This is commonly called the Triennial DBE Goal. Metropolitan Council's current triennial goal is 14% overall, with a 11% Race -Conscious goal and 3% Race-Neutral. DBE Participation is based on awarded contracts and reviewed on a semi-annual basis by the Federal Transit Administration (FTA) to ensure the agency is on track to meet the established triennial goal. OEEEO compiles and submits these reports to FTA on June 1<sup>st</sup> and December 1<sup>st</sup> of each calendar year.

The Metropolitan Council achieved 6.5% awarded DBE participation for this reporting period. The information compiled during reporting period October 1, 2022 – March 31, 2023 includes the following: **(Note that all calculations are applied 80% - dollar values per FTA DBE regulation)**



Major contracts awarded that largely contributed to the total award above:




2. Master Contract for Bass Lake Spur Freight Rail Maintenance and Repair II – Contract 21P143B – amount \$4,137,954 (21.62%) – DBE Commitment 10.2%
3. OHB Hoists Replacement – Contract 22P206 – amount \$1,243,483 (6.5%) DBE Commitment 18.78%
4. Of the 29 Prime Contracts: 12 Contracts had DBE Subcontracting Opportunity - \$8,614,266 and 17 Contracts had No Opportunity for Subcontracting \$10,529,150




