# 2040 TPP Amendment



## Five Regionally Significant Projects

- I-94 Albertville to Monticello lane addition in Wright County
- US 169/CSAH 59 new interchange in Scott County
- US 10 lane addition in Anoka County
- MN Highway 65 and 117<sup>th</sup> Ave new interchange in Anoka County
- MN Highway 13 new grade separations in Dakota and Scott counties

# 2040 TPP Amendment



## Summary of Public Comments

- Public comment period closed on October 31.
- 26 public comments received.
- 21 supportive comments
  - 16 for the I-94 Albertville to Monticello lane addition
  - 2 for US 169/CSAH 59 interchange
  - 1 for MN 65/117<sup>th</sup> Ave interchange
  - 2 for MN 13 grade separations
- 5 comments expressing opposition – general opposition to highway expansion and its role in contributing to induced demand.

# Proposed Action – TPP Amendment

That the Metropolitan Council:

- Accept the 2040 Transportation Policy Plan Amendment 2 Public Comment Report
- Adopt Amendment 2 to the 2040 Transportation Policy Plan adding five regionally significant highway projects

# TIP Amendment



## Two Regionally Significant Projects

- **I-94 Albertville to Monticello lane addition in Wright County**
- **US 169/CSAH 59 new interchange in Scott County**
- US 10 lane addition in Anoka County
- MN Highway 65 and 117<sup>th</sup> Ave new interchange in Anoka County
- MN Highway 13 new grade separations in Dakota and Scott counties

# TIP Amendment



## Summary of Public Comments

- Due to construction starting next spring, two of the five projects in the TPP amendment required a TIP amendment at this time. The other three projects will be added to the TIP at a later date.
- Public comment period from October 19 to November 8.
- 24 public comments received.
- 10 supportive
  - 10 for I-94, plus 1 suggested improving westbound access at CSAH 37 to be added to the project
  - 3 for Scott County
- 13 opposed
  - 13 for I-94
  - 3 for Scott County
- One comment with unrelated content.

# Proposed Action – TIP Amendment

That the Metropolitan Council adopt an amendment to the 2024-2027 TIP to add two regionally significant projects:

- Lane additions on I-94 from Albertville to Monticello in Wright County and
- New interchange at US 169 and CSAH 59 in Scott County
