

April 1, 2024 – September 30, 2024, FTA Report Summary

The Metropolitan Council's annual DBE goal is set for fiscal years 2024-2026. This is commonly called the Triennial DBE Goal. The current triennial goal is 13.4% overall, with an 11% Race -Conscious goal and 2.4% Race-Neutral. DBE Participation is based on awarded contracts and reviewed on a semi-annual basis by the Federal Transit Administration (FTA) to ensure the agency is on track to meet the established triennial goal. OEEO compiles and submits these reports to FTA on June 1st and December 1st of each calendar year.

The Metropolitan Council achieved 17.42% DBE participation on awarded contracts this reporting period. The June report achieved 9.6% DBE on contracts awarded. Between the June and December reports, 13.5% was achieved on the contracts awarded for the year. The information compiled during the reporting period April 1, 2024- September 30, 2024 includes the following:

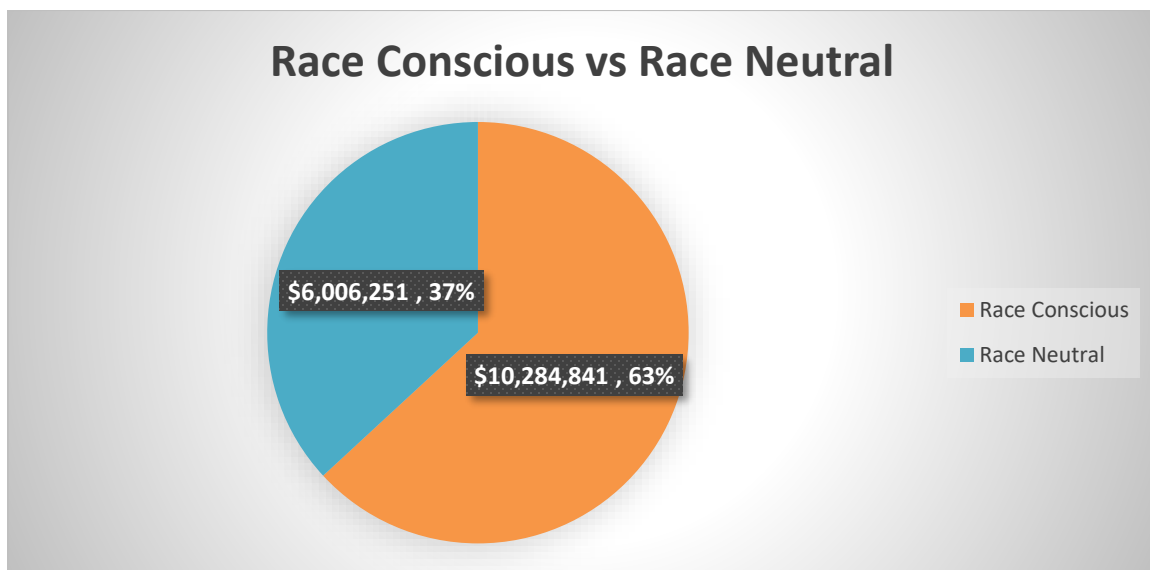

5. **Fastfare Farebox Upgrade** – contract 24P209 – amount \$3,606,926 (3.86%) – Sole Source - Since it is not publicly solicited no goal was set. DBE Commitment 0%.

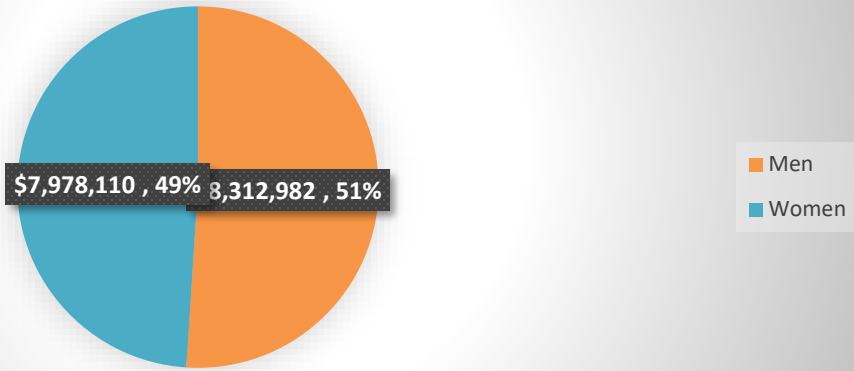
Race-Conscious versus Race-Neutral Contracts:



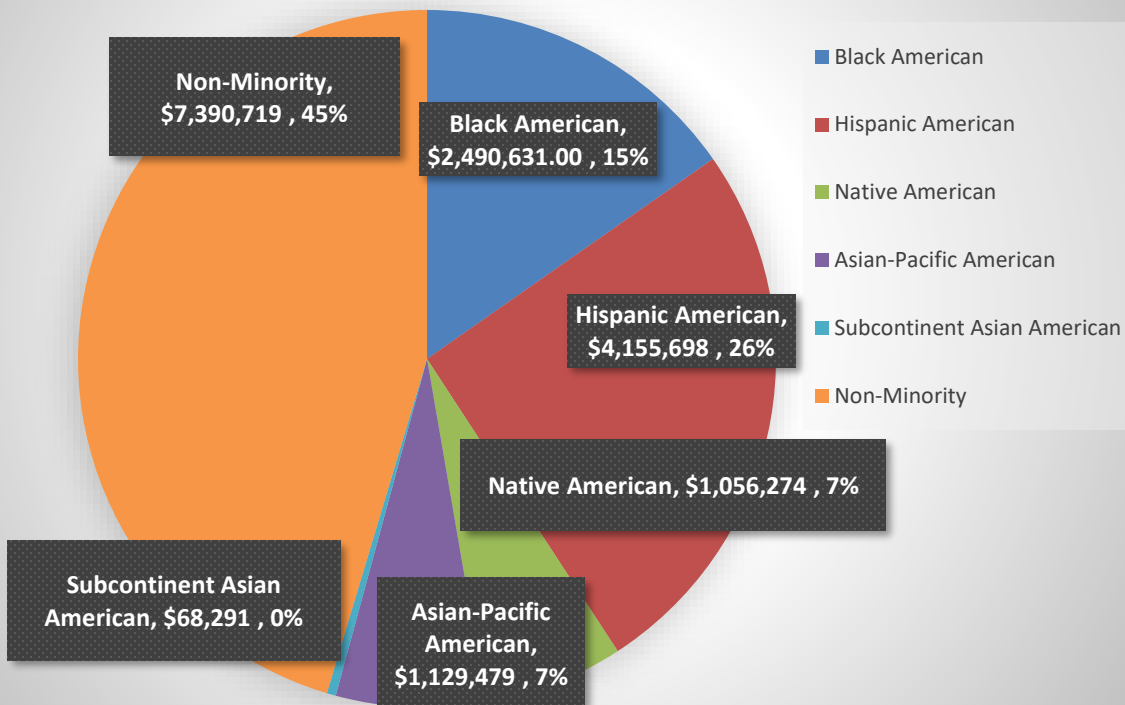

Awards by Gender



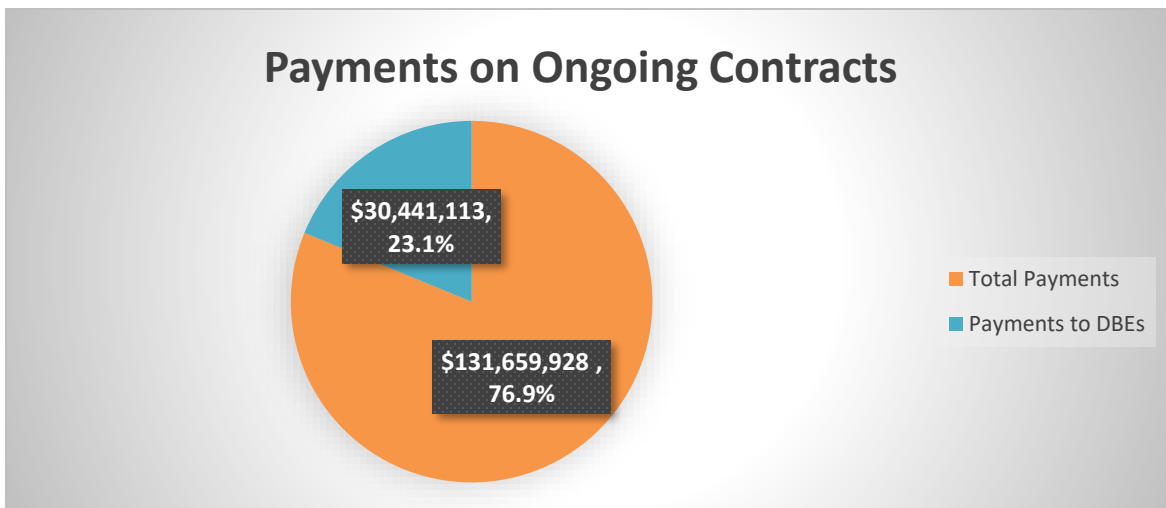
Award Amounts by Ethnicity



DBE's were awarded **104 (47.27%)** of the overall 220 subcontracts

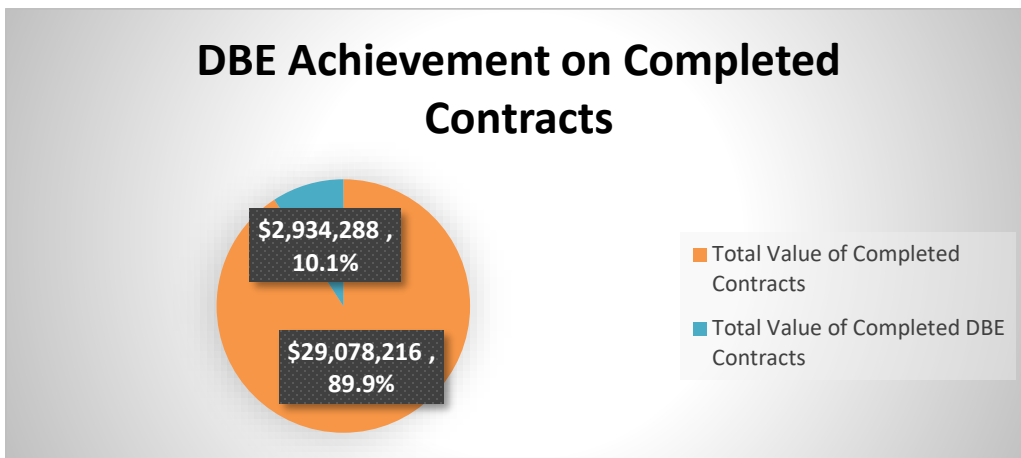
