#### **Proposed Action**

That the Metropolitan Council adopt an amendment to the 2025-2028 Transportation Improvement Program (TIP) to add consultant services for a study of dual turn lanes on CSAH 83 (Canterbury Rd) near US 169 in Shakopee.

#### Background

MnDOT requests an amendment to the 2025-2028 Transportation Improvement Program (TIP) to add consultant services for a study of dual turn lanes on CSAH 83 (Canterbury Rd) near US 169 in Shakopee. The project would be funded with Highway Safety Improvement Program (HSIP) funds not provided through the competitive HSIP Solicitation. Intersections to be explored are at 12<sup>th</sup> Avenue; north and south US 169 ramps; Eagle Creek Boulevard and Deans Lake Boulevard; and 17<sup>th</sup> Avenue and Eagle Creek Boulevard.

#### Rationale

The Metropolitan Council approves formal amendments to the TIP. The project is consistent with the Transportation Policy Plan (TPP) and meets fiscal constraint because the federal and state funds are sufficient to fully fund the project.

#### **Thrive Lens Analysis**

This action promotes livability by exploring ways to reduce crossing distances and collision points at intersections.

#### Funding

This project is fully funded with federal funds.

#### **Small Business Inclusion**

This project is federally funded. The Minnesota Department of Transportation will oversee the federal requirements, including the DBE requirement.

This formal amendment is to add a new state fiscal year 2025 project into the 2025-2028 TIP.


## Fiscal Constraint (as Required by 23 CFR 450.216)
