October 1, 2024 – March 31, 2025, FTA DBE Semi-Annual Report Summary

The Metropolitan Council's annual DBE goal is set for fiscal years 2024-2026. This is commonly called the Triennial DBE Goal. The current triennial goal is 13.4% overall, with an 11% Race -Conscious goal and 2.4% Race-Neutral. DBE Participation is based on awarded contracts and reviewed on a semiannual basis by the Federal Transit Administration (FTA) to ensure the agency is on track to meet the established triennial goal. OEEO compiles and submits these reports to FTA on June 1st and December 1st of each calendar year.

The Metropolitan Council achieved 26.9% awarded DBE participation for this reporting period. The information compiled during reporting period October 1, 2024 – March 31, 2025 includes the following: (Note that all calculations are applied 80% - dollar values per FTA DBE regulation)












DBE's were awarded 31 (26.9%) of the overall 66 contracts.
