# **Proposed action**

That the Metropolitan Council approve an amendment to the 2026-2029 Transportation Improvement Program to add its Southwest Transit Station Rehabilitation project.

## **Background**

In 2024, SouthWest Transit was awarded funds in the Fiscal Year 2024 FTA Bus and Low- and No-Emission grant program for its Southwest Station rehabilitation. The award is to rehabilitate the Southwest Station Park and Ride and the bus garage. This project includes ADA and security improvements for riders, as upgrades to the maintenance facilities to improve safety for workers. This project was not funded with Regional Solicitation funds.

### Rationale

The Metropolitan Council approves formal amendments to the TIP. The projects are consistent with the Transportation Policy Plan (TPP) and meet fiscal constraint because the federal, state, and local funds are sufficient to fully fund the projects.

# Thrive lens analysis

On Feb. 12, 2025, the Council adopted Imagine 2050, which builds on policy direction in Thrive MSP 2040. Under the Thrive lens, this project furthers the stewardship indicator by maintaining our existing transit stations.

# Funding

This project is fully funded with federal and local funds.

# Small business inclusion

The project included in this request is federally funded. Until SouthWest Transit becomes a direct FTA recipient in the near future, the agency works through the Council's grant administration team in coordination with OEEO and Procurement to include DBE requirements on relevant projects.


# Fiscal Constraint (as Required by 23 CFR 450.216)
