Existing Structure

- Outcomes (5 from *Thrive MSP 2040*) – Desired outcomes that define our shared regional vision.
- Principles (3 from *Thrive MSP 2040*) – Guide how the Council carries out its policies, both internally and externally, to advance outcomes.
- Transportation Goals (6) – A broad statement that describes a desired end state.
 - Stewardship
 - Safety and Security
 - Access to Destinations
 - Competitive Economy
 - Healthy and Equitable Communities
 - Leveraging Transportation to Guide Land Use
- Objectives (19) – A specific, measurable statement that support the achievement of goals.
- Strategies (58) – Actions that can or will be taken to address goals and objectives.

Scope of Work



Task 1: Work Plan and Schedule



Key Deliverables

- Project management team agendas, materials, and notes
- A detailed work plan identifying key stakeholder groups, tentative schedule, and data needs

Task 2: Summary of Existing and Peer Region Plans



Key Deliverables

- Summary of important and recurring statements about goals and objectives (or similar) from MnDOT, Council, and up to 15 local plans
 - Include an assessment of the notable similarities or differences, including any that are based on geography or other factors
- Synthesized themes from six peer region long-range transportation plans, including a list of notable goals or objectives that address already identified gaps
 - Focus on peer region plans covering areas of similar population and land use or that introduce innovative approaches

Task 3: Engagement Workshops and Listening Sessions



Key Deliverables

- Organize and facilitate at least two workshops and eight listening sessions as well as five additional events with format TBD
 - Listening sessions with each county board and staff
 - Workshops or listening sessions with cities
 - Flexibility to address other groups, as needed
- A report summarizing key themes discussed during engagement, including any notable differences based on geography or other factors

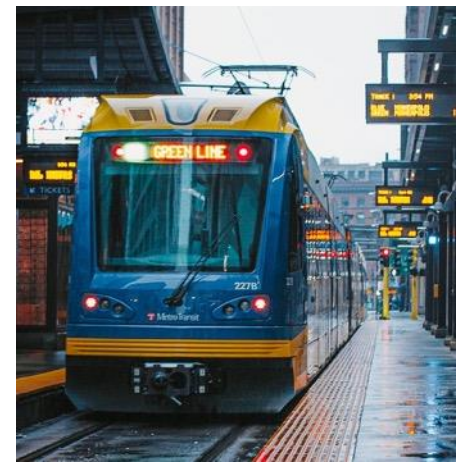
Task 4: Coordination with Equity Engagement Consultant

Scope includes coordination but not actual engagement (separate contract)

- Five coordination meetings with equity engagement consultant
- Provide supporting materials for engagement
- Ensure consistency and seamless reporting and integration of results

Equity Consultant

- Use Council master contracts
- Engage with groups that are historically underrepresented, complement the engagement (e.g., primarily local government focus) in this contract



Task 5: Evaluation of 2040 TPP, Recommendations, and Summary Report



Key Deliverables

A summary report and presentation that includes themes from Tasks 2-4 and an assessment of the 2040 Transportation Policy Plan goals and objectives with recommendations for improvements for the 2050 TPP and Metropolitan Development Guide
