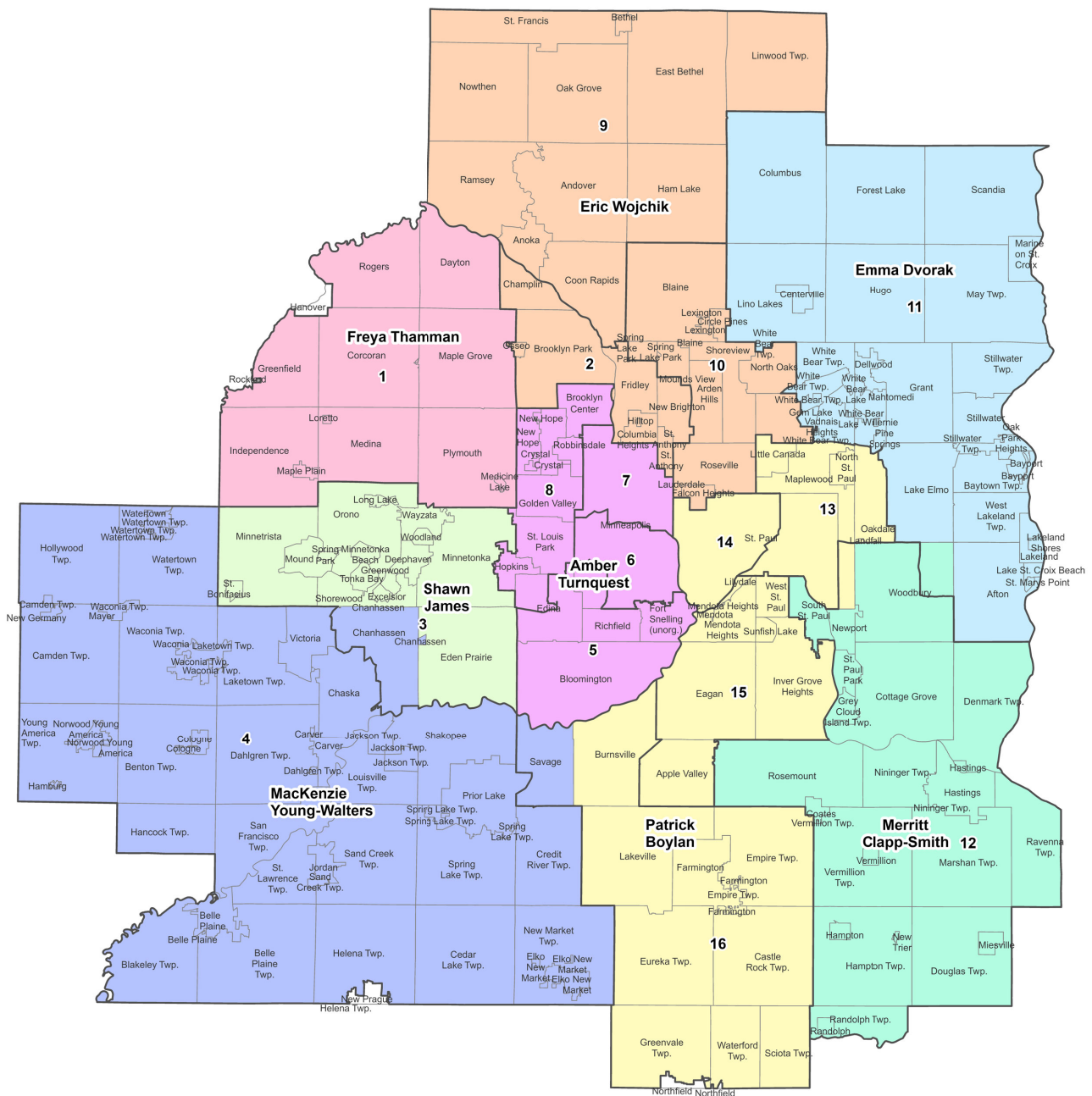


SECTOR REPS BY COMMUNITY
