Metro HRA Section 8 Housing Choice Voucher (HCV) Waiting List Opening FAQ

Q: How do I find out if I made the lottery?

A: 2000 applicants will be randomly selected and placed on the Metro HRA's Section 8 Housing Choice Voucher (HCV) Waiting List. Results of the Metro HRA lottery will be posted to <u>www.waitlistcheck.com</u> on July 8, 2022. You will need to enter your username and password to view your status.

Until the lottery is completed, your status will say pending.

After you log in your status will either indicate ACTIVE or INACTIVE

ACTIVE=Randomly selected in the lottery and you are on the waiting list for Section 8 HCV at the Metro HRA **INACTIVE**=Not randomly selected in the lottery and you are NOT on the waiting list for Section 8 HCV at the Metro HRA

Q: My status says inactive. Why?

A: Your name was not selected in the random lottery.

Q: Why didn't I qualify for the lottery?

A: There was nothing you did to not qualify. Placement on the list was done through a random selection through the computer.

Q: My status says active. Why?

Your name was selected in the random lottery. You will be placed on the Metro HRA's Section 8 HCV waiting list.

Q: I was randomly selected for the Metro HRA's Section 8 HCV Waiting List. What do I do now?

You will wait for your name to be selected from the waiting list. Please use <u>www.myassistanceconnect.com</u> to report any changes in your address or family size. If you move and we are unable to locate you, your name may be removed from the waiting list.

Q: My status says I am active. Can I go get an apartment now?

A: You have applied for the waiting list. You may wait 3-5 years for assistance. Final eligibility is determined when your name is selected from the waiting list.

Q: How long will I wait for a voucher?

A: Applicants that are placed on the Metro HRA's waiting list, could wait 3-5 years for a voucher.

Q: Where can I live with a voucher?

The Metro HRA offers assistance in communities throughout Anoka, Carver, and suburban Hennepin and Ramsey Counties, excluding the cities of St. Paul, Minneapolis, Bloomington, Plymouth, Richfield and St. Louis Park.
