SUMMARY

The Metropolitan Council is the designated Metropolitan Planning Organization (MPO) for the Minneapolis/St. Paul urban area and is responsible for continuing, comprehensive, and cooperative (“3C”) transportation planning in the region. Through the Transportation Advisory Board (TAB), the Metropolitan Council is required by the Infrastructure Investment and Jobs Act (IIJA) to oversee the allocation of federal funds for transportation projects.

The Metropolitan Council and TAB annually adopt the Transportation Improvement Program (TIP), a program of federally funded projects programmed by the Metropolitan Council and Minnesota Department of Transportation (MnDOT). This report is the Annual Listing of Obligated Projects for Fiscal Year 2022.

Table 1 displays all federally funded highway, non-motorized, and MnDOT Mobility projects obligated during State of Minnesota fiscal year 2022 (July 1, 2021 to June 30, 2022). Table 2 displays transit projects obligated during federal fiscal year 2022 (October 1, 2021 to September 30, 2022). Both tables include projects funded through TAB’s bi-annual Regional Solicitation for transportation projects. Total project and total federal amounts reflect administrative modifications and TIP amendments completed throughout the year.
