I met last week with Dennis Gimmestad and Jackie Sluss for a corridor tour and discussion of their findings of effect. Jackie will be preparing a letter documenting their findings. I think that the letter will state that there is a general potential for effect but will not state any specific areas of adverse effect as they think that everything can most likely be resolved through design discussions. They may flag a few areas including the Raymond station area, the Capitol, the 10th Street station, and Union Depot. They had some specific questions that I need your help to answer:

- 1. What will the station elevation be at Raymond? Will it be at-grade or a raised platform? If the latter, how high will the platform be? Note: I expect that they will want to see some special architectural design of this station.
- 2. What is the alignment on Cedar (center or side which side)? This is important because if center running, it affects the green space which ties to the Capitol.
- 3. Where is the specific alignment of the station at 10th? If it is north of 10th, it is likely not a problem. If it is south of 10th, then they may require some special design treatments due to the three historic church buildings in that area.
- 4. Where is the specific alignment of the station at Rice? If it is entirely west of Rice, then it is not a problem. If it is partially or entirely east of Rice, then they may require some special design treatment due to the Ford Building and the church.
- 5. Will the station at the Depot impact the green space? The plan view drawing done by the consultant suggests that it would not but this would be an issue for SHPO. They are not concerned about the loss of access to the driveway as long as the circular driveway stays in place.
- 6. What is the status of discussions of realignment to bring light rail behind the Depot and under the concourse? They would much prefer this alignment.
- 7. They would like more information on the west portal at the UM. Could you email me the illustrations done by the consultant on this. I don't think that this will be an issue but they have some concerns about visual impacts.

I'll forward your responses on to Jackie and Dennis. Once we receive the letter, then that will need to be reflected in the FEIS and we will need to consult with them on design as PE proceeds. Overall, their concerns are not major - they seem to understand cost issues but want to have input on station locations and station design at the above mentioned locations.

### Charleen:

- 1. The platform east of Raymond and elsewhere would be 14" above top of rail to accomodate level wheelchair boarding.
- 2. The current plans are for LRT to be in the median crossing I-94 on Cedar.
- 3. The station is currently between 10th and 11th. This station will likely get some close scrutiny in cost-saving efforts.
- 4. Current plans show the station just west of Rice with a center platform.
- 5. It depends. Some drawings show a dual platform, three track station that would probably encroach on the green space. If it's just a center platform, perhaps with tail tracks, I think that could be avoided. Auto access to the driveway would be lost, however. While that's not an issue for SHPO, it probably is for the building owner.
- 6. It's much too early to tell whether the concourse station will work out or not. It might create some visual issues along the side of the Depot to get to the track level at the concourse. It's a plus in that it would allow room to have a light maintenance/storage facility there and provide good intermodal connections. It's a negative from the standpoint of cost and it makes people using LRT to the Lowertown area walk farther.
- 7. The U is lobbying to move the West Bank station east into the tunnel. Potentially a significant cost item. I have attached three drawings that give an idea of how the DEIS alternative might look.

We are providing your office with this information pursuant to our FHWA-delegated responsibilities for compliance with Section 106 of the National Historic Preservation Act, as amended (36 CFR 800).

As you know the cultural resource survey, identification, and evaluation for the current proposed Central Corridor has been completed. Our office has identified thirty-one individual National Register-listed or eligible properties and one district within the area of potential effect for this project. We have been working with your office to assess effects to these properties. Only one adverse effect is clear at this time: the removal of the Minnesota Transfer Railway Company University Avenue Bridge (RA-SPC-6310).

Other anticipated effects are generally related to station design and pole and line placement. Recent project information indicates that the Rice Street station will be located west of Rice Street thereby avoiding effects to the Norwegian Evangelical Lutheran Church and the rear of the Capitol building. In addition, the 10<sup>th</sup> Street station will be north of 10<sup>th</sup> Street between 10<sup>th</sup> and 11<sup>th</sup> Street, reducing the effects of a station closer to the cluster of religious buildings at Exchange Street. The anticipated height of the station platform at Raymond will be about 14" above the rail in order to accommodate wheelchairs. And recent discussions are exploring the possibility of moving the West Bank station on Washington Avenue into the underground tunnel. Every reasonable effort will be made to avoid and reduce effects to eligible and listed cultural resources from these sources. However, several areas of concern will remain open until final designs are worked out:

- •the design of the Union Depot station in St. Paul
- •the location of the transit line in the median of Cedar Avenue and its visual effects on the view of the approach to the State Capitol Building
- •station location and design near the Central Presbyterian Church, St. Agatha's Conservatory, and St. Louis King of France Church that cluster at Exchange Street

- •the underground tunnel and station at the University of Minnesota Minneapolis Campus
- •station design in the Raymond-University Historic District
- •potential effects to Porky's drive-in from the traffic change caused by closing the median at Linhurst
- •the rear elevation of the capitol building on University Avenue

We will continue to consult with your office on these design issues to avoid and reduce effects along the project corridor.

We are providing you with this determination pursuant to the responsibilities given the State Historic Preservation Office (SHPO) by the regulations at 36 CFR 800.



We are providing your office with this information pursuant to our FHWA-delegated responsibilities for compliance with Section 106 of the National Historic Preservation Act, as amended (36 CFR 800). Your letter of August 21, and our later phone conservation, indicates that you have concerns that some properties considered significant in local St. Paul studies were not considered or were left out of the final 2004 report for the Central Corridor. At that time I said I would review the project methodology to ensure that no properties had been overlooked.

A review of the methodology and bibliography contained in Phase II Architectural History Investigation for the Proposed Central Transit Corridor completed in 2004 by the 106 Group Ltd. explains the effort to include past cultural resource identification and evaluation efforts as well as new information generated by the 2004 phase I and II surveys (Introduction, pages1-3, Methods, page 13, and bibliography). All existing inventories of properties along the realigned corridor were reviewed as part of the literature search, including those of the 1983 Saint Paul and Ramsey County Historic Sites Survey as well as those generated by other studies and held in the State Historic Preservation Office (SHPO) files. Existing literature used in the study included the 2001 Saint Paul Historic Context Studies developed by Landscape Research, Inc. as well as the information gathered for the ongoing Prospect Park eligibility study and the National Register certification for the Raymond University Commercial District.

The 2004 survey was completed between 29th Street in Minneapolis and the Union Depot in St Paul along an alignment that largely follows existing University Avenue (figure 1 of the report). Since the proposed project will take place within the existing curb line of a busy commercial thoroughfare, the area of potential effect (APE) for the survey included the first tier of properties along the corridor. The APE was expanded where station construction and resulting development could be anticipated. St. Paul neighborhood planning documents from communities along the corridor were consulted in order to understand growth potentials at the stations.

The list of eligible properties on the Central Corridor that you received as part of the series of open houses conducted for this project in May 2006 is slightly different than the list provided in the 2004 report. This discrepancy can occur when the MnDOT Cultural Resources Unit (CRU) or SHPO do not concur with the recommendations of the report. The properties on the final May 2004 list were determined to be eligible for the National Register of Historic Places in consultation with the State Historic Preservation Office. These properties meet National Register of Historic Preservation Eligibility Criteria, which are the criteria used to identify significant historic properties in federally-funded undertakings under Section 106.

I hope this addresses your concerns about the extent and thoroughness of the survey. In addition, our office recognizes your request to be consulted in the development of the MOA for this project. If you have any questions regarding this project, please contact me at (651) 296-3065.

Thank you for the opportunity to review and comment on the results of the identification and evaluation activities for the above referenced project.

We have reviewed the report of the survey of the project area, completed by The 106 Group. In addition, we have reviewed the May 2006 "Summary of Cultural Resource Impacts, Central Corridor Transit Study". Our comments below are based on the information presented in the May 2006 summary.

- 1. The Minnesota Linseed Oil & Paint Company Building appears to have an incorrect address. Our records show it at 1101 3<sup>rd</sup> Street.
- We would suggest that the historic district at the University of Minnesota be titled the "University of Minnesota Mall Historic District". A map of the district boundaries is needed for use in completing the Section 106 review.
- 3. It would appear that the Minnesota Transfer Railway Company Main Line and the Minnesota Transfer Railway Company University Avenue Bridge should be combined into a single historic property the Minnesota Transfer Railway Company Historic District. A map showing the district boundaries is needed.
- 4. A map of the State Capitol Mall Historic District is needed. This district should include the Power Plant, which should then be removed from the summary list as a separate property.
- 5. The First National Bank Building appears to have more than one address; we also show the building under 332 Minnesota Street. The correct address or addresses for the building should be clarified to avoid future confusion.
- 6. The list includes separate entries for the Pioneer Building and the Pioneer and Endicott Building. The listing and the maps need to be clarified.
- 7. Fire Station #25, which is considered eligible, is missing from the list.

8. The Minnesota Building, located at 46 East 4<sup>th</sup> Street, is currently under review by our office for National Register eligibility. If determined eligible, it will need to be added to this list.

We recommend that a consultation meeting be scheduled with the staffs of the Minneapolis and St. Paul Heritage Preservation Commissions, to review the methodology and findings of the identification efforts, and to assure that the commissions find the surveys to be adequate. We would like to be included in this meeting.

As you indicate, it is clear at this time that the project will have an adverse effect on at least one historic property – the proposed removal of the Transfer Company Railroad Bridge over University Avenue. There are other potential adverse effects as well, including, but not limited, to, visual effects of the catenary near certain properties (for example, Central Presbyterian Church, St. Louis King of France Church, Norwegian Evangelical Lutheran Church, and the State Capitol), visual/other effects from the proposed tunnel within the University of Minnesota Mall Historic District, and visual/landscape effects at the St. Paul Union Depot. Your letter of 27 July 2006 includes other potential effects as well. It is important that all potential effects are clearly identified early in the project planning/design process, when there is the greatest latitude for development of alternatives that could avoid or reduce the number and magnitude of effects on historic properties.

Thank you for giving the Heritage Preservation Commission (HPC) the opportunity to review and comment on the summary information regarding eligible historic properties and potential effects from the Central Corridor Project. We also appreciate your response dated December 5, 2006 regarding concerns the HPC had about the extent and thoroughness of the 2003 survey. It is our understanding the first survey, completed in 1995 by BRW, Inc. and Hess, Roise and Co., evaluated the route which at that time was along Interstate 94 then to downtown St. Paul and terminating at the Union Depot. The 2003 survey work, completed by The 106 Group, only evaluated and surveyed those properties not evaluated in the 1995 survey work which is mostly the route along University Avenue.

The HPC formed a committee and along with staff reviewed the summaries and lists of both the 1995 and 2003 surveys. The committee also drove along the University Avenue route to better understand the contexts of the corridor. One of the committee members, Paul Larson, meets the Federal Standards for History and three of the members, Lee Meyer, Richard Faricy and Diane Trout-Oertel, are registered architects.

In addition to being consulted in the development of the MOA for this project, the HPC is requesting your consideration or re-consideration of the eligibility of certain properties to the National Register. There are a few reasons for requesting updated evaluations. First, several years have lapsed since the 1995 evaluation of the downtown properties. Some buildings along the route have become older than 50 years since 1995 and the Minnesota Building, at 46 East 4<sup>th</sup>, originally determined not eligible is currently under review by the State Historic Preservation Office. Second, a few properties along University Avenue may not have gotten the necessary level of survey in determining eligibility. And third, information available to the HPC on some properties indicating potential eligibility was inconsistent with the survey's determination of eligibility. The properties are as follows:

### 1. Downtown:

Athletic Club Building, 340 Cedar Street Minnesota Building, 46 East 4<sup>th</sup> Street Pioneer Building, 345 Cedar Street (now more than 50 years old)

2. University Avenue and vicinity:

Minnesota Milk Company, 370-380 University Raths-Seavold Mfg. Company, 823 University Victoria Theater, 825 University TipTopTap, 1415 University Quality Park Investment Company, 1575-79 University St. Matthew's Evangelical Lutheran Church, 507 N. Dale

Outside the scope of the Section 106 review process, the HPC would like to stress that several other buildings along this Central Corridor are considered to potentially have historical significance and be eligible for designation on a local level. For your information, a list of properties is attached that the HPC believes warrants further study to determine significance on a local level.

We write regarding the impact of the Central Corridor LRT line on historic properties located on Cedar Street between 7th and 10th Streets in downtown Saint Paul. We are interested in knowing if the appropriate reviews and studies have been performed that are required by Section 106 of the National Historic Preservation Act (36CFR800).

National Register properties in this area include Central Presbyterian Church at 500 Cedar Street and St Agatha's Conservatory of Music and Arts (Exchange Building) at 26 East Exchange Street. Both are also designated by the Saint Paul Heritage Preservation Commission.

The Church of Saint Louis, King of France and Parish House at 506 Cedar Street is generally considered to have historic interest and has been declared eligible for the National Register, but it is not currently listed in the National Register or with the city's Historic Preservation Commission (HPC).

The Sam S Shubert (Fitzgerald) Theatre and Shubert Building at 10 East Exchange Street have also been declared eligible for the National Register and are under consideration for designation by the HPC.

There is concern that the vibration caused by the construction and operation of the Central Corridor LRT line would have a significant negative impact on these historic structures, and that the existence of the line would have a negative impact on the viewscape to and from these structures.

In addition, there is concern that the construction of the LRT line along Cedar Street would negatively affect the viewscape to and from the Minnesota State Capital, as envisioned by Cass Gilbert in his seminal studies of the Capital Approach. The Minnesota State Capitol was listed on the National Register of Historic Places in 1972.

We are working closely with the Met Council to ensure that the line is designed in a way that will mitigate the effects of the LRT line where possible.

Please let us know if this situation has been reviewed by your office.

# Description of historic properties located on Cedar between 7<sup>th</sup> and 10<sup>th</sup> streets:


Central Presbyterian Church at 500 Cedar Street was placed in the National Register of Historic Places on February 10, 1983. The one-paragraph Statement of Significance in the National Register nomination states, "Central Presbyterian Church, built from 1888-1890, is historically and architecturally significant as one of St. Paul's earliest Presbyterian congregations established in 1852, as one of the city's finest Richardsonian Romanesque churches and one of only two designed on such a large scale, and as one of the few known St. Paul designs of prominent Minneapolis architect Warren H. Hayes, a specialist in church design who is credited with developing the 'diagonal' form of auditorium employed in the Central Presbyterian Church." The primary (west) facade on Cedar Street remains virtually unchanged, though the removal of the garage/office building as a result of the project improved the view of this façade. The south façade, facing the pocket park, was restored to its historic appearance as a result of the project.

St Agatha's Conservatory of Music and Arts (Exchange Building) at 26 East Exchange Street was placed in the National Register on May 25, 1989. The one-paragraph Statement of Significance simply reads, "St. Agatha's Conservatory of Music and Arts is significant as the oldest of the four arts education institutions established in the Twin Cities before the turn-of-the-century that survived well into the 20<sup>th</sup> century." The more detailed Statement of Significance makes no mention of the building, although the Description section states, "St. Agatha's was designed in the Beaux Arts style with identifying features such as: facade symmetry with a centered entrance, pilasters, decorative banding with shields, a low pitched hipped roof, and an accentuated cornice."

Church of Saint Louis, King of France and Parish House at 506 Cedar Street is not on the National Register but has been declared eligible for the Register. The one paragraph Statement of Significance on the 1981 draft nomination form states, "The Church of Saint Louis, built in 1909, is historically and architecturally significant as one of St. Paul's few remaining links to its rich French Canadian heritage, as one of the oldest Roman Catholic parishes in the Twin Cities and one of only five churches which remain in downtown St. Paul, and as the work of a nationally prominent French-born Beaux Arts architect, Emmanuel Masqueray (1861-1917)."

The Sam S Shubert (Fitzgerald) Theatre and Shubert Building at 10 East Exchange Street and 488-494 Wabasha Street, respectively, are not on the National Register though they have been declared eligible for the register. The one paragraph Statement of Significance on the 1984 draft nomination form states, "The Sam S. Shubert Theater in downtown St. Paul is significant as the best preserved theatrical house in the downtown entertainment districts of Minneapolis and St Paul associated with the local development of the of the legitimate theater before the advent of the motion picture industry." The more detailed Statement of Significance makes passing reference to "an adjacent Shubert building." The Description does mention both the Shubert Theater and the Shubert Building.

We last wrote you regarding the above referenced project on 18 January 2007. We have appreciated the numerous opportunities to consult with your office, the Metropolitan Council staff, and other interested parties since that time. We are writing now to provide updated comments about several aspects of the Federal Transit Administration's Section 106 review and its relationship to the larger project planning process.

- 1. We have received the 28 February 2008 summary chart on the status of the identification/evaluation of historic properties in the project area, prepared by Hess Roise. This listing includes 44 properties that are listed on the National Register, determined eligible to the National Register, or currently under evaluation. The chart provides a good basis for continuing consultation. Of course, we recognize that additional survey and evaluation of properties may be needed for additional project areas that are added, as well as for any changes in project design which increase the area of potential effect.
- 2. We have a concern about the current status of the assessments of effect on historic properties. We acknowledge the fact that we have had a number of discussions about effects on historic properties in various project areas, but a comprehensive effects assessment is needed. We recognize that, like the list of historic properties, the effects assessment will need to be expanded as project elements change and as additional properties are identified and evaluated. However, for the substantial number of listed/eligible properties that are now known, it is important that thorough assessments of effect be completed promptly. Extensive planning efforts are currently underway to refine or modify project elements, and the lack of clear information about effects to historic properties means that planning decisions can be made without considering historic property issues. Of course, it will be important to have clear information about project effects for all known historic properties in the Supplemental Draft EIS.

- 3. We note that your letter of 27 July 2006 acknowledged one adverse effect, resulting from the proposed removal of the eligible Minnesota Transfer Railway Company University Avenue Bridge. The project design in this area has been changed, and this bridge is no longer proposed for removal. However, there are several other historic properties with significant potential for adverse effects. We would expect that some of these effects may be resolved through avoidance and/or the development of mitigation measures before completing the Section 106 agreement, but many will need to be resolved programmatically through stipulations outlined in the agreement. Due to the size of the project, the number and importance of the historic properties, and the substantial public interest, we would strongly recommend that you work with the Federal Transit Administration to notify the Advisory Council of the initiation of consultation at this time.
- 4. Of course, effects on all historic properties need to be addressed. That said, we have identified five areas that may merit some special attention due to the complexity of the issues and/or involvement by interested parties. These areas are listed below, along with parties we know of who have been already involved in discussions or who have discussed the project with our office. We appreciate the fact that you are identifying other interested parties as well.
  - A. University of Minnesota area (Jim Litsheim, University Architect's Office; John Anfinson, National Park Service).
  - B. State Capitol area (Nancy Stark, Capitol Area Architectural and Planning Board; Carolyn Kompelien, MHS State Capitol Site Manager).
  - C. St. Paul Union Depot area (Steve Morris, Ramsey County Regional Rail Authority)
  - D. Cedar and Exchange area (Rev. David Colby, Central Presbyterian Church; Jeff Nelson, Minnesota Public Radio).
  - E. Prospect Park area (Joseph Ring, Prospect Park East River Road Improvement Association [has requested consulting party status]).

As you know, the St. Paul Heritage Preservation Commission has expressed a continuing interest in the project. We understand that Historic Saint Paul has recently requested consulting party status. The Minneapolis Heritage Preservation Commission and the Preservation Alliance of Minnesota may have an interest as well.

We appreciate your willingness to engage in discussions about the effects assessments for the above five areas – as well as for the other historic properties along the corridor - in the near future.

5. It would be helpful to coordinate Section 4(f) considerations into the overall discussions of project effect.

Now that the Central Corridor Light Rail project between St. Paul and Minneapolis has been approved by our Metropolitan Council the Prospect Park East River Road Community feels the time has come for us to communicate our concerns about possible negative impacts to our proposed Historic District, now in the final stages of the nomination process with the Minnesota State Preservation Office.

The first of our concerns is the commercial building at 3400 - 3408 University Avenue Southeast (SHPO Inventory Number HE-MPC-2998). This is the only commercial contributing property in the District that is on University Ave, and is only one of a total of three within the District as a whole.

The Metropolitan Government plans now call for all parking in front of this building to be taken away which most likely render it commercially unsustainable. This fact would greatly add to pressures to redevelop this building at some future date.

The second item concerns the impact the closure of Washington Avenue through the University of Minnesota would have on traffic in Prospect Park. The increased amount of traffic coupled with the loss of the ability to make left turns on to or off of Prospect Park Streets that intersect with University Avenue would greatly increase the pressure and volume for traffic on Franklin Avenue Southeast, which travels East to West down the middle of the Historic District. If this would be the case the Livability of the District would be greatly reduced.

The last issue is the fact that Prospect Park is next to the major highway exits of US 94 and Minnesota 280 which has the likelihood of bringing many autos to the proposed LRT Stations at Westgate and 29th Ave SE for Park and Ride type train riders going to the U of M or flown town Minneapolis. A large number of these cars would be parked on the residential streets of Prospect Park.

The residents of the Prospect Park Historic District will expect a thorough review of the above issues during the Section 106 Study.







We are providing your office with this information pursuant to our FHWA-delegated responsibilities for compliance with Section 106 of the National Historic Preservation Act, as amended (36 CFR 800).

Enclosed you will find historic photographs, Sanborn maps and a current utilities and topography map of the area of potential effect (general construction limits) for the Capitol station. There are no known precontact sites in this parcel and the Mn/Model survey implementation model depicts the APE as unknown site potential. It does not appear that the part of the site west of former Peter Street and north of Wabasha was ever occupied by buildings, as least not after the Sanborns of the 1880s. However, given the distance from a source of water and the level of disturbances by utilities and road work in the area, it is our assessment that there is low potential for any unknown or undisturbed precontact archaeological sites in the APE. The potential for important and undisturbed historic archaeological resources is also low. Although there were buildings in the northwest corner of the project site (east of Peter and north of Wabasha) by the mid to late 1880s, the Sanborns indicate that there was no open space at the backs of these buildings that would provide an environment that would be likely to yield important information or a focus of study about the inhabitants of the buildings. The site was subsequently cleared in the early 1950s.

Therefore it is the conclusion of this office that the project area for the LRT station has a low potential for unknown and intact archaeological remains. Our office is not recommending a survey or monitoring. We would appreciate the opinion of the SHPO office on this assessment of potential. In response to your questions of the past few months regarding that part of the Capitol Grounds at the northwest corner of the campus with the Leif Erickson statue, I find no official documentation referencing the space as "park".

People working in the Capitol Area may habitually make reference to either Cass Gilbert Park or Leif Erickson Park; however, the Capitol Area Architectural and Planning Board (CAAPB), which is the party responsible for zoning within the sixty-block Capitol Area, has no official document (be it a deed, a zoning classification, zoning map, or a plat map) that makes official or anything more than incidental reference to park or open space, but rather treats it as an extension of the Capitol Grounds. In checking with the Department of Administration, who serves as landlord, they, too, have no documentation that makes note of the space as an official park.

In fact, the diagonal path running through the space was originally part of Wabasha Street, which had a street car track running its full length from downtown Saint Paul to the intersection with University Avenue at the Rice Street intersection.

### Correspondence Background

This letter is a follow up to an April 16, 2001 correspondence that was sent to Genevieve Bolling (URS/BRW, Inc.) in response to a Natural Heritage database request for the area in the vicinity of the proposed Central Corridor light rail alignment (see attached). In this letter, 11 records for occurrences of rare species or natural communities were identified in the area searched. The letter stated that "[the DNR] do[es] not believe [the project] will affect any known occurrences of rare features."

Since that communication, a significant amount of time has passed, and minor changes have been made to the proposed Central Corridor light rail alignment.

On behalf of the Central Corridor Development Authority, HDR Engineering, Inc. (HDR) is requesting an updated review of the potential effects that the Central Corridor alignment may have on rare species and natural communities. Please review and provide recommendations regarding rare species or natural communities for the area within one mile of the proposed alignment. A copy of the review will be included in the upcoming Central Corridor Supplemental Draft Environmental Impact Statement and the Final EIS.

### Project Background

The proposed Light Rail Transit runs about 11 miles between downtown Minneapolis and downtown St. Paul, and crosses the Mississippi River at an existing crossing over Washington Avenue Southeast. The majority of the alignment follows the existing University Avenue corridor. The specific alignment of the proposed route is indicated on the enclosed project map. The following sections are located within one mile of the alignment:

### **NHIS Findings**

A query of the 2007 Natural Heritage GIS database records by HDR (NHIS license LA381) within a 1 mile buffer of the proposed alignment indicates that there are 12 documented occurrences of state listed rare species or natural communities in the area searched (see enclosed map). These occurrences represent seven different zoological and botanical species, including: one bird, one fungus, three mollusks, one reptile, and one spider (Table 1).

Since the proposed light rail alignment follows existing urban infrastructure (primarily University Avenue) and crosses the Mississippi River at the existing Washington Avenue Bridge, no impacts are expected to the aforementioned species of bird, fungus, mollusk, reptile, and spider.

Additionally, the April 16, 2001 DNR correspondence identified records of Eastern Pipistrelle (*Pipistrellus subflavus*) and bat concentrations within the Central Corridor project study area. However, a similar query of the 2007 NHIS database does not reflect these findings. Could you please confirm the presence or absence of bat species within one mile of the proposed project alignment?

The Minnesota Natural Heritage database has been reviewed to determine if any rare plant or animal species or other significant natural features are known to occur within the sections containing the project, plus all sections within ½ mile of the project. Based on this review, there are 11 known occurrences of rare species or natural communities in the area searched (for details, see enclosed database printout and explanation of selected fields). However, based on the nature and location of the proposed project I do not believe it will affect any known occurrences of rare features.

The Natural Heritage database is maintained by the Natural Heritage and Nongame Research Program, a unit within the Division of Ecological Services, Department of Natural Resources. It is continually updated as new information becomes available, and is the most complete source of data on Minnesota's rare or otherwise significant species, natural communities, and other natural features. Its purpose is to foster better understanding and protection of these features.

Because our information is not based on a comprehensive inventory, there may be rare or otherwise significant natural features in the state that are not represented in the database. A county-bycounty survey of rare natural features is now underway, and has been completed for Hennepin and Ramsey Counties. Our information about natural communities is, therefore, quite thorough for that county. However, because survey work for rare plants and animals is less exhaustive, and because there has not been an on-site survey of all areas of the county, ecologically significant features for which we have no records may exist on the project area.

The enclosed results of the database search are provided in two formats: index and full record. To control the release of locational information which might result in the damage or destruction of a rare element, both printout formats are copyrighted.

This letter is a follow up to a June 13, 2001 correspondence that was sent to Genevieve Bolling (URS/BRW, Inc) regarding the alignment of the proposed Central Corridor Light Rail Transit Project. In a signed response dated August 24, 2001, you stated that "this project is not likely to adversely affect any federally listed species or their critical habitat." You also noted that, in the event that "the project is modified or new information [regarding species] becomes available," consultation with your office should be reinitiated (see attached). Since that correspondence, a significant amount of time has passed, and minor changes have been made to the proposed Central Corridor alignment.

On behalf of the Metropolitan Council, HDR Engineering, Inc. (HDR) is requesting an updated review of federal records for potential Threatened or Endangered species for the Central Corridor Light Rail Transit Project in accordance with Section 7 of the Endangered Species Act of 1973, as amended. A copy of the review will be included in the upcoming Central Corridor Supplemental Draft Environmental Impact Statement and the Final EIS.

The proposed Central Corridor Light Rail Transit Project runs about 11 miles between downtown Minneapolis and downtown St. Paul, and crosses the Mississippi River at an existing crossing over Washington Avenue Southeast. The majority of the alignment follows the existing University Avenue corridor. The specific alignment of the proposed route is indicated on the enclosed project map. Sections adjacent to the alignment are indicated in the following table:



Alternatives for this project include two light rail transit options and one busway option. The majority of project site is along the existing University Avenue from its junction with 29<sup>th</sup> Avenue Southeast in Minneapolis to its junction with Rice Street in St. Paul. Nine potential station locations have been identified along this portion of the corridor. An additional 14 station sites are proposed west of 29<sup>th</sup> Avenue Southeast in downtown Minneapolis; and 7 are proposed east of Rice Street in downtown St. Paul among the alternate alignments. There are two proposed Mississippi River crossings in downtown Minneapolis – the existing Washington Avenue Southeast and the existing 10<sup>th</sup> Avenue Southeast. There is one proposed crossing in downtown St. Paul – the existing Robert Street North. The adjacent land use along the corridor is mostly developed with commercial properties.

Enclosed is a map of the project area with a list of the sections of which the corridor passes through. Please review the federal records to determine if any Threatened or Endangered species are located in proximity to the project corridor. ### **Executive Summary**

The purpose of this Feasibility Study is to pursue the three stated goals for the Central Corridor Light Rail Transit (CCLRT) project, which are:

Goal 1: Economic Opportunity and Investment – The Central Corridor should support investments in infrastructure, business, and community that sustain the heart of the region. It should promote a reliable transit system that allows an efficient, effective land use development pattern in major activity centers which minimizes parking demand, facilitates the highest and best use of adjacent properties, and gives employers confidence that employees can travel to and from work.

Communities and Environment - The Central Corridor should facilitate the preservation and enhancement of neighborhoods within the corridor; acknowledge the individual character and aspirations of each place served and of the region as a whole; and support regional goals for cleaner air and water, more efficient energy use, and a safer and healthier environment.

Goal 3: Transportation and Mobility - The Central Corridor should create transportation improvements that add people carrying capacity, minimize operating costs, improve operating efficiency, provide high quality modal alternatives, and reinforce the region's transportation system. It should expand opportunities for all users to move freely to, through, and within the Central Corridor as well as enhance the existing transportation infrastructure to serve the high number of transit dependent persons in the corridor.

The University of Minnesota (U of M) has undertaken this study to investigate the feasibility and potential benefits of an alternate "Northern" Alignment with respect to these stated goals. The Northern Alignment (depicted in red in Figure E-1) represents an alternative to the current Washington Avenue At-Grade Alignment (depicted in blue in Figure E-1) between I-35W and the U of M Transitway.

The following four criteria were used to evaluate the feasibility of the Northern Alignment.

Engineering, Safety, and Accessibility: SRF Consulting Group, Inc. 1. evaluated geometric design, right-of-way, utility relocations, structures, constructability and compatibility with existing and future roadways and trails. This analysis revealed that the Northern Alignment is technically feasible and meets FTA design standards. The proposed Northern Alignment requires minimal right-of-way mitigation, minimal utility relocations, and does not preclude the integration of future roadways and trails. More specifically, a future new connection to northbound I-35W via 4th Street/Washington Avenue as well as development of Granary Road and various trail connections are accommodated in the Northern Alignment.

Furthermore, the Northern Alignment utilizes the existing pedestrian Bridge 9 alignment to traverse the Mississippi River, which would not impact vehicular traffic circulation in the West or East Bank neighborhoods.

With the majority of the Northern Alignment below grade, the relatively small number of potential LRT conflict points with pedestrians, autos, buses, and emergency vehicles maximizes the safety of the alternative.

Appropriate accommodations have been designed to ensure a high level of accessibility for pedestrians, bicyclists, and people with disabilities at the three Northern Alignment CCLRT stations. Accessibility features such as elevators, switchback ramps, stairs, and low-floor vehicles have been designed to meet or exceed Americans with Disability Act (ADA) requirements.

2. **CCLRT and Roadway Traffic Network Operations**: Operating the CCLRT on the Northern Alignment has been determined to be feasible based on station location and design, track geometrics, and rail crossings. The overall estimated travel time on the Northern Alignment is less than for the Washington Avenue Alignment<sup>2</sup>.

With a considerable portion of the Northern Alignment below grade, there would be no significant impacts to the roadway network in and around the vicinity of the U of M. Thus, no failing conditions at intersections, particularly in the East Bank and Stadium Village areas, would result from the Northern Alignment. Impacts to mission critical U of M services as well as traffic flow and circulation in and around the U of M campus are minimal with the Northern Alignment.

Travel times estimates for the Northern Alignment are preliminary. Additional minor refinements to the travel times estimates would likely reduce the travel time for the Northern Alignment.

Since the Central Corridor Management Committee meeting of April 30, 2008, continued feasibility design development of the Northern Alignment has resulted in further enhancements which are described in Chapter 8 of this report.

3. **Environmental and Land Use Impacts**: Based on SRF Consulting Group, Inc.'s environmental analysis, there are anticipated impacts to cultural resources, park areas, contaminated sites, and HUD subsidized affordable housing units that will need to be considered. None of these impacts are anticipated to be fatal flaws, but may require mitigation. In addition, the aesthetics impacts to the historic U of M Mall are minimized.

The Dinkytown neighborhood, which has mostly commercial land uses mixed with some residential and University of Minnesota-related land uses, has higher density development that is compatible with the CCLRT line. The number of privately-owned parcels within walking distance coupled with the reduced demand for surface parking due to their proximity to the Dinkytown station increases redevelopment opportunities on underutilized parcels in the area.

4. **Cost Effectiveness:** The fully-loaded capital cost for the Northern Alignment ranges from \$154.075 million to \$159.675 million<sup>3</sup>. Compared to the Washington Avenue Alignment, the Northern Alignment's fully-loaded capital cost is \$14.3 to \$19.9 million less. Conformity and concurrence on the Cost Effective Index (CEI) for the Northern Alignment was not reached between the U of M and the Central Corridor Project Office (CCPO) prior to publication of this feasibility report. A supplemental technical memorandum detailing the Northern Alignment's CEI and its assumptions will be issued once conformance and concurrence between the U of M and the CCPO is reached.

Based upon this analysis, the Northern Alignment is determined to be feasible with respect to engineering, safety, accessibility, light rail operations, roadway network operation, environmental impacts and compatibility with land uses in proximity to the corridor. While the fully-loaded capital cost for the Northern Alignment is \$14.3 to \$19.9 million less than the Washington Avenue Alignment, its CEI has not been finalized. Thus, a feasibility determination for the cost effectiveness of the Northern Alignment can not be made at this time. Overall, the Northern Alignment supports the CCLRT project goals for: (1) Economic Opportunity and Investment, (2) Communities and Environment, and (3) Transportation and Mobility.

The upper bound estimate of \$159.675 million was presented to the Central Corridor Management Committee on April 30, 2008, and does not include enhancements (see Chapter 8) to the Northern Alignment that resulted in the \$154.075 million estimate, a net savings in fully loaded cost of \$5.6 million.
