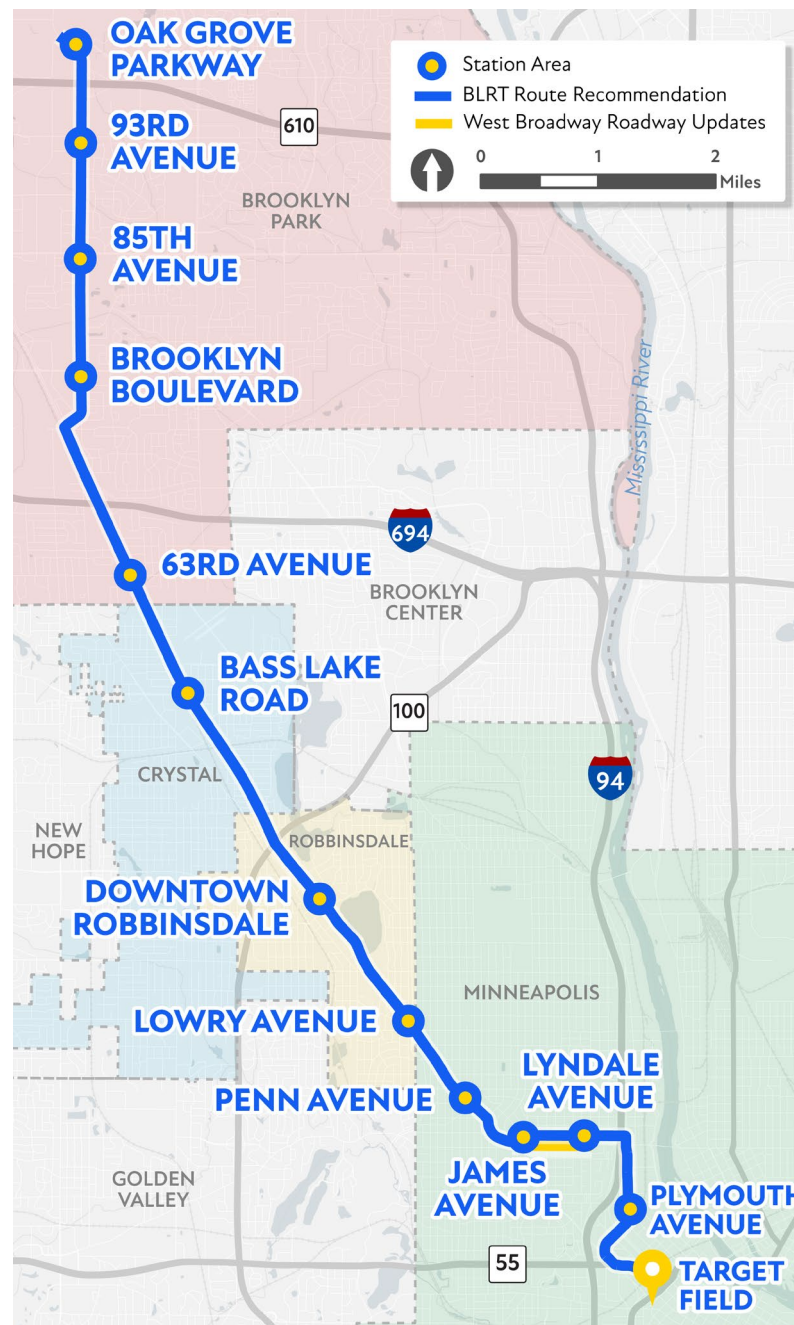
Project Update



Blue Line

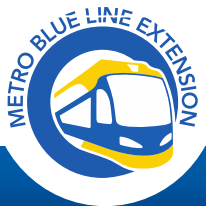
EXTENSION

- 13.4 miles & 12 new stations
- Connecting Minneapolis, Robbinsdale, Crystal, Brooklyn Park and surrounding communities to fast, frequent, all-day service across the METRO system
- Single seat ride to existing Blue Line stops downtown, MSP Airport and Mall of America
- Focus on building community prosperity through anti-displacement strategies before, during, and after construction



Next steps

- Updated post-COVID ridership: early 2024
- Supplemental Draft Environmental Impact Statement: Spring 2024
- Municipal Consent process to confirm final route: Summer 2024
- Updated cost estimate: 2024
- Final Design: 2024-2025
- Construction starts: 2026-2027
- Anticipated opening: 2030

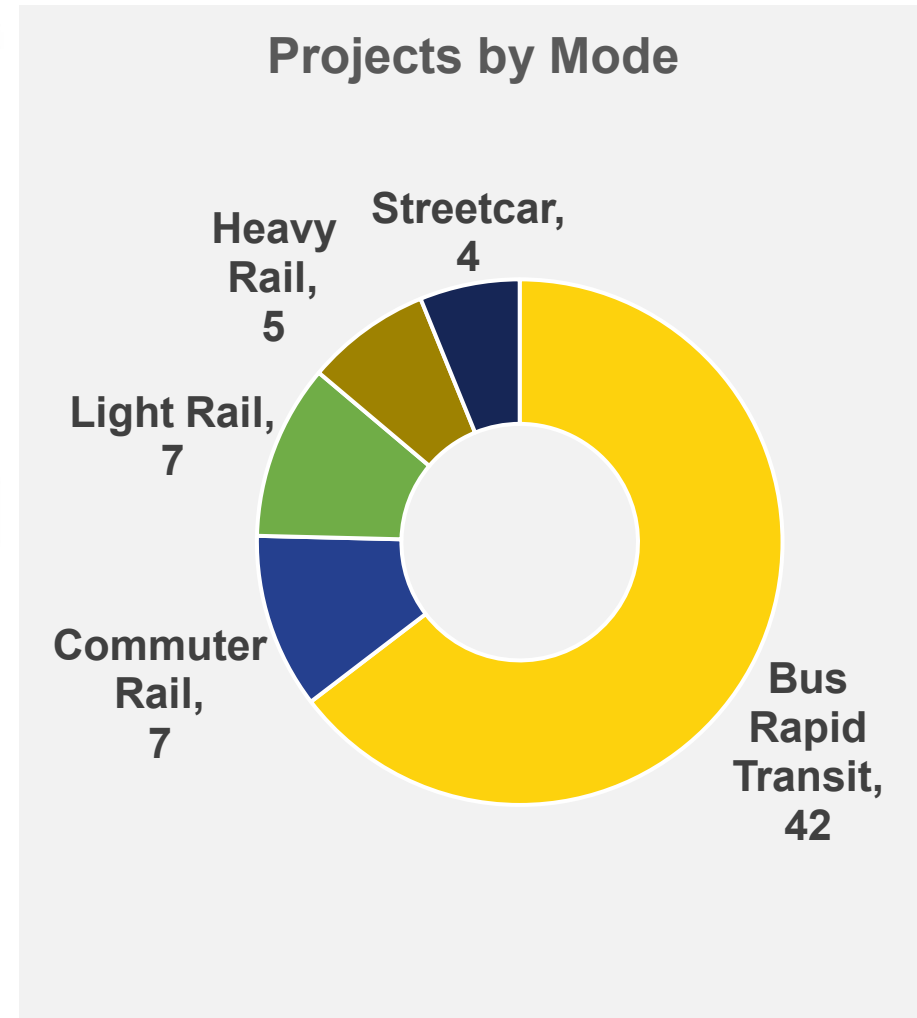
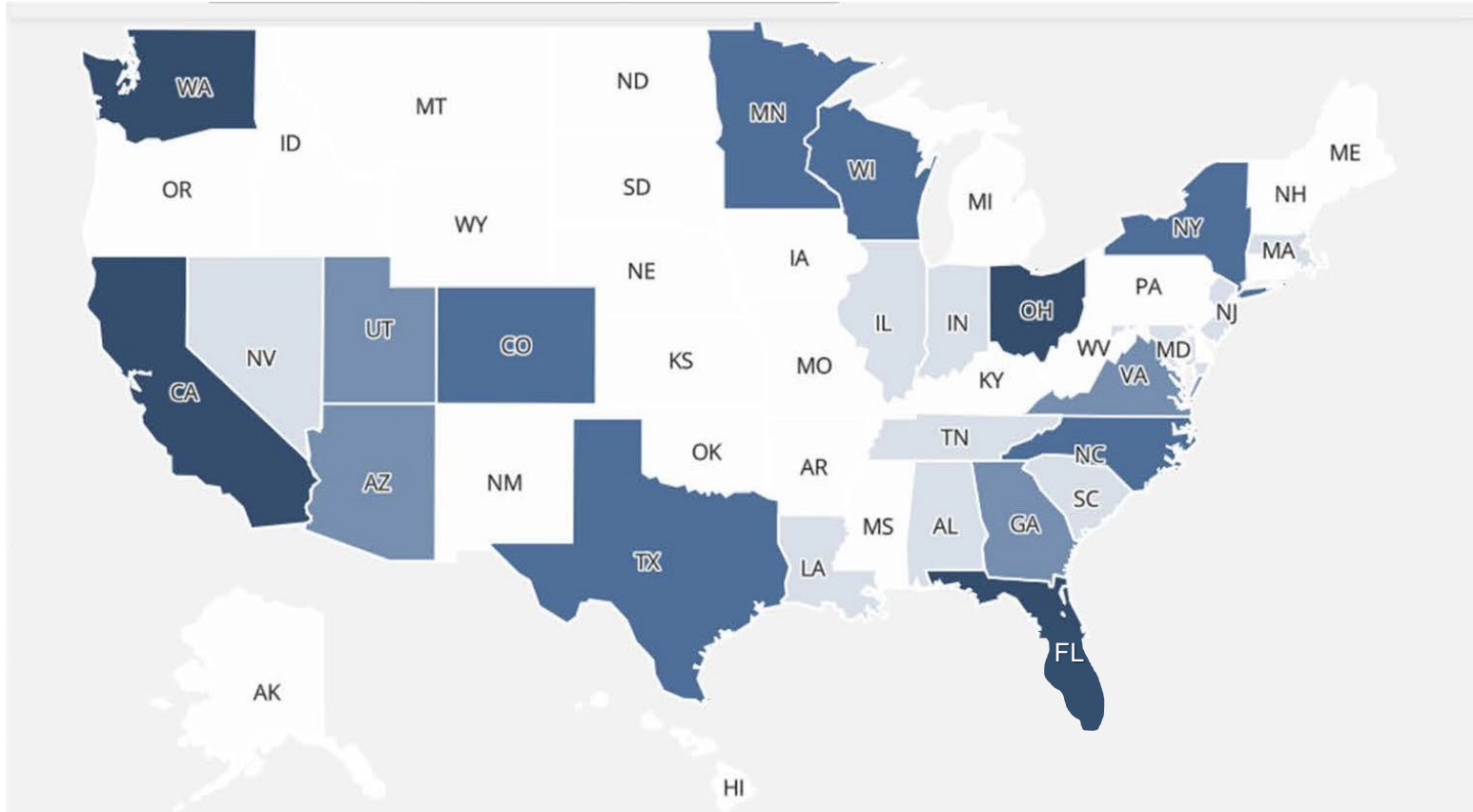


FTA CIG Program

- What is CIG and the New Starts program?
 - The **Capital Investment Grant (CIG)** program is the Federal governments largest discretionary grant program to fund transit capital investments for:
 - Light, Heavy, and Commuter Rail
 - Bus Rapid Transit
 - Streetcar
 - Managed by the Federal Transit Authority (FTA)
 - Includes **New Starts** (>\$400M), **Small Starts** (<\$400M), and **Core Capacity** projects



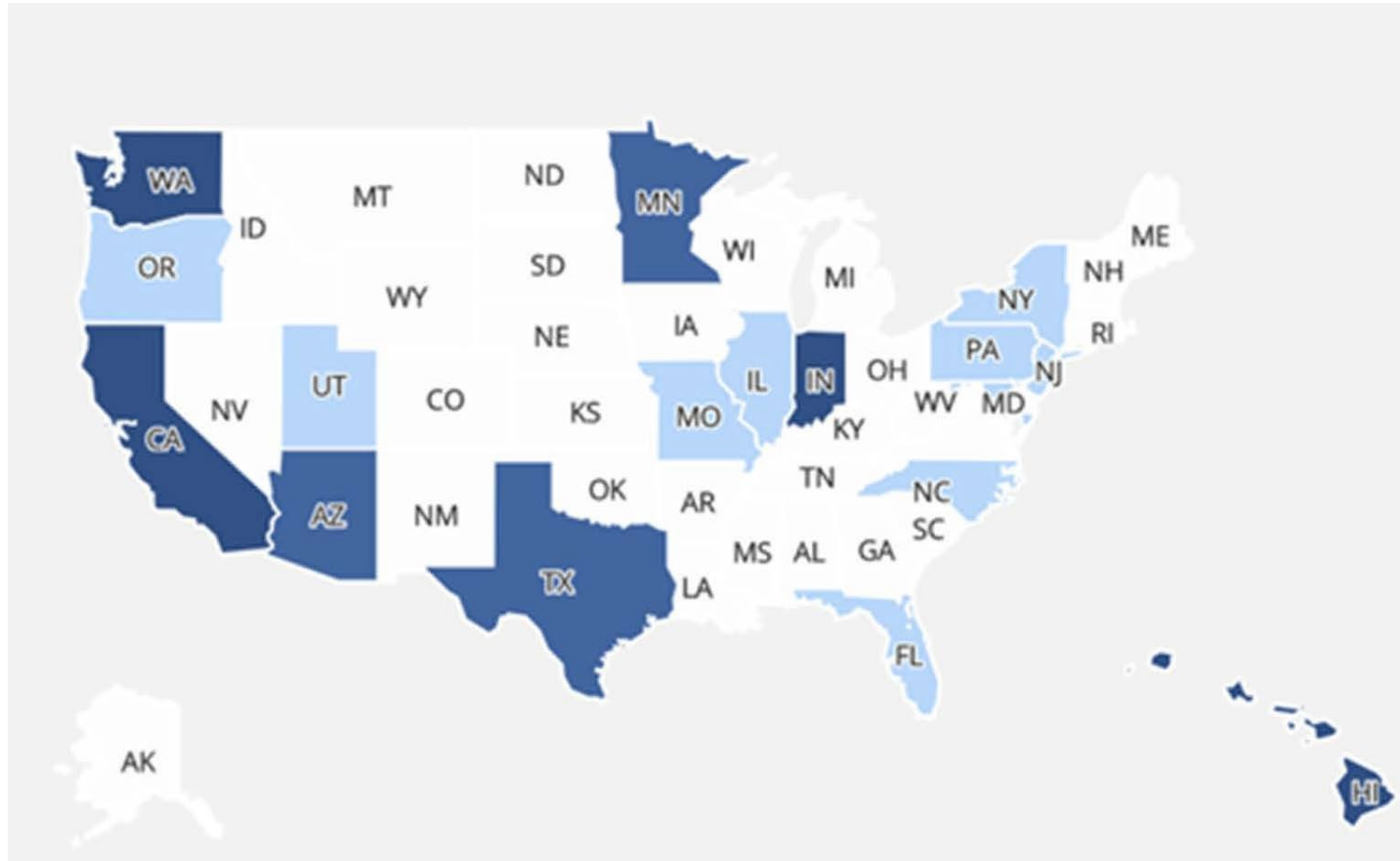
65 Projects in CIG Program (as of Sept 2023)



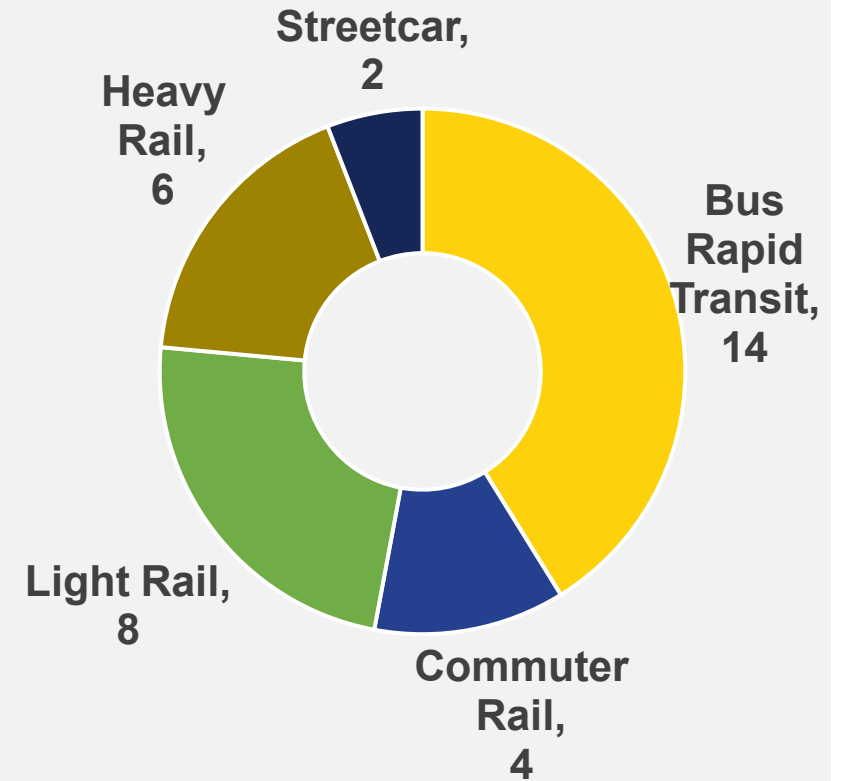

34 CIG Projects Under Construction Grants (as of Sept 2023)



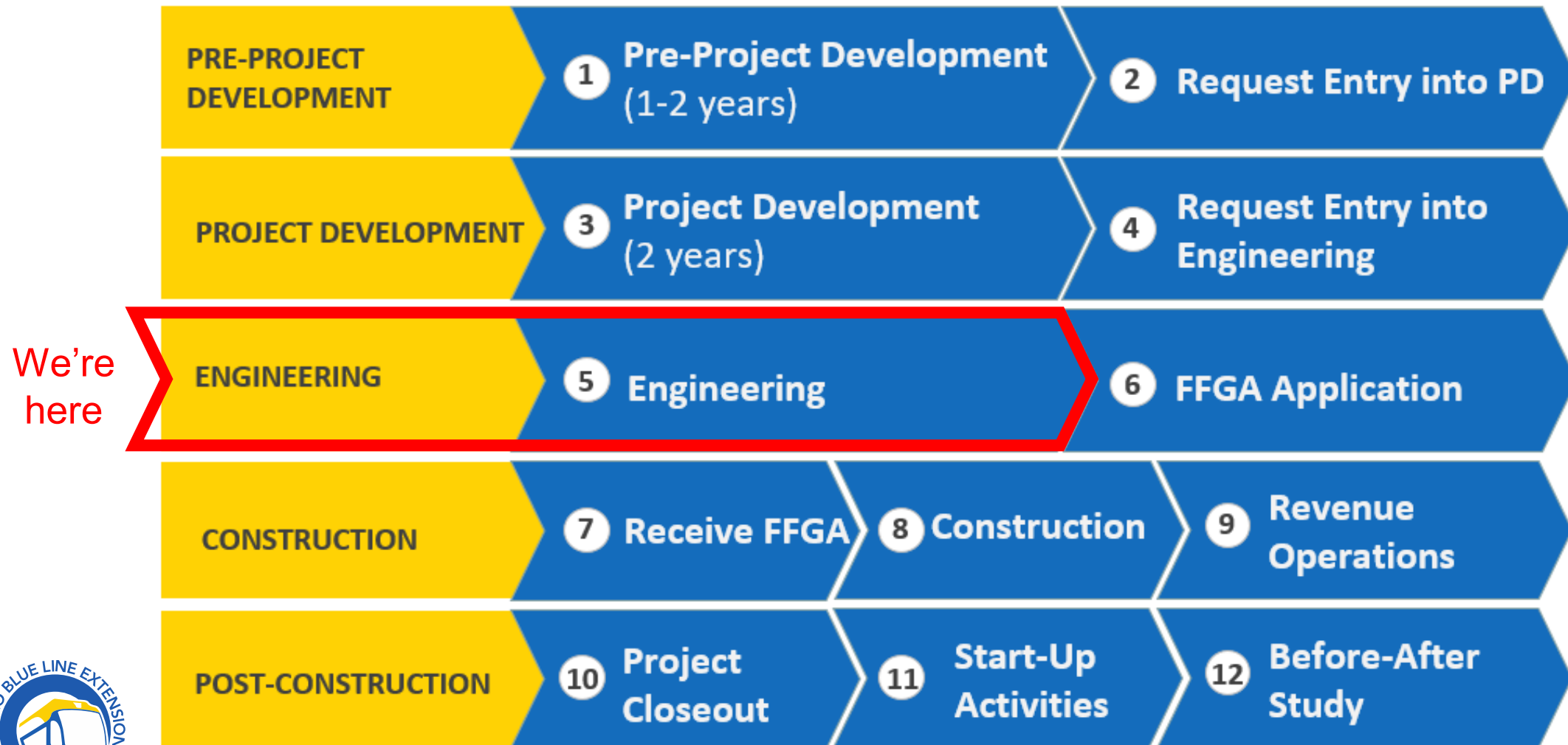
Projects by Mode

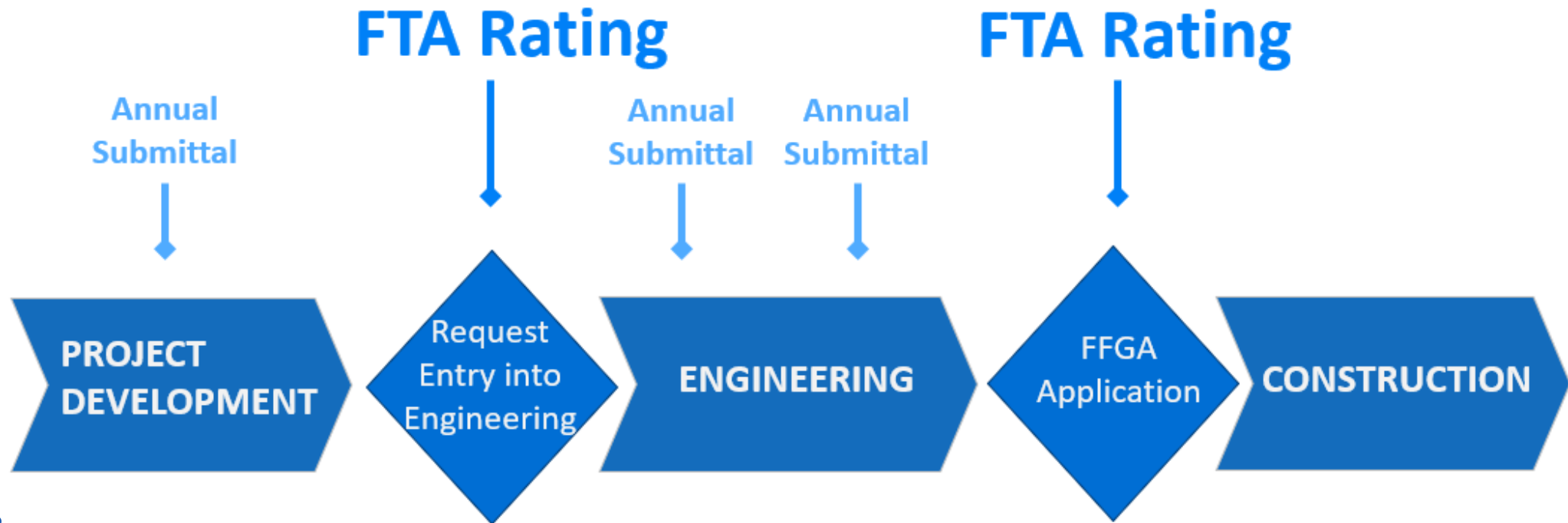


FTA's New Starts Process

- Project ratings at key program milestones; or annually in FTA New Starts funding submittals



FTA New Starts Rating

- FTA's New Starts ratings inform their program funding decisions
- Rating criteria are divided between two categories

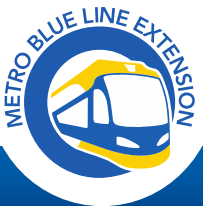

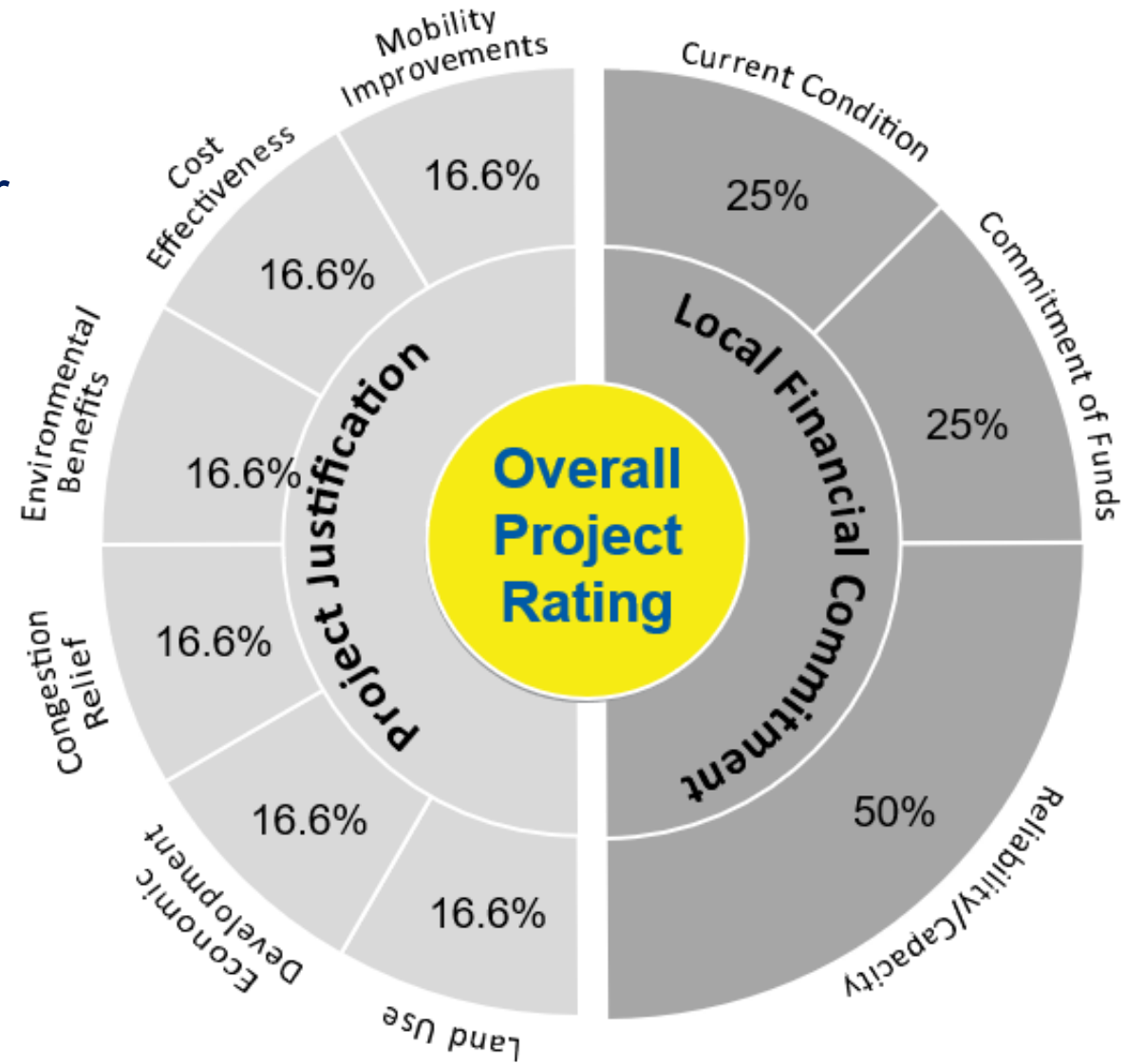
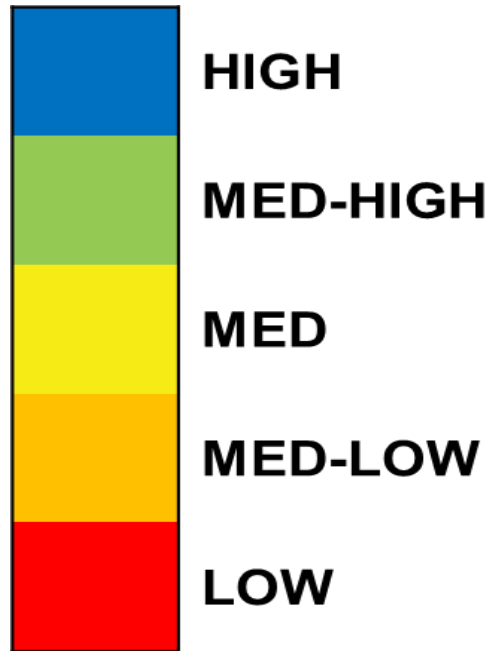

FTA Rating Criteria

- Project must achieve a Medium or higher rating (criteria rated on a 5-point scale)



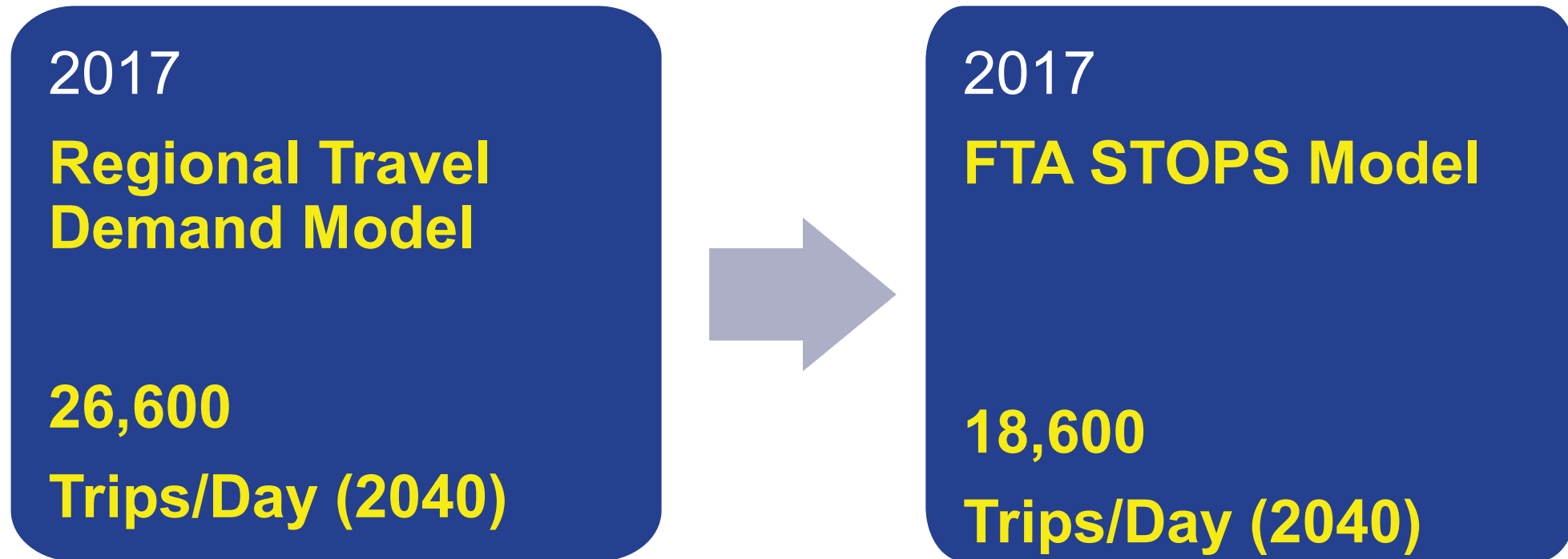
FTA “STOPS” Ridership Forecasting Model

- STOPS is FTA’s current model for ridership forecasting (more conservative)
 - Twin Cities’ projects previously used our own Regional Travel Demand Model (TDM)
 - STOPS is intended to level the playing field and help FTA make decisions on funding
- STOPS is calibrated nationally to a variety of transit corridor investment projects
- STOPS relies on local data including transit onboard surveys, official population and employment forecasts, transit schedules, and walk infrastructure



STOPS Example: Blue Line Extension 2017 Ridership

- Previous alignment ridership converted to FTA's STOPS Model results in a 30% lower ridership projection

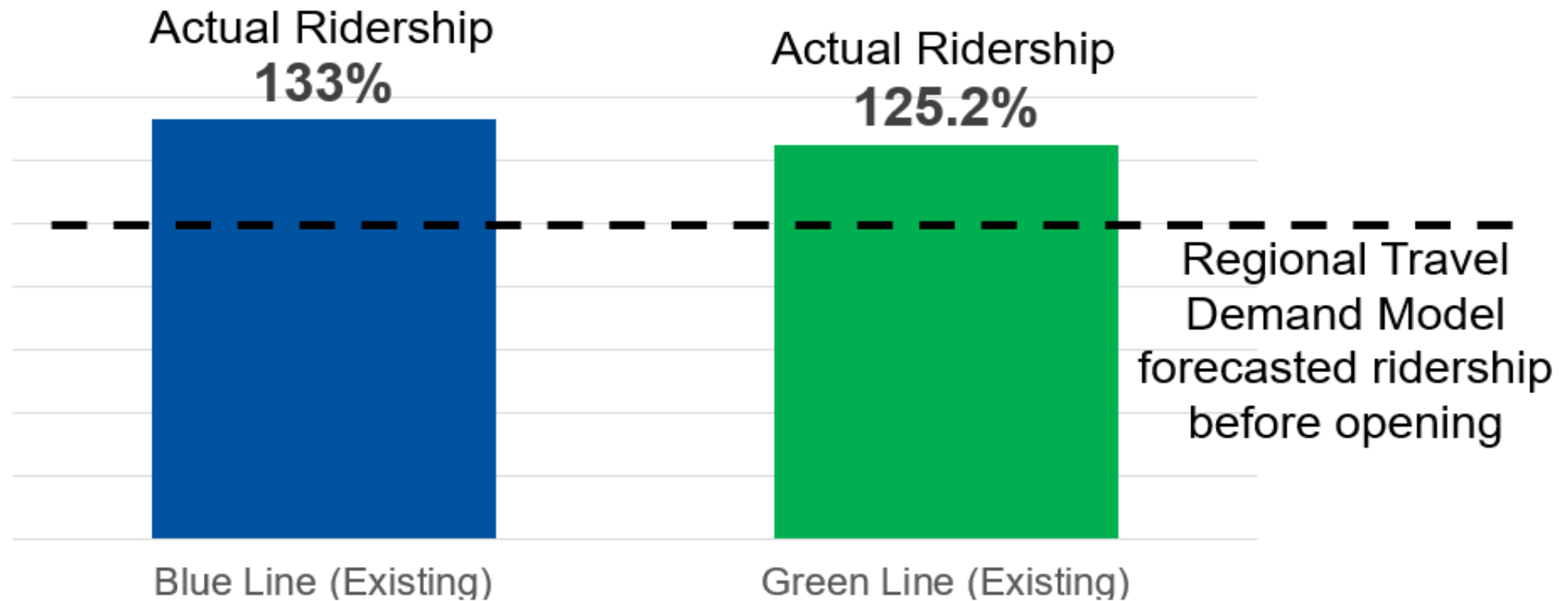


Note: no other changes except for ridership model

Corridor Partner Collaboration

- Working to finalize collective legislative strategy to advance ADWG recommended outcomes toward implementation:
 - Funding, resources
 - Public, private, and philanthropic funding for anti-displacement implementation
 - Land use
 - Protections, land trusts, land disposition, zoning
 - Commercial and business development
 - Business protections and support; technical and financial assistance, Transit Oriented Development



Corridor Partner Collaboration Continued

- Culture and community vibrance
 - Placekeeping/placemaking; income support; technical assistance to CBOs/non-profits
- Housing
 - NOAH; affordable housing; homeownership; financial assistance; inclusionary zoning
- Workforce development
 - Increase participation of people of color, DBEs, in project work
- Other independent legislative items per agency



Framework Development

Developing framework to support action planning and implementation

- Clearly identify goals, objectives, action steps to achieve recommended outcomes
- Initial topic areas to build framework around:
 - Relocation and Right of Way
 - Community ownership
 - Workforce
- Existing agency programs, policies, resources to serve as baseline

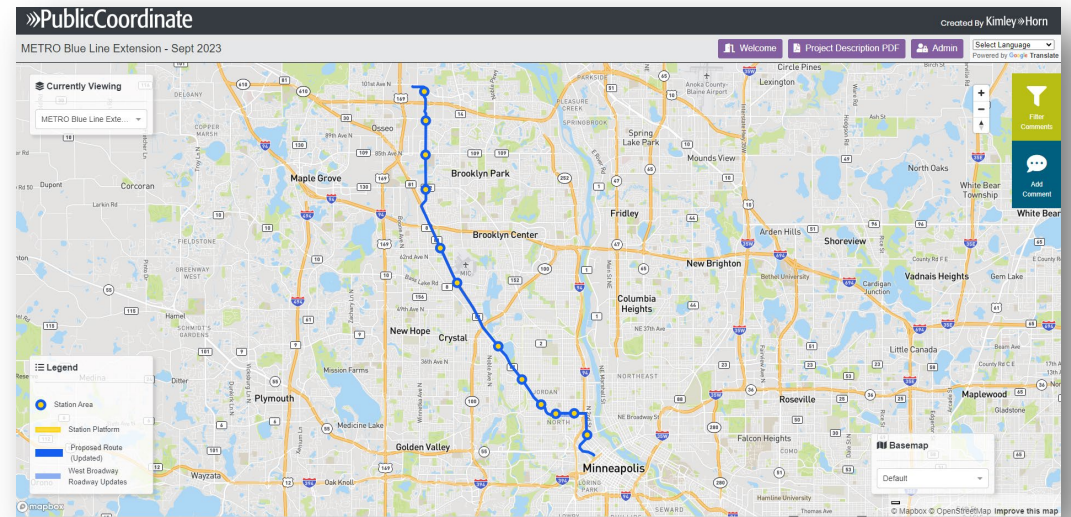
