





- Anticipated FTA Rating doesn't change
 - Base Project:
 - MEDIUM or Better
 - Added Station at WB/Washington:
 - MEDIUM or Better



Conclusion

- Adding a station:
 - Improves access to the developing area between I-94 and the Mississippi River
 - Enhances connections with bus routes serving North and Northeast Minneapolis
 - Strongly supported by City of Minneapolis
- Project Impact:
 - Project retains projected Medium or higher rating needed for Federal funding
 - Station design has advanced to point it will not impact schedule
 - January 2025 cost estimate will reflect station costs (if approved)



Proposed Action to Adopt Resolution

Resolution

BE IT RESOLVED, that the Project Decisions Board approves the inclusion in the project scope of construction of a station at Washington and West Broadway Avenues in Minneapolis; and

BE IT FURTHER RESOLVED, that the Project Decisions Board directs that, when final design plans are prepared for the project, such plans should include this station; and

BE IT FURTHER RESOLVED, that the approvals provided in this Resolution are subject to and conditioned on the receipt of a Record of Decision from the Federal Transit Administration determining that the requirements of the National Environmental Policy Act are satisfied for the project.
