

1A-a: Side running light rail, West 7th, 5 Lane Section, Side running light rail, Flyover to Plymouth






1B: Olson Memorial to East Lyndale, Flyover to Plymouth

2A-a: West side running light rail along Lyndale Avenue, Plymouth Station north of Plymouth







2A-b: West side running light rail along Lyndale Avenue, Plymouth Station south of Plymouth Avenue on structure perpendicular to Plymouth Avenue







3A-a: Center running light rail along West Broadway Avenue, following existing centerline of roadway. Note: This is a baseline concept that was used to develop other alternatives.





3A-b: Center running light rail along West Broadway Avenue, alignment shifted to the north










SECTION 3: WEST BROADWAY AVENUE - LYNDALE AVENUE TO IRVING AVENUE








SECTION 3: WEST BROADWAY AVENUE - LYNDALE AVENUE TO IRVING AVENUE







4A-a: Center running along West Broadway, existing turning lanes to remain







