


METRO Green Line Extension

- Extends the Green Line with 14.5 miles of new LRT
- 16 new stations
- One seat ride from Eden Prairie to Downtown St.
 Paul
- Direct service to Downtown Minneapolis, U of M, stadiums
- Connections to rail and bus routes
- Downtown Minneapolis to Eden Prairie: ~35 minutes



METRO Green Line Extension Scope

- 16 new stations
- 44 structures
 - 29 new bridges: LRT, pedestrian, roadway, freight
 - 7 existing bridges with modifications
 - 6 pedestrian tunnels
 - 2 cut and cover tunnels:
 - TH 62 582 ft., Kenilworth 2,236 ft.
- 15 at-grade LRT crossings
 - Includes 5 shared crossings w/ freight rail
- 127 retaining walls
- Track: ~182,000 TF
- 7.8 mi shared LRT and freight rail corridor

West 21st Street Construction – Key Questions


- What are the planned construction activities for the West 21st Street area?
- What is the timing and duration of the work?
- What will be the traffic impacts and access plan for East Cedar Lake Beach and Upton Avenue?



West 21st Street 2023 Construction

- Construction activities that impact West 21st Street in 2023 are expected to take about six months
- Work requires a closure of West 21st Street between Upton Avenue and Thomas Avenue.
- Local access to be maintained to Upton Avenue and East Cedar Lake Beach
- Sequencing and duration based on staging needs for utilities
- Haul route remains active to Cedar Lake Channel and Kenilworth Tunnel sites
- Clearing of vegetation will take place on existing right of way for LRT construction
- Work hours: 7:00 AM 6:00 PM, Monday to Friday


Construction Phasing – Spring/Summer 2023



Construction Phasing – Spring/Summer 2023 (continued)

- Access road located north of roadway to accommodate majority of construction phasing
 - Width allows for single vehicle as well as pedestrian access
 - Line-of-sight for motorists at each end of access road
 - Signage to alert motorists to conditions
- Major Activities
 - Utility work: water, sewer, storm sewer, electrical duct bank
 - LRT track installation within roadway
 - Roadway reconstruction (concrete)
 - Sidewalk construction

Construction Phasing – Summer/Fall 2023



Construction Phasing – Summer/Fall 2023 (continued)

- Access road relocated to newly reconstructed south part of West 21st
 Street
 - Pedestrians may be able to use south sidewalk facility on West 21st Street
- Major Activities
 - LRT track installation outside of roadway
 - Roadway reconstruction (concrete)
 - Sidewalk reconstruction

Cedar Lake Trail Detour

- Closure between West 21st Street and the connection to the North Cedar Lake Trail
- Trail traffic to be routed from Lake of the Isles Parkway to Kenwood Parkway and north to access point near I-394.
- Access needs for haul route and construction site
- Pinch point at transition between trail and West 21st Street
- Detour change will be promoted on project website and in construction update
