


DBE Subcontractor	Projected On-Site
Gunnar Electric and PWS was onsite for the month of July. Gunnar was installing the ground loop, which is a ring that goes all the way around the building to protect it from lightning. It goes around the outside and ties into the steel inside the building at 27 different locations.	07/01/2025
M3Sixty (Supplies expected to be delivered for Flynn Midwest)	09/15/2025
AW Painting is projected to be on site in November.	11/05/2025
Steel was delivered on 08/26/2025. They will be finished with setting steel on 10/10/25. After setting the steel, they will finish masonry and start metal panels to get dried in and heated for winter.	08/26/2025

Substantial Completion will be 06/03/2026.

Gunnar Electric installed conduits into the poured walls and installed the ground loop which ties into the steel in 27 different locations around the building.








Current Workforce Participation


Workforce Participation Percentage*


