The Metropolitan Council proposes to adopt a 2020 operating budget for Environmental Services in the amount of \$311M that anticipates revenue from the Municipal Wastewater Charge in the amount of \$235.6 million. This is an increase of 3.6% from the 2019 charge of \$227.4 million.

MCES continues to use an allocation method to calculate each municipality's charges. The method uses 2018 calendar year flow to allocate the \$235.6 million of total metropolitan charges to customer communities.

Your municipality's percentage of the overall system flow during that period is the percentage of the Metropolitan Wastewater Charge that will be charged to your community in 2020. We have included the calculation on the attached table and will bill your municipality in equal monthly amounts in 2020. Please note that there were some very minor adjustments to each community's MWC estimate provided to you in May due to flow validation over the summer.
