On July 26, 2023, the Metropolitan Council adopted the 2024 Environmental Services Rates and Charges. This included the Municipal Wastewater Charge in the amount of \$281,587,000. This is an increase of 6.8% from the 2023 charge of \$263,703,000.

MCES continues to use an allocation method to calculate each municipality's charges. The method uses 2022 calendar year flow to allocate the \$281.6 million of total metropolitan charges to customer communities.

Your municipality's percentage of the overall system flow during that period is the percentage of the Metropolitan Wastewater Charge that will be charged to your community in 2024. We have included the calculation on the attached table and will bill your municipality in equal monthly amounts in 2024. There were no material changes to the estimated MWC allocations provided to you in May.
