## SAC yog Sewer Availability Charge.

The Metropolitan Council tsub tus nqi no ib zaug yog tias koj vaj tse los yog lag luam yuav los sib txuas rau cov ciav dej ntawm thaj chaw koj nyob. Yog tias koj lub lag luam loj tuaj lawm los yog koj yuav kho pauv lub lag luam ua ib lub lag luam tshiab, tej zaum The Metropolitan Council yuav tsub nqi rau koj them ntxiv vim tias yuav ua rau ciav dej ua hauj lwm heev.

The Council tsum nqi rau tsoom fww. Lawv mam muab rau lag luam los yog khaub qhua them. Tej zaum tsoom fww ntawm koj nyob yuav ntxiv ib tug nqi rau koj them thiab.

## Yog vim li cas kuv yuav tau them SAC?

Cov ciav dej thiab tsev lim dej kim heev. Peb qiv nyiaj txiag ntau los muab kho kom loj thiab kom txhua leej txhua tus tau siv txuas ntxiv mus. Peb siv SAC los pab them cov nuj nqi no.

## Lub Council txiav txim tus nqi rau koj them li cas?

SAC tsub ib lub unit.

Ib lub vaj tse = 1 SAC unit = \$2,485 (2025)



Peb yuav tsum tuaj soj ntxuam (yees xam) koj lub lag luam yuav sib dej ntau npaum cas. Nyob ntawm koj lub lag luam, tej zaum koj yuav tau them tshaj ib SAC unit. Piv ib lub lab a ham uas tsis muaj chaw haus dej caws, peb puas tag nrho square taw yuav raug ib SAC unit.



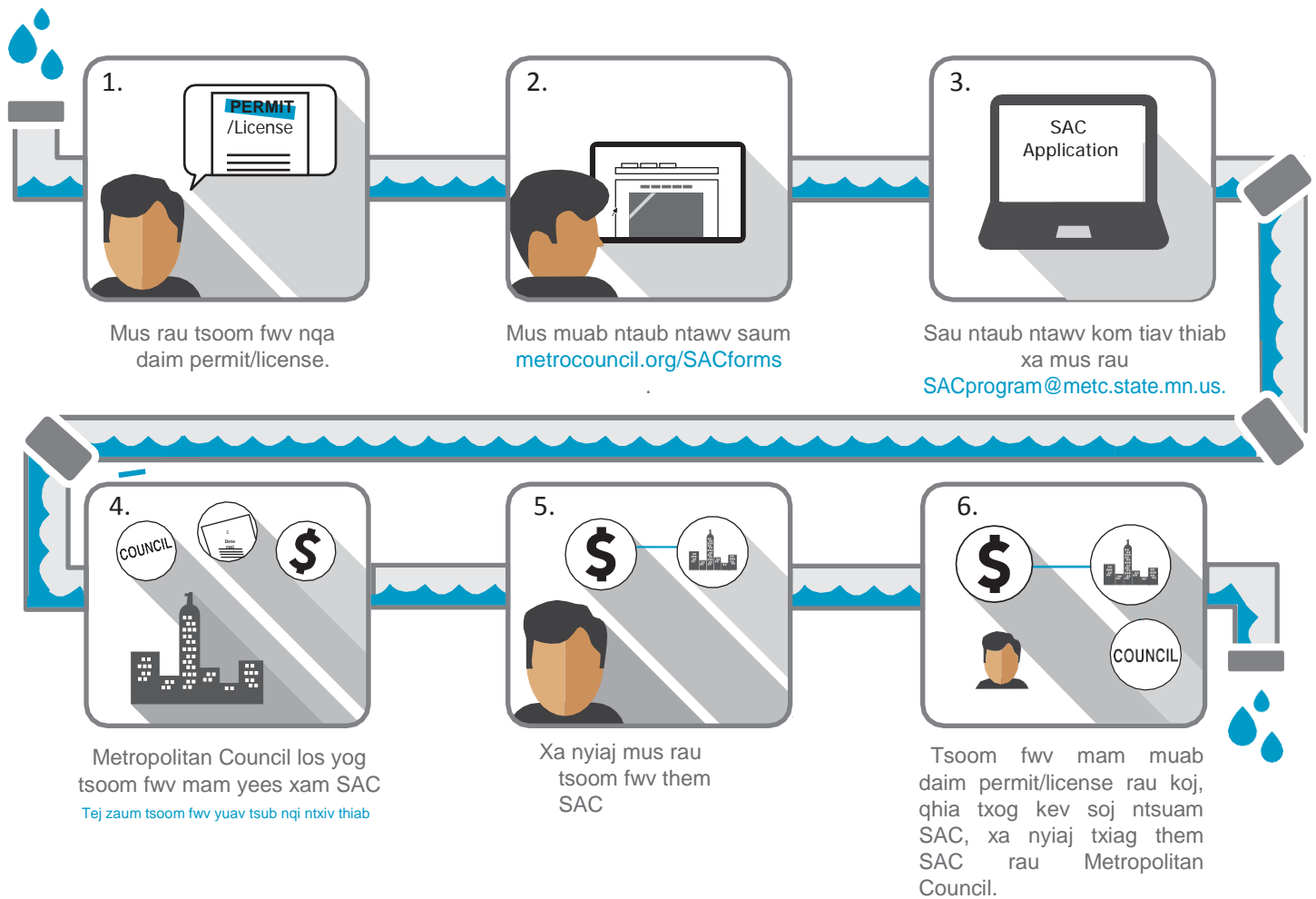
Peb yuav tuaj soj ntsuam koj siv dej ua dab tsi thiab siv ntau npaum cas hauv koj lub lag luam (ua zaub mov, ntxuav tais diav, so tsev, siv chav dej...). Peb mam txiav txim tus nqi rau koj them.

Tom qab peb txais tau koj cov ntaub ntawv, Metropolitan Council mam hu tuaj rau koj tham txog koj cov ntaub ntawv. Thaum peb txais tau tag nrho cov ntaub ntawv lawm, Metropolitan Council yuav siv ob mus rau peb lub li tiam mam txiav txim SAC. Koj yuav tsum them SAC rau tsoom fww, feem ntau tsoom fww yuav ntxiv SAC rau daim permit los yog business license.

## Kuv yuav them SAC li cas?

Yog koj tsis muaj nyiaj txaus los them SAC rau tsoom fww:

- Koj mus txais small business loan los pab koj them SAC thiab lwm yam nqi uas tsoom fww muab rau koj them. Mus nrog koj lub bank los yog tus neeg qiv nyiaj sib tham.
- Tsoom fww mam qha SAC kom koj tsuas them ib feem, yav tom ntej koj mam them ntxiv. Noog tsoom fww saib seb lawv puas txais koj mus nkag hauv SAC Deferral Program.
