

Southwest LRT Community Events, Meetings, and Presentations

This section provides an overview of public and agency coordination activities performed from October 2008 through March 2016.

Table 1 includes a summary of the public hearings conducted for the Project.

Table 2 includes a listing of the meetings of the Project's advisory committees that were formed during the Draft Environmental Impact Statement (EIS) process and have continued meeting through the development of the Supplemental Draft EIS and the Final EIS, as well as Metropolitan Council meetings related to the Project. The three committees are the Corridor Management Committee (CMC), Business Advisory Committee (BAC), and the Community Advisory Committee (CAC). Table 2 also contains meetings held by the Community Works Steering Committee, hosted by Hennepin County.

The Community Advisory Committee (CAC) is composed of residents appointed by neighborhood organizations or cities from along the Southwest Transitway corridor. The BAC represents a diversity of business establishments along the corridor, including small business entrepreneurs, chambers of commerce and business organizations, corporate headquarters, nonprofit organizations, developers, and land owners. The CMC is composed of representatives from the Council; HCRRA; the Cities of Minneapolis, St. Louis Park, Hopkins, Minnetonka, Eden Prairie, and Edina; Metro Transit; Minnesota Department of Transportation (MnDOT); Minnesota Department of Management and Budget; the CAC and BAC; and the Counties Transit Improvement Board. The Community Works Steering Committee includes members from the cities of Eden Prairie, Minnetonka, Hopkins, St. Louis Park, Minneapolis, Edina; Hennepin County Board of Commissioners; HCRRA: the Council: Minnehaha Creek Watershed District: Minneapolis Park & Recreation Board: SouthWest Transit Board; and Minnesota Urban Land Institute. The Metropolitan Council receives input from the Council's Transportation Committee, which focuses on regional transportation issues specifically concerning transportation policy and planning and transit operations. The Committee is composed of Council members and meets on the second and fourth Mondays of each month. The full Council meets on the second and fourth Wednesday's of each month on a broad range of topics impacting communities, parks, transportation, wastewater and water, housing, and planning. These meetings are public and agendas, presentations, and meeting minutes are posted on the Council's website (http://www.metrocouncil.org).

Tables 3, 4, 5 and 6 include community meetings and events attended by Project staff from the end of the Draft EIS comment period, December 31, 2012, through March 2016. The tables include dates, locations, a summary of participants, and topics discussed. Public meetings and open houses held by HCRRA prior to December 31, 2012are listed in Chapter 12 of the Draft EIS. Project staff continue to host and attend meetings and other events for the Project. Additionally, Project staff continue to attend and present information at community meetings throughout the Southwest LRT Project corridor. Attending such meetings allows groups with specific concerns or questions to interact with staff and to provide feedback in a more personal, less formal setting. Concerns expressed at these meetings are shared with the appropriate team members.

The Project also received input from the Council's Transportation Committee, composed of Council Members, which meets the second and fourth Mondays of each month.
