Executive Summary





Goals and Objectives

The Metropolitan Council contracted Information Systems Group, Inc. to administer a regional parks and trails site-intercept survey. The surveys were conducted during the summer of 2008 between Memorial Day and Labor Day to visitors at each of the 91 park and trail sites throughout the seven-county Twin Cities Metropolitan Area.

Goal

To provide statistically representative and useful data on park uses and preferences of visitors to the Twin Cities regional parks system.

Objectives

- Obtain baseline data for use in doing annual use estimates.
- Develop seasonal use multipliers (spring, summer, fall and winter) one for regional parks and one for regional trails.
- Determine average persons-per-vehicle factor (PPV) for each park for people arriving by vehicle to be used to estimate the total number of people.
- Obtain data on visitor place of residence for local and non-local use of regional park system for parks funding formulas (percentage of non-local visits for each of the 10 park implementing agencies).
- Obtain data on the ethnic/racial characteristics of park visitors.



Methodology

Overview

The survey methodology ensured that a 95% confidence interval of +/- 5% was achieved in each of the ten operating agencies. For the 2008 Regional Parks and Trails Survey, a total of 7,245 intercept surveys were conducted (4,191 in parks and 3,054 on trails).

To achieve the desired sample, the study design included the following requirements:

- a minimum of 30 respondents per park and trail unit ;
- a minimum of 385 intercepts per agency's park units and trail units.

The methodology for the 2008 Regional Parks and Trails Survey mirrored that of the previous studies conducted in 1998. Peer review of the original methodology and survey issues (questionnaire, sampling plan, statistically valid sample size, weekend/weekday site visits, random choice selection protocol for intercept) were conducted with University of Minnesota—School of Statistics, University of Minnesota—Forestry Resources, University of Minnesota—Tourism Center, and Department of Natural Resources—Office of Planning.

Questions were pared down to meet funding allocation data needs in 2008. Questions maintained included spring, summer, fall and winter multipliers; local/non-local visits and diversity of population use.

The sampling plan was amended to reflect closed parks and new units (June 2008).

Sampling Plan

Overview

The Twin Cities Regional Parks 1998 Summer Visitor Survey was much more extensive in scope than the goals set for the 2008 survey, however, the 1998 Survey was used as a major resource document for sampling. The sampling plan for the 2008 Regional Parks and Trails Survey included the following:

- On-site personal interviews were conducted between Memorial Day and Labor Day 2008. Each park and trail site was sampled at least four times on both weekday and weekend dates.
- Sample periods ranged in length from 2 to 6 hours and were conducted between 7am and 7pm. Sample periods rotated for each park/trail to ensure coverage over the course of a day and week.
- Park and trail respondents were randomly selected at pre-determined sites. Individuals 12 years of age and older were interviewed.
- Interviews were conducted to cover the activities available at each park.
- On the trails, interviews were conducted throughout the trail to assure coverage of the length of trail.

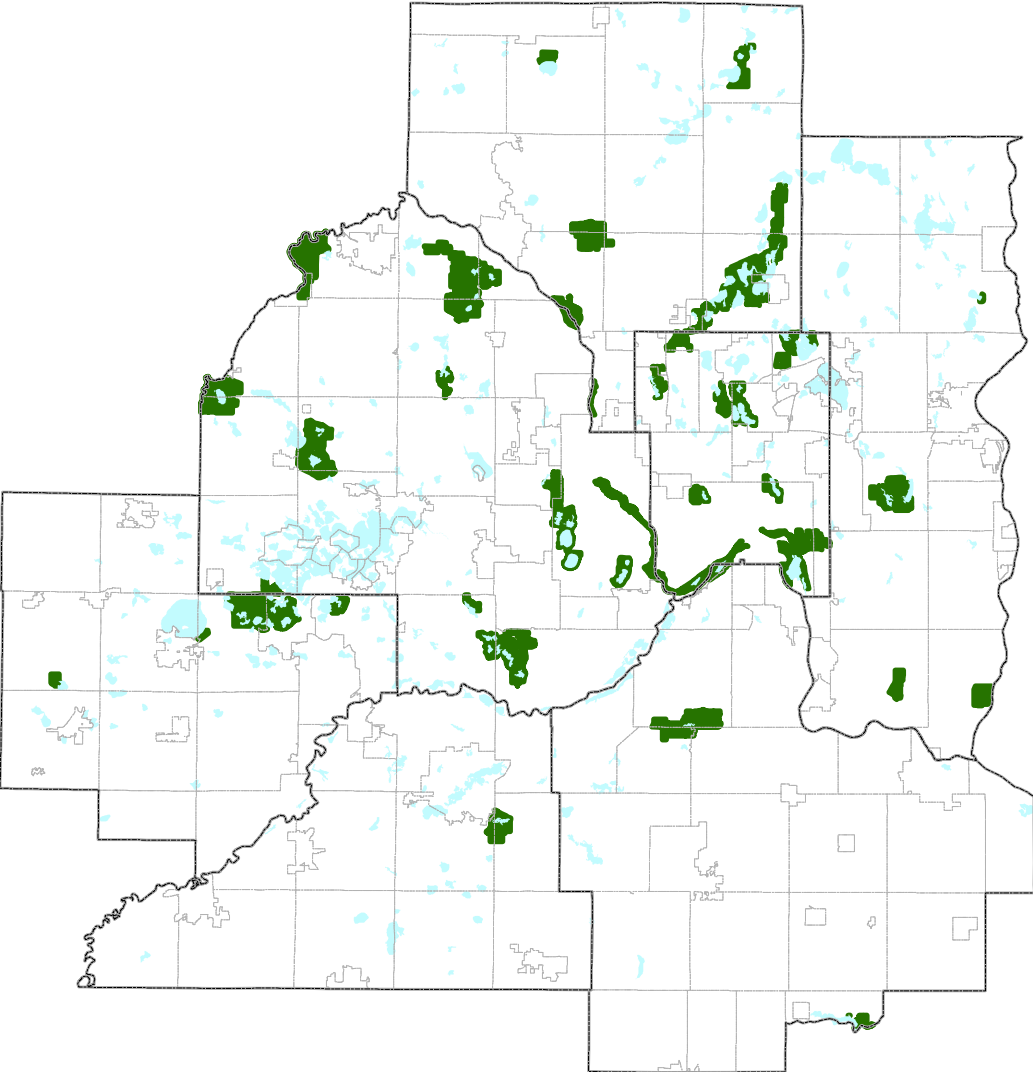

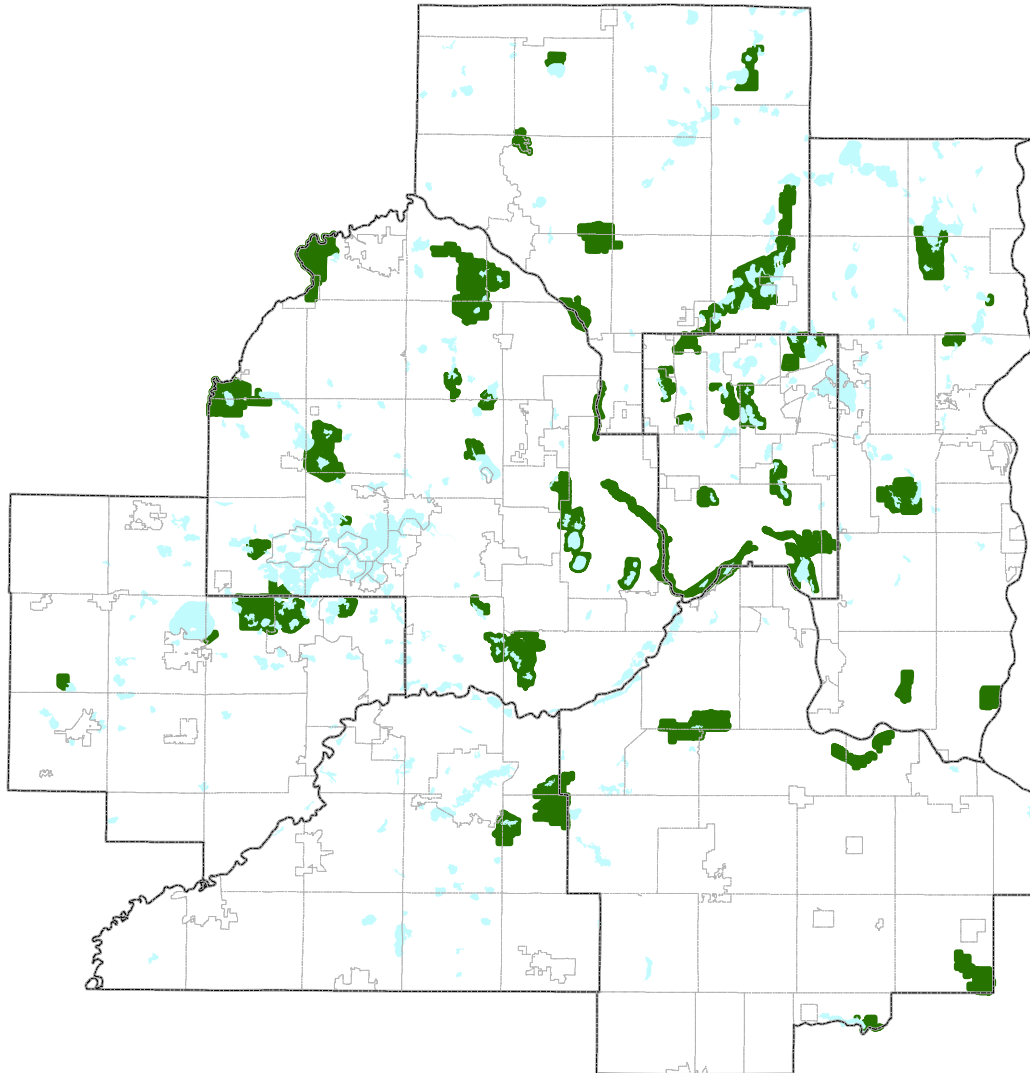

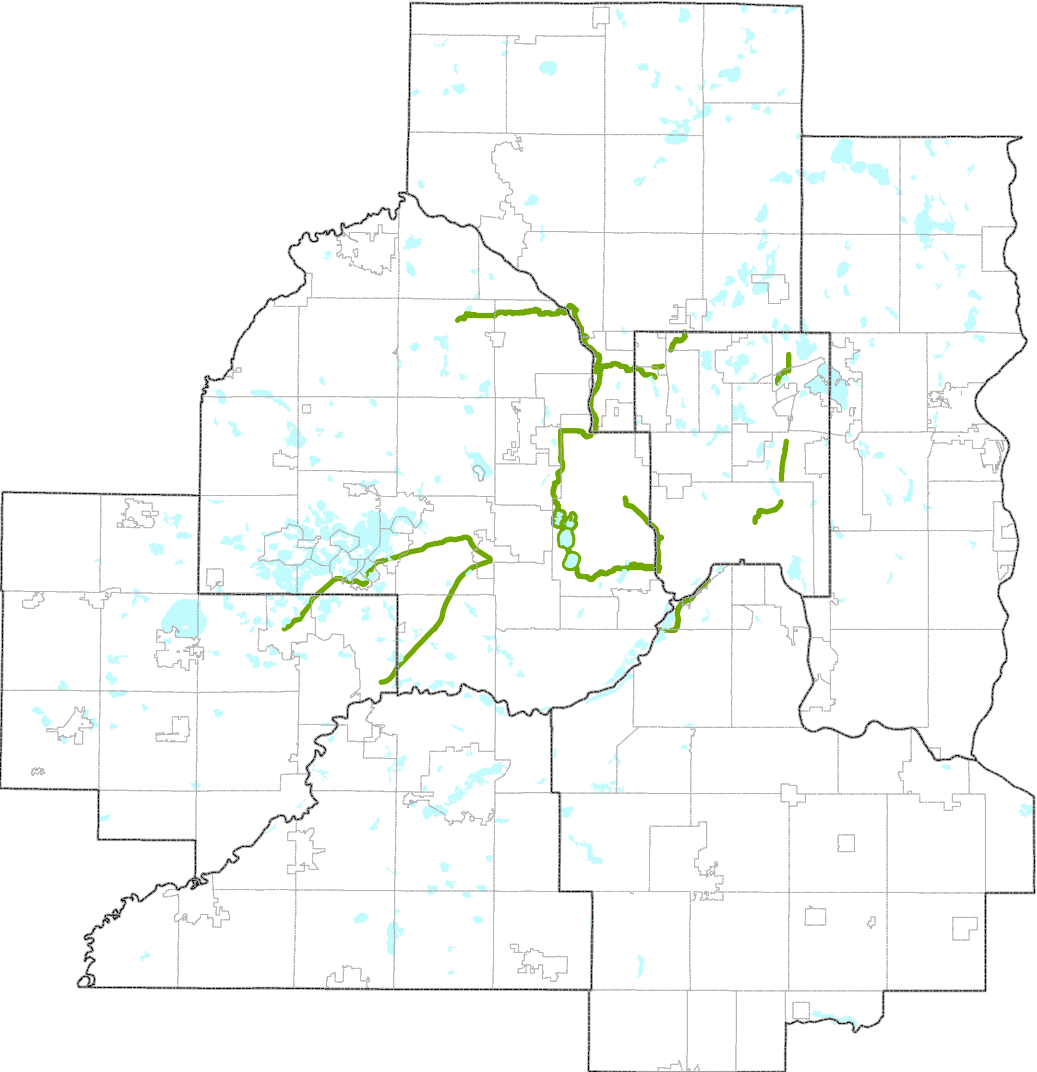
1998 Parks Surveyed



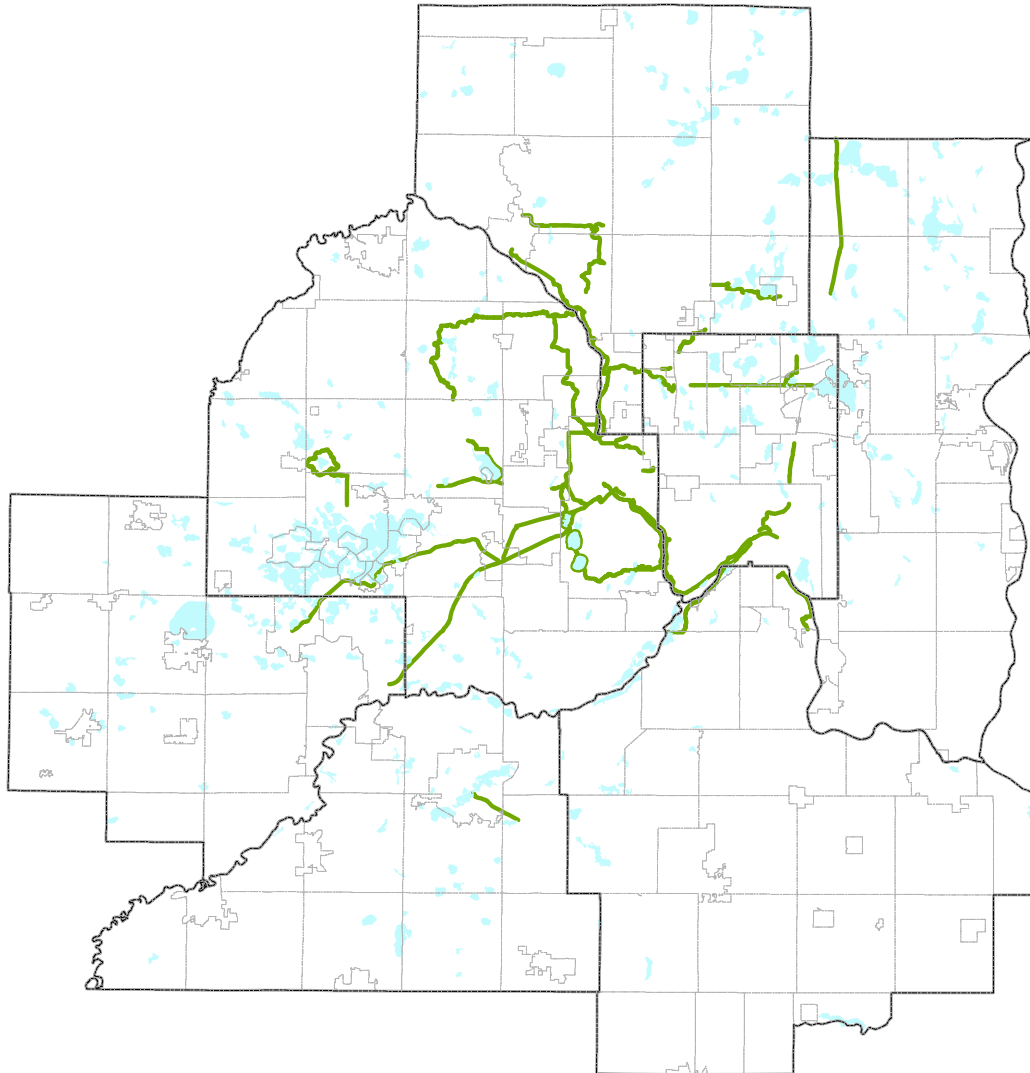
2008 Parks Surveyed

2008 Trails Surveyed

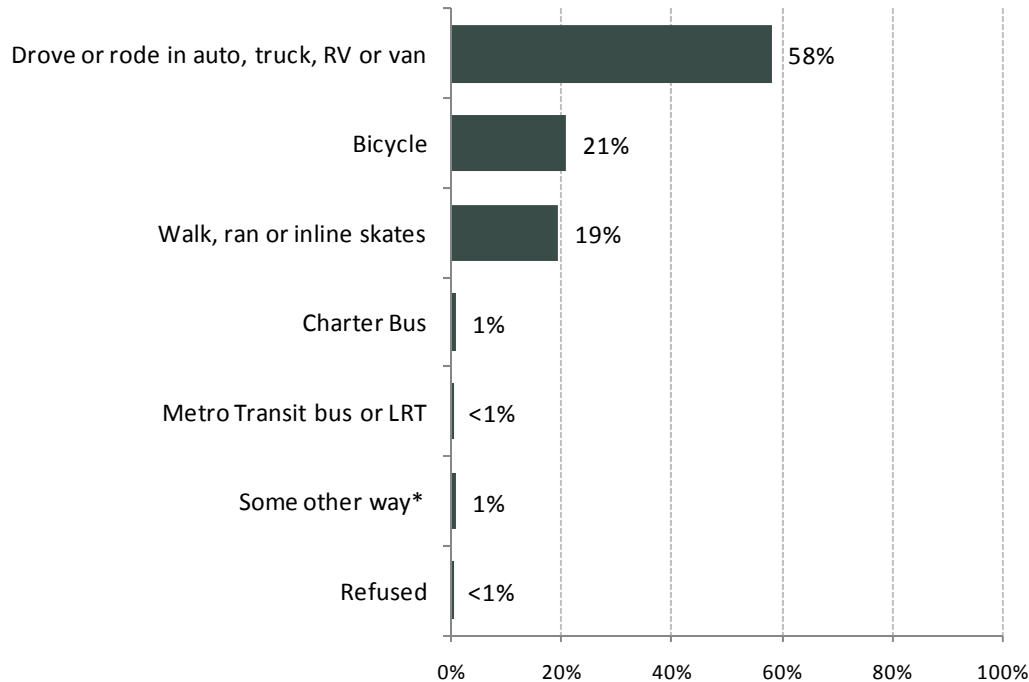

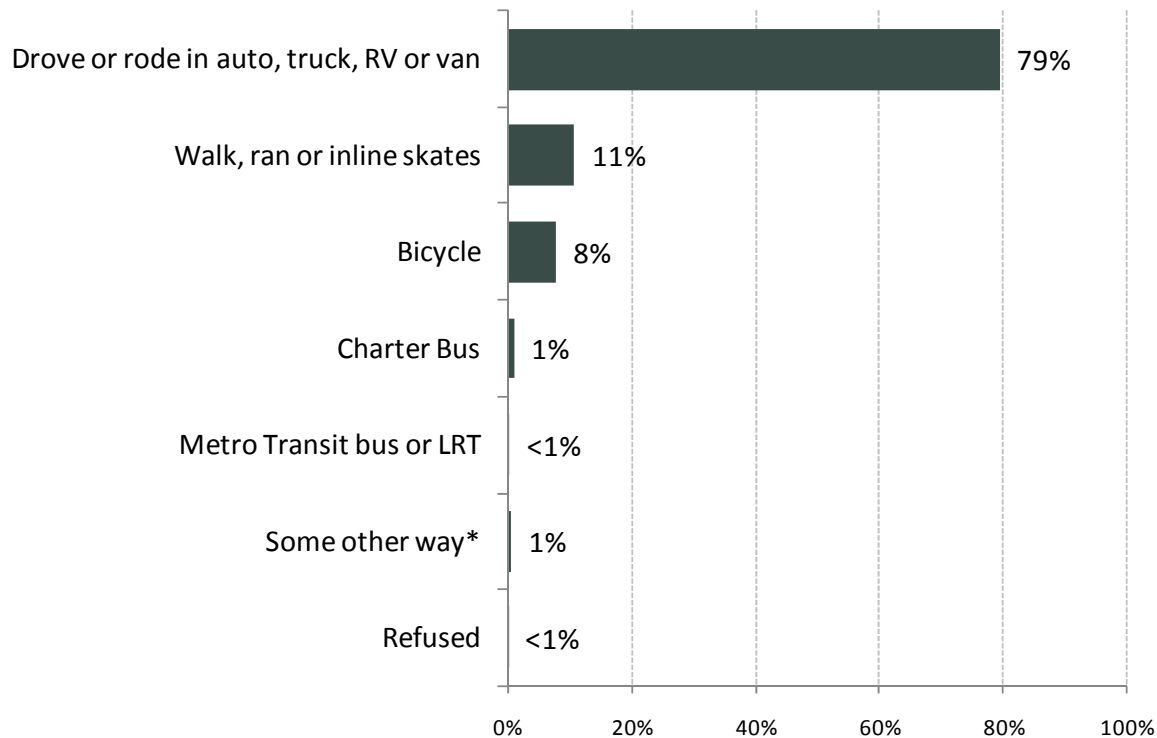

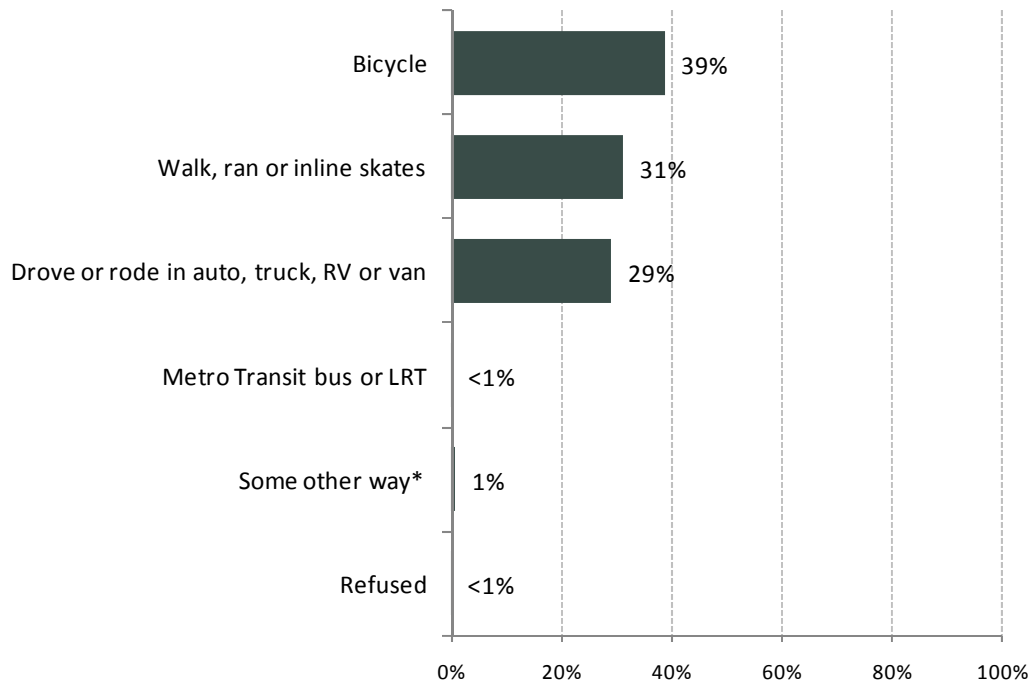

How did you travel to this trail on your visit today?



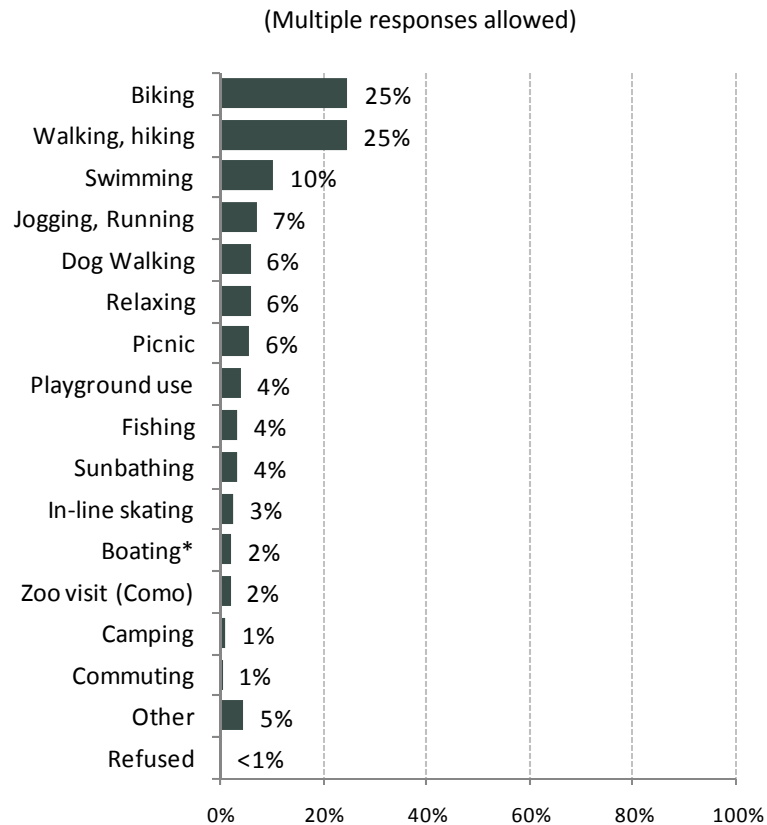

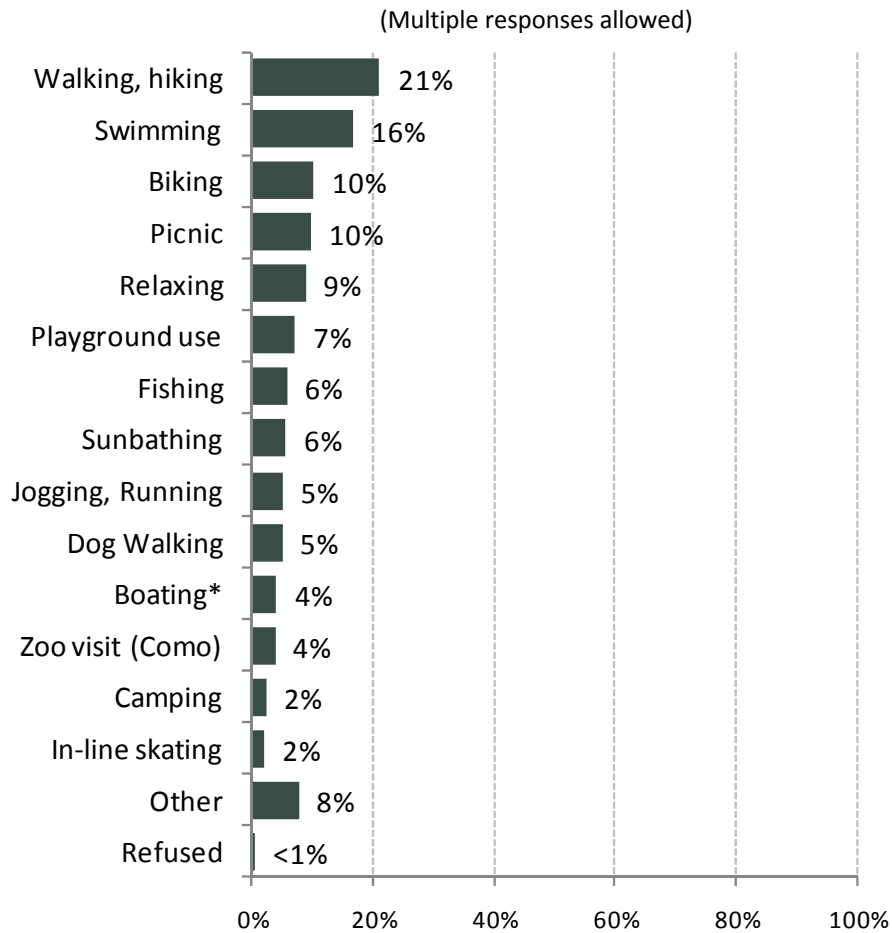

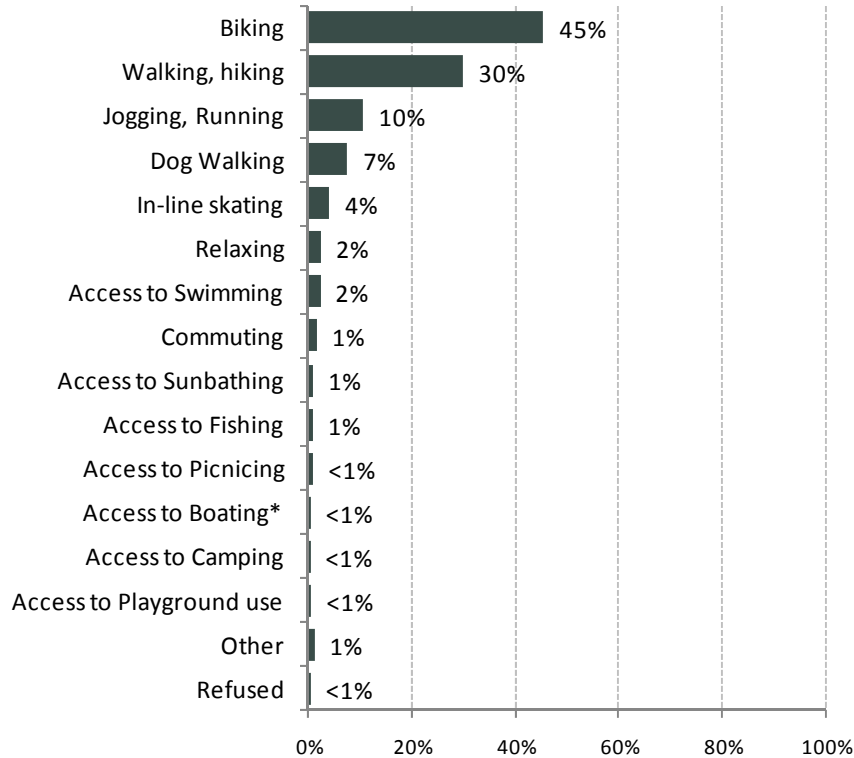

(Multiple responses allowed)



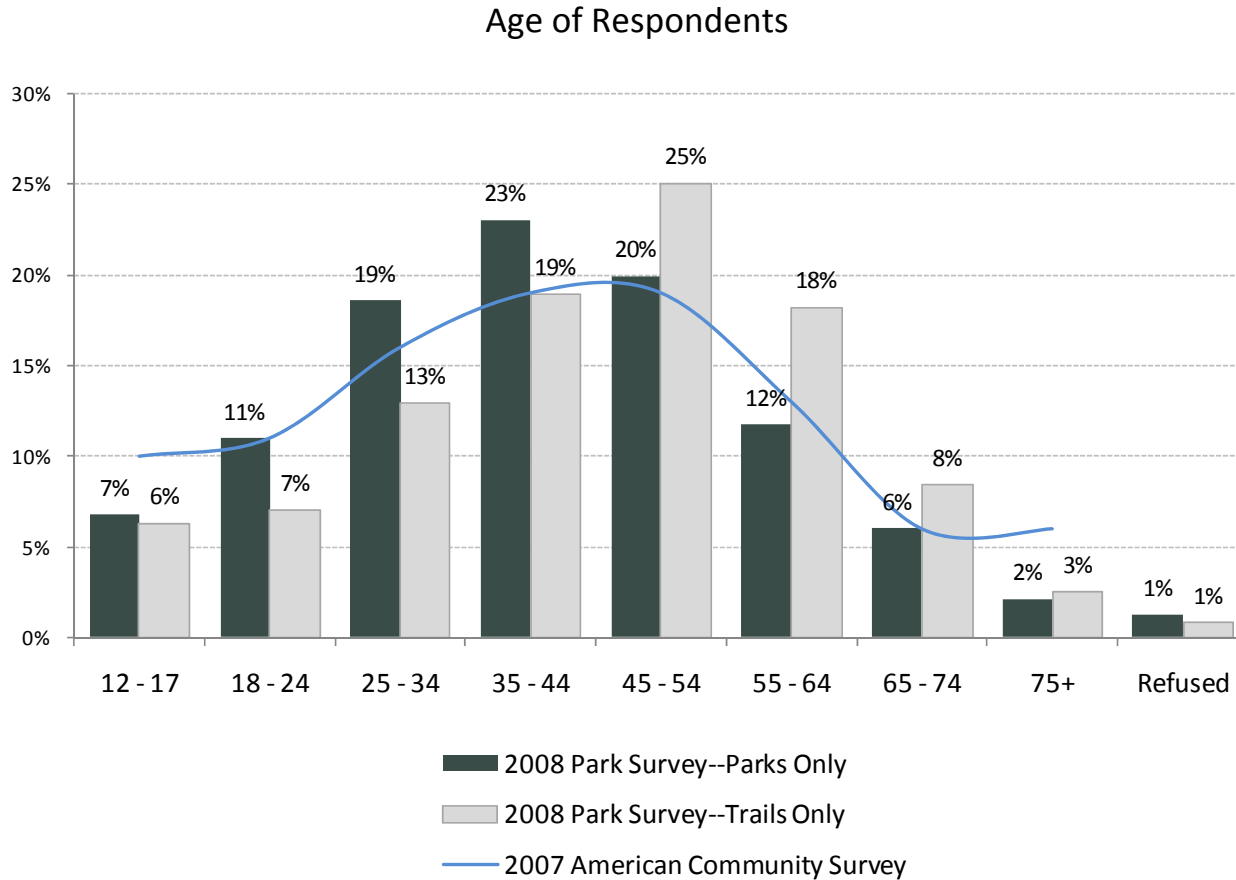

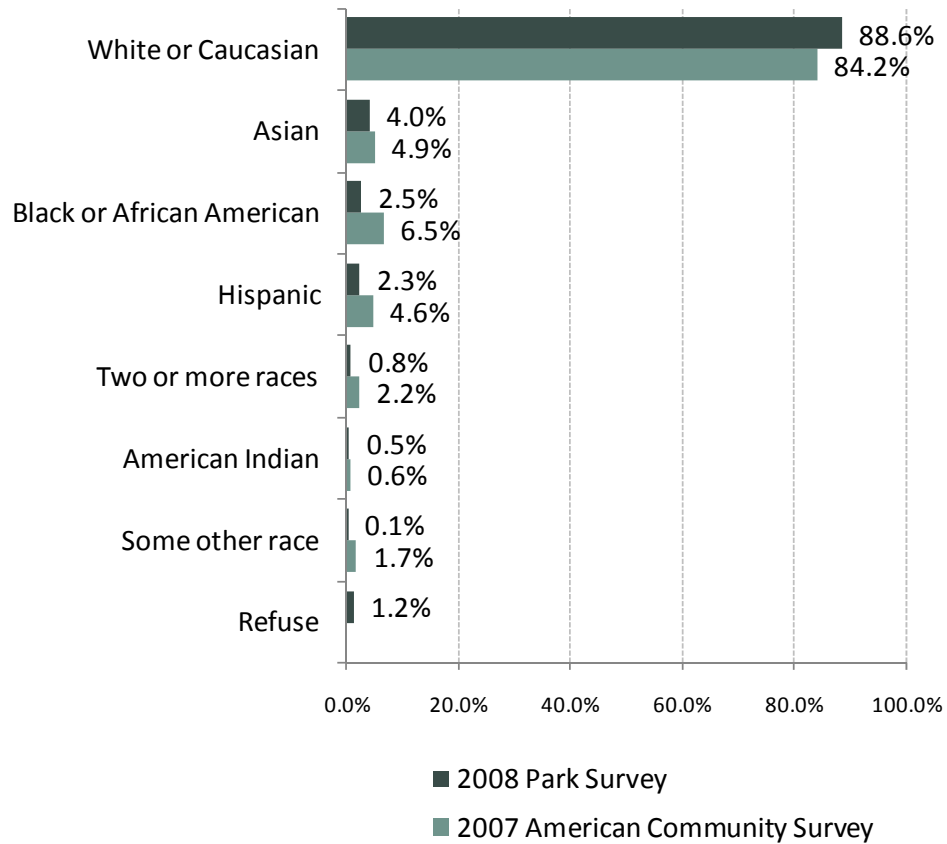
Overall: Age by Parks Only/Trails Only

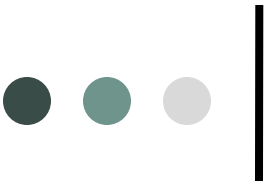
Overall: Race/Ethnicity

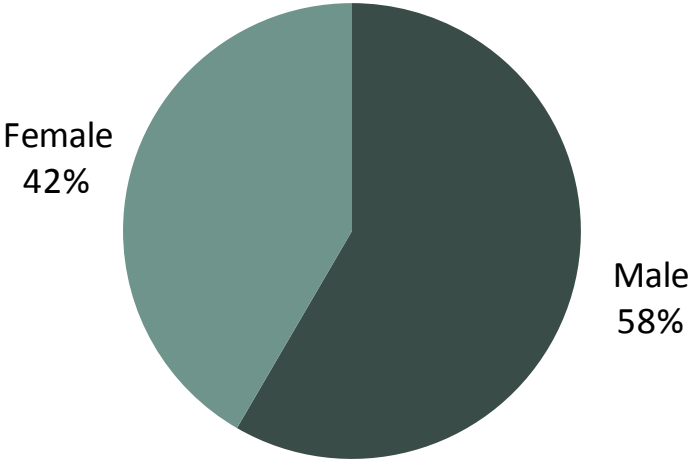
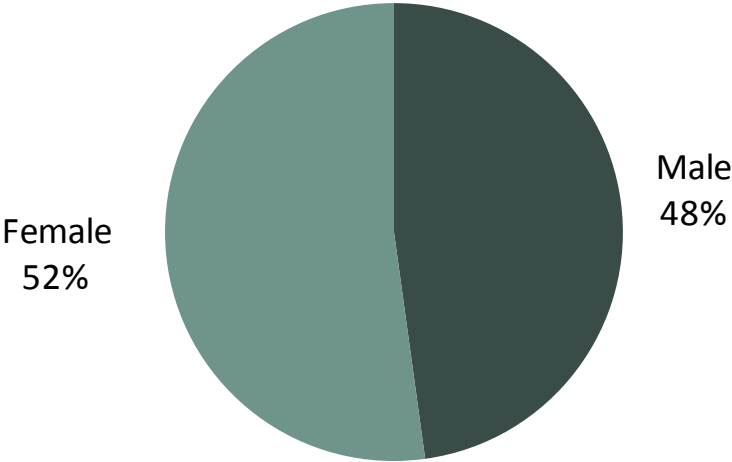




Overall: Gender

Recommendations for Future Surveys

What we learned:

By incorporating the following recommendations, future surveys and research can benefit from the lessons learned conducting this survey.

- **Commuting on trails** – To fully capture the use of Regional Trails for transportation needs, the identification of commuters should be incorporated.
- **Increase minority input** – To better understand the lower utilization rates of parks and trails by minority populations, research should be conducted on minority non-users to identify and address potential barriers to use.

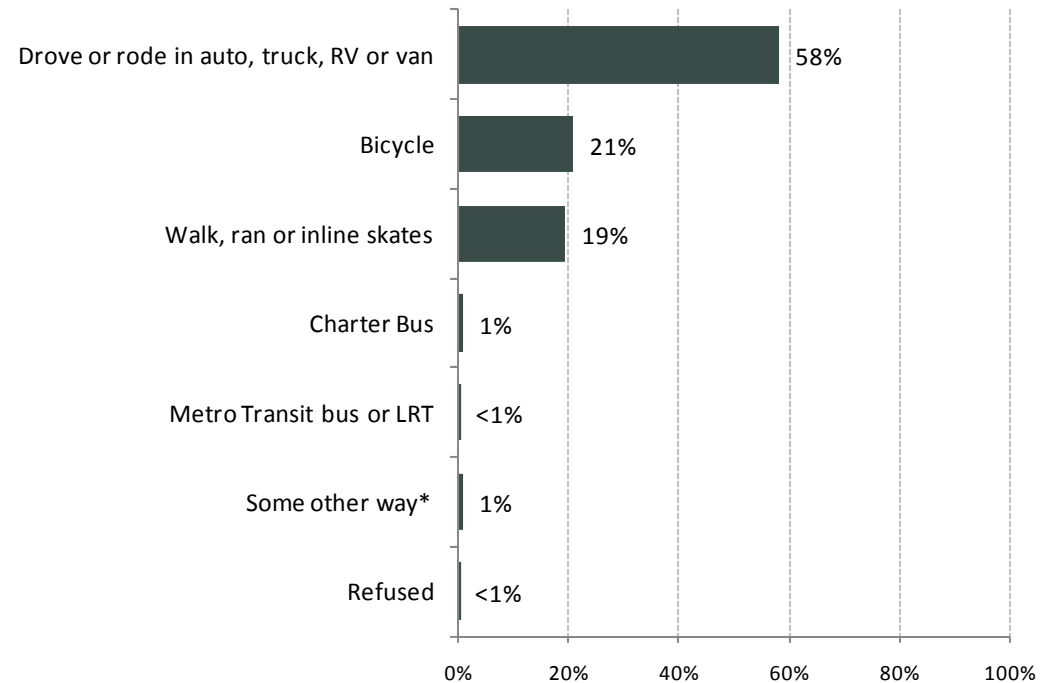

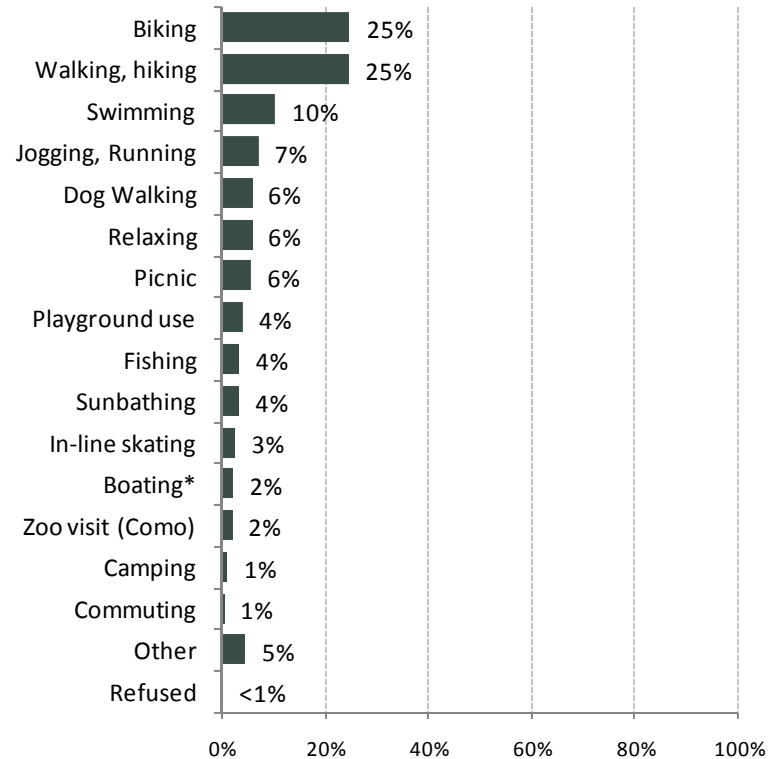

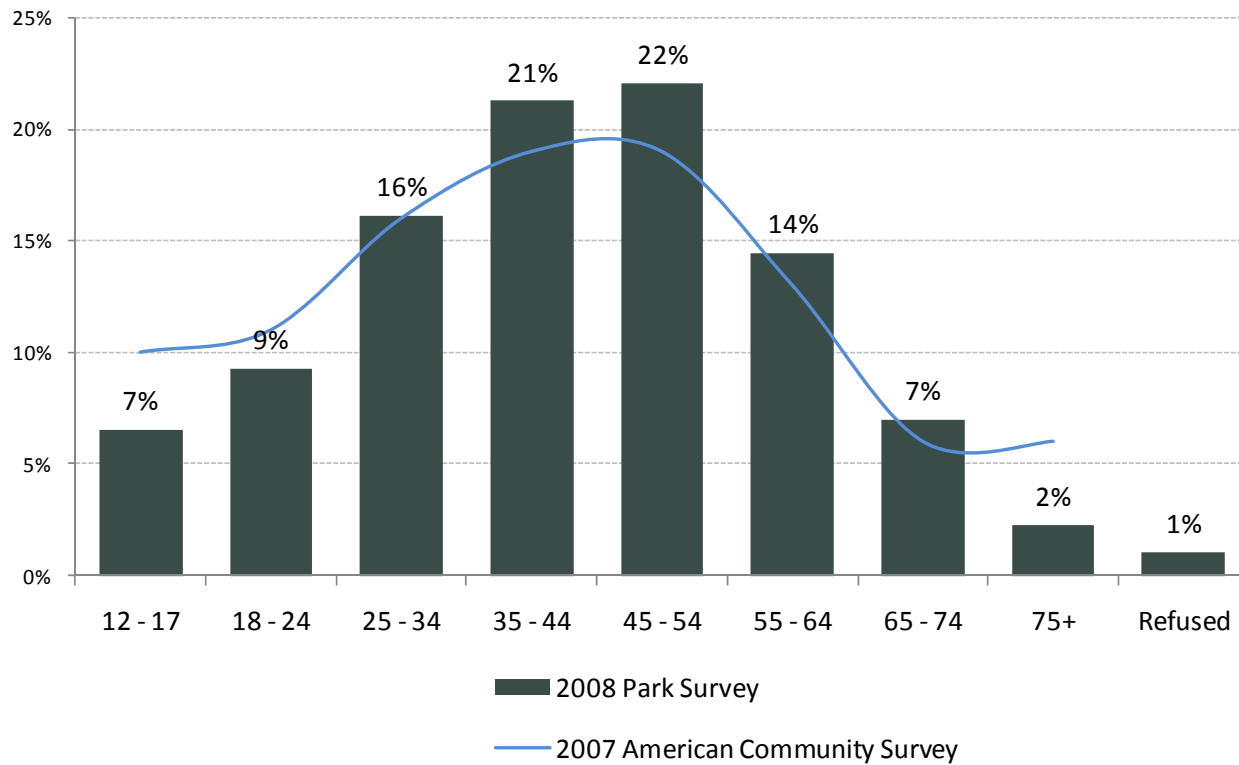

Age of Respondents (Q8)

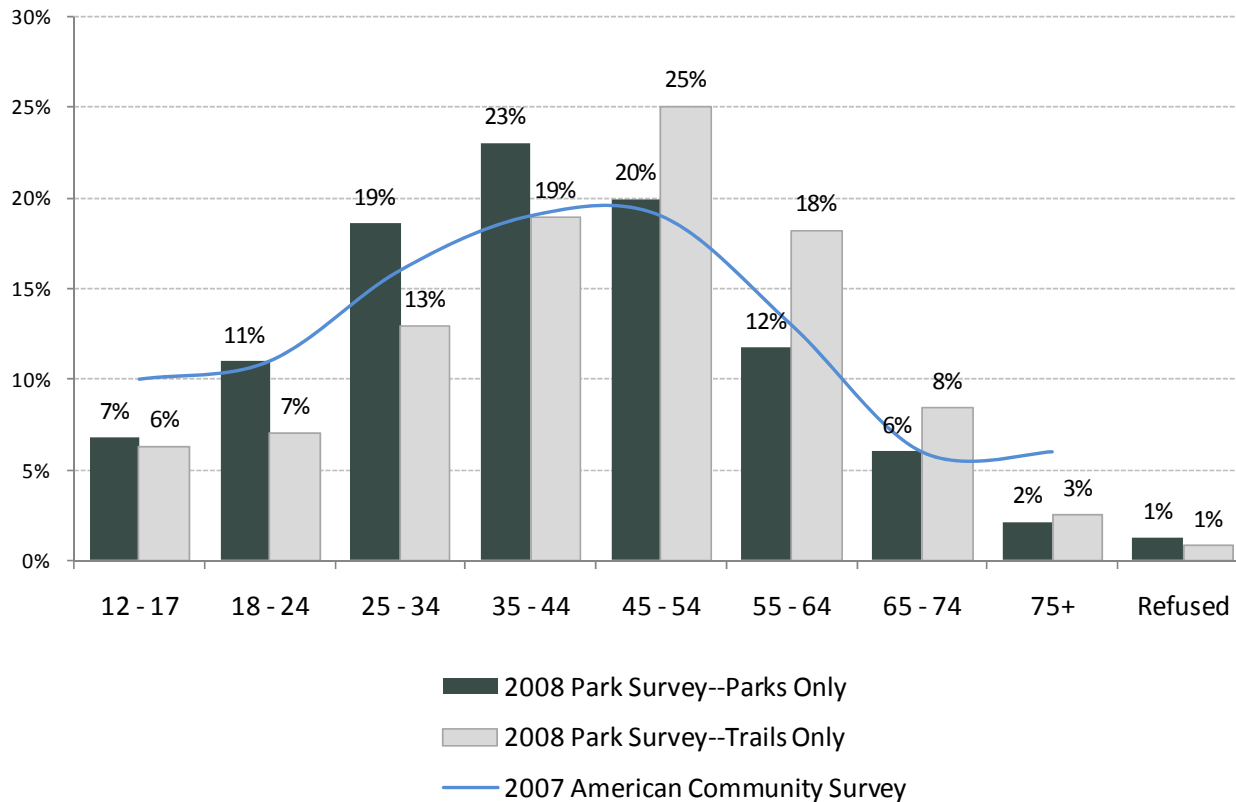

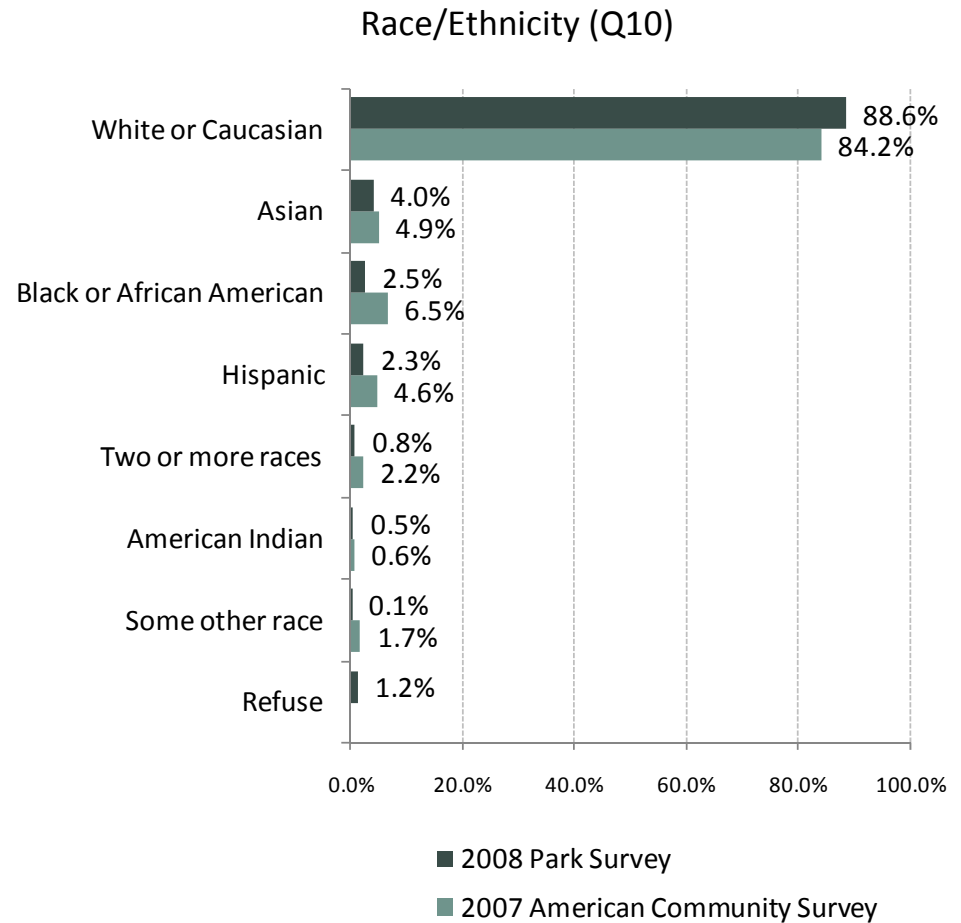

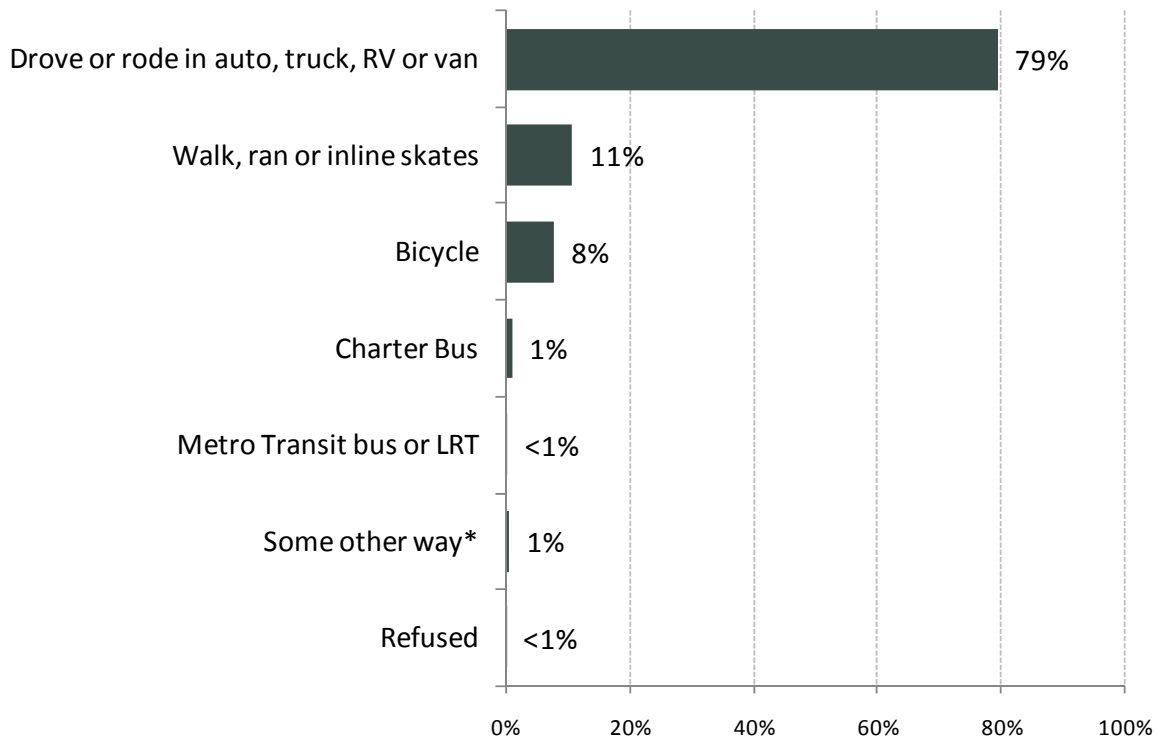

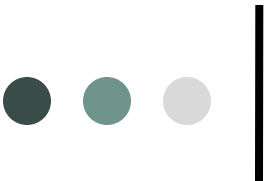

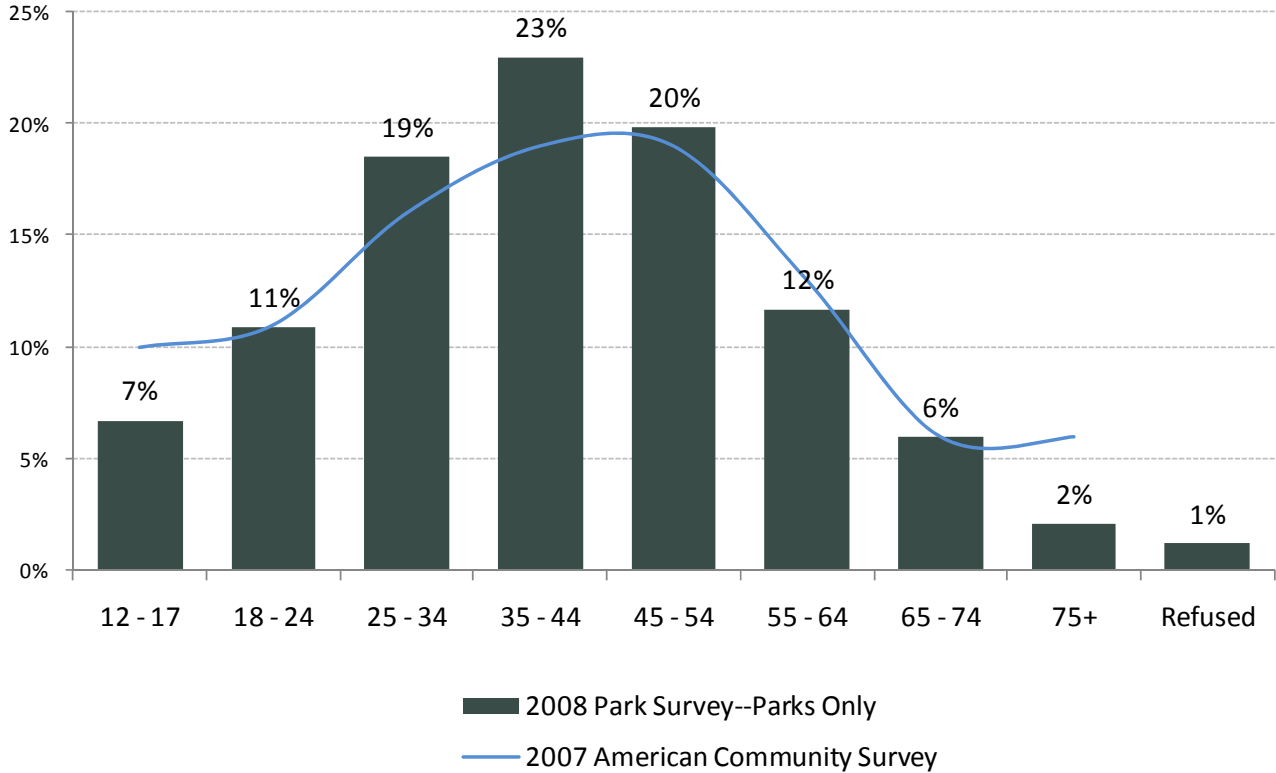
