CALL TO ORDER

A quorum being present, Committee Chair Lindstrom called the regular meeting of the Council's Environment Committee to order at 4:00 p.m. on Tuesday, June 11, 2019.

APPROVAL OF AGENDA AND MINUTES

It was moved by Philip Sterner, seconded by Kris Fredson to approve the agenda. Motion carried.

It was moved by Kris Fredson, seconded by Ray Zeran to approve the minutes of the May 28, 2019, regular meeting of the Environment Committee. Motion carried.

INFORMATION

1. Environment Committee Comprehensive Plan Review Process:

Jeannine Clancy, Assistant General Manager, Technical Services and Kyle Colvin, Manager, Engineering Programs presented a process for consideration by the Committee. Given the number of cities who will have comprehensive plans being presented to Environment Committee, a plan was shared with the Committee to have plans that meet specific requirements be added to a consent agenda versus non-consent agenda.

Qualifying Criteria for Consent Agenda:

- Satisfies content requirements
- Conforms and Consistent with regional wastewater policies and is Compatible with adjacent communities and other jurisdictions.
- Reflects Council assigned forecasts
- No changes in 2040 service area (MUSA)
- Growth and wastewater flow accommodated without need for system capacity improvements or system extensions.
- Addresses I/I mitigation Plan requirements
- Absent significant advisory comments

Criteria for Non-Consent Agenda:

- Represents potential negative impact on regional wastewater system
 - Insufficient existing system capacity
- Represents departure from regional wastewater system plan
 - Underutilization of capacity/investment
- Represents new connection to regional wastewater system by 2040
- Requires follow-up by community considered to be non-typical



It is noted that this process had previously been adopted in 1998. In 2008, the process was amended to have all comprehensive plans reviewed on a non-consent agenda. A return to the 1998 process is being requested for Environment Committee as it will allow staff the opportunity to focus on resolving plans requiring further actions.

Comments and Questions:

Council Member Sterner asked which communities may be added to the system in the future. Staff stated Credit River Township reflects one potential addition to the wastewater system.

Council Member Sterner inquired if there would be a groundbreaking process for new communities who are added to the system. Staff stated a customer forum would be created approximately one year prior to the cut over to the regional system. It is an orientation of sorts that Council Members would be made aware of if they are interested in attending.

Council Member Fredson asked how often the wastewater components would be considered controversial versus having opposition. Staff stated very rarely do plans come in that would warrant a non-consent item. System departure or opposition that exists would warrant non-consent.

Council Member Fredson requested an update to the slide to add "known opposition" to the non-consent criteria. Staff duly noted the update.

Chair Lindstrom stated we would move forward with this plan.

2. General Manager Report

Sam Paske, Assistant General Manager, Environmental Quality Assurance represented General Manager Leisa Thompson who was on annual leave. No report at this time.
