#### INFORMATION

1. Priority Waters Project Update

Staff presented an update on the Priority Waters project, which was first introduced to the Environment Committee through an information item in February. The Priority Waters project is an internal Council staff effort to prioritize the region's lakes, rivers, and streams. The list will be used for staff and financial resource decisions, as a key lens for policies and activities included in the 2050 Water Resources Policy Plan and will be able to offer insights to other organizations as they spend their own valued resources. Staff have produced a draft Priority Waters list which includes 156 lakes and 78 rivers and streams. The list is currently available for internal staff to provide feedback and will be released to external partners and stakeholders through a GovDelivery email later this month. ## Comments and Questions:

Chair Lindstrom recommended the communications include additional benefits received if a lake, river or stream is or is not on the list. Staff appreciated the feedback.

Committee Member Wulff stated she was surprised at the number of unnamed water bodies there are. Staff stated the information was obtained from another source and a number were unnamed. We are not releasing the information to the public until after Thanksgiving and are hoping to go back and take a look at those streams.

Chair Lindstrom indicated that it is a bit more involved than saying we are going to evaluate the dirtiest lakes, streams, and rivers. Staff agreed.
