Non-Consent Business

2023-1: Master Contract for Water Resources Planning, Design, and Consultation (Michael Nguyen 651-602-1503, Rene Heflin 651-602-1077)

It was moved by CM Sterner, seconded by CM Wulff, that That the Metropolitan Council authorize the Regional Administrator to award and execute master contracts 21P339 A-C for water resources planning, design, and consultation services with not to exceed amounts as follows:

Discussion

CM Sterner asked: Are all of the awarded teams local companies?

Staff responded: Yes, they all have local offices.

CM Sterner asked: The DBE was requested to be 9 percent or higher, what were the DBE commitments of the three selected proposers?

Staff responded: We are not sure of the actual commitments, but all three of the selected proposers passed review by the Office of Equity and Equal Opportunity (OEEO).

CM Wulff asked: Is there anyone in-house that can do this?

Staff responded: This contract involves specialty engineering disciplines and having third-party

assistance is important.

Chair Lindstrom asked: Is this master contract for two years?

Staff responded: This contract will be for 5 years.

2023-02: Metro Plant Fourth Incinerator System Supplier Services Request for Proposal, Contract 21P055A (Stephen Norton 651-602-1551, Jody Jacoby 651-602-1144)

It was moved by CM Wulff, seconded by Sterner, that the Metropolitan Council authorize the Regional Administrator to negotiate and execute Contract 21P055A (Metro Plant Fourth Incinerator System Supplier Services) with Veolia Water Technologies & Solutions in an amount not to exceed \$600,000.00.

Discussion

CM Wulff asked: This contract is a bit complex, can you provide some clarification?

Staff responded: This \$600,000 contract is just for the selected incinerator system supplier to support, the design build teams during the design-build proposal phase. The design will occur by the selected incinerator system supplier as a subcontractor to the Design-Builder during the design-build contract.

2023-03: Intergovernment Agreement with the City of Golden Valley (Tim Wedin, 651-602-4571)

It was moved by CM Sterner, seconded by CM Wulff that the Metropolitan Council authorizes its Regional Administrator to negotiate and execute an intergovernmental agreement with the City of Golden Valley for the relocation of the Plymouth Forcemain (Interceptor 8655-384) as part of the City's Douglas Drive at TH 55 Underpass and Intersection Improvements project.

Discussion

CM Wulff: This doesn't have an amount but we know that it's more than half a million, correct? Staff asked: We are estimating about 2.5 million dollars. We are working with the City of Golden Valley for a final bid.
