DBE Utilization on ES Projects

Disadvantaged Business Enterprise (DBE) - Federal Funds

- Construction, Architectural & Engineering (A&E), Professional Technical Contracts
- Annual goal set every three years (2021 2023 =11%)
- Project specific goals assigned by Small Business Unit staff
- Report utilization to Environmental Protection Agency (EPA) (via Public Facilities Authority (PFA)) annually in October

FFY 2023 DBE Utilization

- The Council achieved 9.42% utilization this reporting period on ES projects.
 - > 4.03% Minority Business Enterprise (MBE)
 - > 5.39% Women Business Enterprise (WBE)
- Total Disbursement: \$4,635,072.38 / \$49,194,650.00=9.42%

Highlights from 2023 Report

 Spend with Asian Pacific Americans Increased in 2023 2022 spend was roughly \$475K (6.73% utilization)
 2023 spend was roughly \$756K (16.31% utilization)

• Although overall spend is down, the spend with WBE and MBE firms was much more evenly distributed than in previous years. Historically, WBE spend across all categories has been much higher than MBE spend.



DBE Achievement-Yearly Comparison



Key reasons for shortfall

- There are four current projects that are high dollar value projects that had minimal DBE subcontracting opportunities.
- > 19P187A-Contract of roughly \$19M with 4% DBE goal and commitment by Prime of 4.69%
- ➤ 20P182-Contract value of roughly \$15M with DBE goal of 9% but prime awarded on GFE through reconsideration process with 6.76% commitment
- > 20P228-Contract value of roughly \$30M with DBE goal of 2% and commitment by Prime of 2.29%
- > 21P087-Contract value of roughly \$47M with DBE goal of 4% and commitment by Prime of 4.26%
