#### Low wage workers


The US has 30 million prime-age, low-wage workers

In total, low-wage workers make up more than a quarter of the total labor force.


Minneapolis-St. Paul-Bloomington, MN-WI Ages 18-64 All low-wage workers

548,500 low-wage workers • 35% of all workers • Median hourly wage: \$11.26






#### Making transportation more affordable

Transportation is the second largest household expenditure category after housing.

Households in the lowest income quintile spent the least on transportation but faced a larger transportation cost burden, spending 30% of their after-tax income on transportation.



#### Better transit access: measurable social benefits



Study: Transit pass program brings academic, social and economic benefits to MPS students

The Minneapolis School District's decision to have high school students use public transportation to get to class instead of riding yellow school buses is paying off with <a href="better attendance">better grades</a> according to a new study by University of Minnesota researchers.

The study funded by Metro Transit found that 81 percent of pass users rated their experience as satisfied or very satisfied and 80 percent of parents gave the program the same marks.

Students eligible for free or reduced lunch or were black, foreign-born or from single-parent homes reaped the biggest benefits and rode most, according to the study co-authored by research fellow Kirti Das.

"Transit enables students to access additional educational opportunities and participate in additional activities," Fan said.

To that end, it also helps students' social well being, a benefit Fan did not expect find.

"Not having a pass would be social exclusion," she said, noting that students can use their passes to get to jobs or go to movies with friends. "Not having transportation hinders the ability to socialize, and that is a very important human development activity."

#### **History**

- Founded by Mary Capistrant in 2017 after a year of pilot projects
- TAP Coordinator hired 2018
- Added Unemployment and Refugees to eligibility in 2020
- Automated online TAP application 2021
- Massive marketing revamp and campaign in 2023
- Partners have almost tripled since inception
- Hit one million rides in 2024

#### What is TAP?

- Reduced fare pass \$1 ride on a Go-To Card
- Lasts for one year, then can be renewed
- Applicants need to have both an identity document and proof of income — usually from a social benefits program like WIC, EBT or Medical Assistance

### Making it easier to qualify: City of Minneapolis

Now people can easily use a tax return or paystub to qualify for TAP directly – even without social benefits.

#### Recent developments: challenges

- Removal of rush hour means TAP isn't needed for seniors and youth
- Social benefits expansions from pandemic expired and now many do not qualify, despite inflation chipping away at household budgets
- Changes at federal level make it less likely immigrants will seek benefits like TAP
- Other pass programs are serving the TAP user base — schools, Access Pass, etc.

#### **Limiting factors**

- Proving identity and income
- Knowing about TAP
- Ease of application and use
- Participation of non-profit partners





### Primary barrier to growth – proving eligibility



Social stigma or other concerns can keep people who are eligible from applying. Many lower income people do not have access to the social programs we depend on to certify riders.





#### Recent developments: positive

- TAP ridership up 13% in 2024
- TRIP agents have embraced TAP, hugely supportive
- TAP Ambassadors have full calendar of tabling and events
- Great collaboration with OECC and Outreach
- Ongoing discussions with major partners like Minnesota DHS
- Technology improvements have significant potential
   fare capping, easier eligibility, increased term to
   two years

# Options for increasing accessibility

Short Term	Medium Term	Long Term
Implement two-year term	New fare system is implemented, switch to account based	Fare capping
Fare simplification: rush hour	Pilot self certification for income	Self certification for income
Direct income verification at stores and online	Integration with DHS	Explore options for TAP \$5 promotional allowance with legislature






