Thrive Lens Defined

 The Thrive Lens is a decision-making tool to align decisions with Thrive.

It's not a check list or compliance exercise.



Council work has historically supported Thrive Outcomes

- Integration of forecasts for jobs, households, population, sewers and transportation
- Affordable housing funds
- Livable Communities Program
- Surface water quality



But challenges today require more

- Global competition
- Growing disparities and equity issues
- Climate pressures
- Etc

These challenges are "complex system" problems



Thrive Lens operationalizes Thrive

Thrive states the Council will...

...use its existing role and capacity to plan and invest in community development and consider **prosperity and economic competitiveness as a lens** through which to evaluate its planning, operations, and investment decisions.

...use **equity as a lens** to evaluate its operations, planning, and investments, and explore its authority to use its resources and roles to mitigate the place-based dimension of disparities by race, ethnicity, income, and ability.

...use climate impacts as a lens through which to examine all of its work.

Who outside the Council has been involved? How? (collaboration)	For example: What cross section of the community has been engaged? Are other entities doing this work? If so, what is the Council's contribution or "added value" to this work?						
How will success be measured? (accountability)	For example: How does this demonstrate data-driven decision making? Will the results be tracked and analyzed?
