



Emerging Mitigation Ideas

- Create regional trails as GHG emissions reduction strategy. Recognize as arterial backbone of an active transportation network.
- Promote tree planting along trails for shade, comfort, and carbon sequestration.

Emerging Adaptation Ideas \bullet

- Create Climate Action Plans that are multi-jurisdictional and create Federal funding opportunities
- Re-think regional trail corridors to expand beyond current use. Stitch together wildlife corridors. Connect important natural areas.
- Build conservation partnerships beyond park and trail boundaries.

Jan. 18, 2024 – Discussion of Draft Parks Objectives, 3 of 3

Natural Systems Ideas

- Emphasize lands with restoration potential, including former industrial landscapes.
- Locate lands in low-service, low-wealth, high BIPOC areas for regional designation.
- Convert abandoned railroad corridors to regional trails.

Equitable Recreation Activities and Facilities Ideas

- Expand allowable activities and facilities in regional parks and trails to meet emerging needs.
- Balance flexibility with desire to retain what is unique about our system's natural resource foundation.

ropolitan Counci

Agency-Council Climate and Natural Systems Workgroup Advice

December 2023, January 2024 meetings

- First meeting focused on desired outcomes and possible actions:
 - Desired outcomes: Increased community buy-in, regional parks mitigate climate impact, native habitat is expanded and enhanced, tree canopies are healthy and robust.
 - Actions (in park): Convert turfgrass, expand bison herd, expand recycling and organics collection, conduct regionwide wildlife and habitat study, inventory greenhouse gas emissions, collect data via citizen science
- Second meeting was intended to be more specific, keying in on three areas of focus: adaptation, mitigation, and natural systems.
 - Promote Regional Parks and Trails System as the "Swiss Army knife" of climate resilience.
 - Build awareness of climate change issue and parks as critical part of the solution. Communications and storytelling are key tools.
 - Acquire land to protect land and water and provide ecosystem services.
 - Consider a new natural system/open-space classification.
 - Collect and disseminate regionwide natural systems data and share tools to facilitate agency and community implementation.



May 2, 2024	Focus: Present overview of 60% draft plan.		









Chapter Four: Siting and Acquisition Policy and Strategies

- **Siting and Acquisition Policy** "Identify lands with high-quality natural resources that are desirable for Regional Parks System activities and put these lands in a protected status, so they will be available for recreational uses and conservation purposes in perpetuity."
- Strategy 1: Priorities "Lands with natural resource features, access to water, and/or restoration potential will be a priority for the Regional Parks System."
- Strategy 2: Geographic balance "Geographic balance or proportionate distribution tied to population distribution patterns shall be a consideration when exploring system additions."
- Strategy 3: Council-approved long-range plans "Priorities for land acquisition are set by regional park implementing agencies in Councilapproved long-range plans."
- Strategy 4: New regional trails "New regional trails must serve a regional audience and provide connections between regional parks, park reserves, and regional trails without duplicating an existing trail."
- Strategy 5: Special recreation features "Special recreation features must enhance services and facilities already offered, not compete with, or duplicate them."
