1.0 Introduction

1.1 Purpose of Report

This Hazardous and Regulated Materials Technical Report has been prepared in support of the Bottineau Transitway Project Draft Environmental Impact Statement (Draft EIS). The objective of this report is to evaluate the Bottineau Transitway Project's potential to encounter during construction, contaminated soils or groundwater as a result of hazardous and/or regulated materials near the project. This includes the following:

- Evaluate the Project's likelihood to encounter buried or aboveground storage tanks that may or may not be leaking.
- Evaluate the Project's likelihood to encounter hazardous building material such as asbestos, lead paint, fluorescent lights, and chemicals.
- Evaluate the Project's likelihood to encounter contaminated material or soils that may have been abandoned at the ground surface or buried.
- Evaluate the Project's likelihood to encounter contaminated groundwater.
- 2.0 Technical Analysis

2.1 Regulatory Context/Methodology

2.1.1 Legal and Regulatory Context

The Minnesota Pollution Control Agency (MPCA) oversees regulations pertaining to contaminated soil, groundwater, and waste cleanup plan approvals; petroleum underground storage tank registration and removal; and National Pollutant Discharge Elimination System (NPDES) permitting. Additionally, the Minnesota Department of Health (MDH) regulates asbestos abatement. Activities that encounter contaminated materials must follow state requirements for safe handling and disposal under the purview of the MPCA.

2.1.2 Study Area

The study area includes potentially contaminated properties or regulated material facilities around each proposed alignment within the appropriate ASTM (American Society of Testing and Materials) standard search distance for available governmental databases identified in the ASTM standards (E1527-05 and 40CFR Sec. 312). These standard search distances vary from adjacent to the project to one-mile around the Bottineau Transitway Project and are listed in Appendix A. The database searches were conducted by alignment; therefore, there is overlap in the number of sites between adjacent alignments, as shown in Figure 2.

2.1.3 Methodology

There is no single comprehensive source of information available, which identifies known or potential sources of environmental contamination along the alternatives of the Bottineau Transitway Project.

Therefore, to identify and evaluate sites potentially containing hazardous or regulated materials (such as petroleum products), or other sources of potential contamination, a governmental database search was conducted. This screening tool identifies locations of sites with known or potential environmental liabilities based on information contained in various federal and state government databases. A list of the databases searched can be found in Appendix A. The databases that identified documented sites for the proposed alignments are listed below.

- Superfund Site Information Listing (SHWS) This database includes all sites that the state Superfund Program is dealing with or has dealt with. The Superfund Program identifies, investigates, and determines appropriate cleanup plans for abandoned or uncontrolled hazardous waste sites. All SHWS sites are categorized as high risk. (one-mile search area)
- Voluntary Investigation and Cleanup Program (VIC) Database containing records for sites enrolled in the VIC. All identified VIC sites are categorized as high risk. (¹/₂-mile search area)
- Brownfields Database containing property information for petroleum impacted sites. All brownfield sites are categorized as medium risk. (½-mile search area)
- Leaking Underground Storage Tanks (LUST) Database contains records of reported leaking underground storage tanks and other subsurface tank storage incidents. Closed LUST Sites beyond 1/8 mile are categorized as low risk and closed LUST Sites within 1/8 mile are categorized as medium risk. Open LUST sites are categorized as high risk. (¹/₂-mile search area)
- Leaking Aboveground Storage Tanks (LAST) Database containing records of reported leaking aboveground storage tanks and other surface tank storage incidents. Closed LAST Sites beyond 1/8 mile are categorized as low risk and closed LAST Sites within 1/8 mile are categorized as medium risk. Open LAST sites are categorized as high risk. (1/8 mile search area)
- SPILLS Database containing records for spills reported to the Pollution Control Agency. Closed SPILLS Sites beyond 1/8 mile are categorized as low risk and closed SPILLS Sites within 1/8th mile are categorized as medium risk. Open SPILLS sites are categorized as high risk. (½-mile search area)
- Department of Agriculture Spills (AG SPILLS) Database containing records for pesticide and fertilizer incidents reported to the Pollution Control Agency. Closed AG SPILLS Sites beyond 1/8 mile are categorized as low risk and closed AG SPILLS Sites within 1/8 mile are categorized as medium risk. Open AG SPILLS sites are categorized as high risk. (½-mile search area)
- Underground Storage Tanks (UST) Database listing registered underground storage tanks. Sites not listed in any previously described database are low risk. (Site and adjoining properties)
- Aboveground Storage Tanks (AST) Database listing registered aboveground storage tanks. Sites not listed in any previously described database are low risk. (Site and adjoining properties)

When multiple databases referred to a site, the highest applicable risk was used for classification.

The impact analysis attempts to evaluate the potential risk for contaminants to be found during construction based on known records. It does not measure the severity of the hazardous materials found onsite. Each of the sites identified through the database search was assigned a degree of risk for potential soil and or groundwater impacts.

Low Risk – Low Risk sites are sites with a low risk potential for having contamination on-site. These sites are locations where hazardous material or petroleum products may have been stored or used; however, based on subsequent file review and field reconnaissance, no known contamination is associated with the property. Low risk sites include closed LUST and LAST sites

that are more than 1/8-mile away from an alignment, inactive UST and AST sites, and closed SPILLS and AG SPILLS sites.

- Medium Risk Medium Risk sites are sites with a medium risk potential for having contamination on-site. These sites are known to have, or have had, soil and/or groundwater contamination, but current information indicates that contamination is being remediated, does not require remediation, or that already requires continued monitoring. Medium risk sites include all Brownfields, open LUST and LAST sites that were more than 1/8-mile away from an alignment, open SPILLS and AG SPILLS sites.
- High Risk These sites have a high potential for contamination to be found on-site. In some cases, contaminated groundwater may have migrated outside the boundaries of the site. Field investigation of soil and groundwater within planned construction limits may be needed to identify any contributing contamination from these sites and to identify a response action plan to be implemented during construction. High Risk sites include all SHWS sites, VIC sites, and open LAST and LUST within 1/8-mile of build alternative alignments.

2.2 Affected Environment

Potentially contaminated properties are often found in previously developed industrial and commercial areas, land uses that are common throughout the Bottineau Transitway project area. All of the proposed alignments have some potential to encounter contaminated soils, groundwater, and materials based on prior use and development along the corridor. Table 1 provides a summary of the known hazardous/regulated materials sites identified within the study area of each alternative based on a review of several databases that track known contamination sites. Appendix B contains the full listing of the contaminated sites potentially affecting the Bottineau Transitway Alignments obtained during the records search. The identified sites are shown on Figures 2 through 8.

2.3 Environmental Consequences

2.3.1 Operating Phase Impacts

No-Build Alternative

There is no likelihood of encountering contamination from hazardous or regulated materials as a result of the No-Build alternative. No positive or negative impacts are anticipated to result from this alternative.

Transportation System Management Alternative

There is no likelihood of encountering contamination from hazardous or regulated materials as a result of the TSM alternative. No positive or negative impacts are anticipated to result from this alternative.

Build Alternatives

There would be no hazardous or regulated materials produced by the project during operation of the Bottineau Transitway. No permanent storage tanks would be installed for this project. The collection and disposal of oils, grease and other waste materials generated during vehicle maintenance and repair activities would be accomplished in accordance with recognized industry Best Management Practices (BMPs) for rail transit maintenance facilities.

Acquiring land that is contaminated or contains hazardous or regulated material creates risk in the form of costs and potential liability to the project and project proposer. The extent of that risk would be based on the type and extent of the contamination. Therefore, acquiring land with known contamination which cannot be easily remediated or contained would be avoided to the extent possible based on a more detailed investigation (Phase 1 and/or 2 Environmental Site Assessment) of potential for contamination after a preferred alternative is identified. If remediation is completed in areas of known and encountered contamination during construction, the long term risk to the project would be small.

Traction Power Substation (TPSS)

There would be no hazardous or regulated materials used or generated by the TPSS sites during operation of the Bottineau Transitway.

2.3.2 Construction Phase Impacts

No-Build Alternative

There is no likelihood of encountering contaminated or regulated materials as a result of the No-Build alternative. Therefore, no positive or negative impacts are expected.

Transportation System Management Alternative

There is no likelihood of encountering contaminated or regulated materials as a result of the Transportation System Management alternative. Therefore, no positive or negative impacts are expected.

Build Alternatives

The number of potentially contaminated sites in each alignment is summarized in Table 2. Because there is overlap in the study area for each alignment, some sites are listed under more than one alignment. Figure 2 illustrates these overlaps. There are no impact differences for the Operations and Maintenance Facility (OMF) sites under Alignment B, as there are no known potentially contaminated sites near either location. There are also no difference in impacts for either of the proposed stations under alignment D1, as there are no known potentially contaminated sites near either station

location. Figures 3 through 8 illustrate known sites by alignment.

TPSS

The minimum clearance distance for TPSS sites and the light rail transit (LRT) tracks is approximately eight feet; therefore, the TPSS site would be located at least eight feet from the tracks. The TPSS would be sited to minimize the risk of acquiring or encountering contaminated materials, as balanced against other project alternatives.

2.3.3 Indirect/Secondary Impacts

Build Alternatives

Provided the project follows the appropriate methods for handling, transporting, disposal and treatment of contaminated soil/groundwater or other contaminated materials, there would be no indirect or secondary impacts as a result of the project.

2.4 Avoidance, Minimization, and/or Mitigation Measures

Hennepin County and the Metropolitan Council would enroll in the MPCA VIC (Voluntary Petroleum Investigation and Cleanup) Program, to obtain assurances that contaminated site cleanup work and/or contaminated site acquisition would not associate the agencies with long-term environmental liability for the contamination, and to obtain approvals for any contamination management and cleanup up plans.

High and medium risk areas, if within or near the area of disturbance, would be further assessed to determine the presence, type, and magnitude of contaminated soil and/or groundwater. A Phase 1 Environmental Site Assessment (ESA)(ASTM standards) would be completed for all disturbance areas within the selected build alternative. The results of the investigation would be used to determine if contaminated materials could be minimized or avoided or if additional investigation is needed (Phase 2 ESA). A Response Action Plan (RAP) would be developed to set a protocol for properly handling and treating contaminated soil and/or groundwater that could not be avoided during construction to address potential short-term impacts.

Prior to construction activities, a MPCA-approved Construction Contingency Plan would be developed, as part of the Voluntary Investigation and Cleanup (VIC) Program. In the event that previously unknown hazardous materials are discovered during construction, the Contractor shall notify the Project Engineer immediately and follow the prescribed management protocol contained in the Construction Contingency Plan. The materials would be handled in accordance with appropriate federal and state regulations to avoid short-term impacts.

A management plan would be developed for properly handling, treating, storing, and disposing of solid wastes, hazardous materials, petroleum products, and other regulated materials/wastes that are used or generated during construction. The plan would also establish protocol to minimize impacts to soils and groundwater in the event a release of hazardous substances occurs during construction. If a release were to occur, the Minnesota Duty Officer would be contacted immediately to make the required agency contacts.

Prior to the demolition of any structures, assessments for asbestos-containing materials, lead-based paint, and other regulated materials/wastes would be performed. A demolition and disposal plan would be prepared for any identified contaminants that may be encountered during construction.















