# Dakota Land, Water, and People Acknowledgment

The Metropolitan Council acknowledges that the land we currently call Minnesota and specifically the seven-county region is the ancestral homeland of the Dakota Oyate who are present and active contributors to our thriving region. As part of the Metropolitan Council's commitment to address the unresolved legacy of genocide, dispossession, and settler colonialism and the fact that government institutions, including the Metropolitan Council, benefitted economically, politically, and institutionally after the forceable removal of the Dakota Oyate, the Metropolitan Council is dedicated to instilling Land, Water, and People Commitments in regional policy. These commitments support the Dakota Oyate, the eleven federally recognized Tribes in Minnesota, Ho-Chunk Nation, and the American Indian Communities representing over 150 diverse Tribal Nations that call the seven-county region home.

  - 2. 2025-152 SW: Streamlined 2025-2028 TIP Amendment Request MnDOT MN 280 Pavement and Bridge Rehabilitation (Joe Barbeau, 651-602-1750)

It was moved by Vento, seconded by Osman.

Vento recommended an information session around transportation safety.

Motion carried.

#### Non-consent business

1. 2025-143: Procurement of 128 Biodiesel Forty-Foot Transit Buses, Contract 25P113 (Jeremiah Riter 612-349-5005)

It was moved by Pacheco, seconded by Carter, Tyronne, that the Metropolitan Council ("the Council") authorize the Regional Administrator to exercise bus purchase options utilizing the State of Washington's Master Contract 06719-01 with Gillig LLC to purchase (128) 40-foot buses for the Council's regular route services in an amount not to exceed \$ 122,085,767.45.

Carter, Tyronne asked about the lifecycle of buses, Riter shared that buses past their life here are sold at auction.

#### Motion carried.

2. 2025-145: Contract – Purchase of Non-Revenue Vehicles and Equipment for the Green Line Extension (Anthony Zessman 612-349-5073)

It was moved by Osman, seconded by Pacheco, that the Metropolitan Council take the following actions related to the METRO Green Line Extension Project:

Approve the purchase of Non-Revenue vehicles and equipment at a cost of up to \$10,000,000 using funds already contained in the Green Line Extension project budget. Council Members voiced appreciation for the state and use of the vehicles.

Motion carried.

3. 2025-146 SW: Allied Universal Contract 22P123 Amendment 4 (Matt Broughton 612-349-7472)

It was moved by Vento, seconded by Carter, Tyronne, that the Metropolitan Council authorize the Regional Administrator to execute an amendment to contract 22P123 with Allied Universal for a total not to exceed of \$13,030,132.

Council Members asked about the various levels of staffing and for clarifications about extensions.

### Motion carried.

4. 2025-153: 2050 TPP Amendment Release for Public Comment (Bradley Bobbitt 651-602-1724)

It was moved by Osman, seconded by Vento, that the Metropolitan Council approve releasing the draft 2050 TPP Amendment 1, changing the alignment and funding for the Blue Line Extension transitway and adding the Gold Line Extension transitway to the fiscally constrained plan, for public comment.

Motion carried. Hearing no objection, Vice Chair Chamblis stated the item may proceed Consent to Council.

## Information

1. 2050 TPP Aviation System Plan Update (Joe Widing 651-602-1822)

Council Members asked about specifics on seaplane bases and asked about the interplay with federal requirements.
