A. 2040 Transportation Policy Plan Kickoff

Connie Kozlak gave a presentation on the update from the 2030 TPP to the 2040 TPP. It is a long-range transportation plan for the Twin Cities region and is required under state and federal law to be updated every 4 years. Since the plan includes multiple modes of transportation, it is prepared in coordination with the Transportation Advisory Board and Committees, MnDOT and MAC. Thrive MSP 2040 will influence the policy direction for the Transportation Policy Plan.
