#### REPORTS

Council Members:

<u>Kramer</u>—The bond sale occurred today, and the Council once again received a AAA rating from both Moody's and S&P. Both rating agencies cited the Twin Cities' strong and diverse economic base, the Metropolitan Council's strong financial position and fiscal management, and a low overall debt burden as factors in the top rating. The Council sold 3 separate bond issues comprising of \$157.3M in new money. Bond sale 2018B was for \$12.3M in taxable GO wastewater revenue bonds sold at a true interest cost of 3.27% with a term of 10 years, and there were 7 bidders with the winning bid going to Doherty & Co. Bond sale 2018C was for \$105M in GO wastewater revenue bonds sold at 3.2% with a 20-year term. There were 8 bidders, with the winning bid going to RBC Capital. Bond sale 2018D was for \$40M in GO transit bonds, sold at a true interest rate of 2.53% with a 10-year term. There were 7 bidders, with the winning bid going to Piper Jaffray. All the sale results fell well within the parameters of the resolution passed earlier this month, and the proceeds will arrive on May 23.

<u>Rodriguez</u>—Gave a shout-out to Metro Transit for their efforts during the historic blizzard on April 15. There were a lot of comments on social media calling the operators heroes during this time. In contrast, there were 2 driver assaults documented on social media in the last few weeks.

<u>Letofsky</u>—Attended the Metro Cities annual meeting along with Chair Tchourumoff and several other Council members. Attended the TPP presentation to Hennepin County along with CM Elkins. Attended a public meeting hosted by MCES regarding the Minnehaha sewer project.

Elkins—Participated in a D Line tour that was well-attended.

<u>Munt</u>—She's glad to be back after ankle surgery; it's given her a newfound appreciation for designing communities for access. Union jobs give workers a voice on the job.

Chair: Testified before the House Transportation Finance Committee about the Council's bonding proposal for \$50M for arterial BRT
